How to Submit a Bid:

Bidders must submit a check for an amount equal to or larger than 5% of their bid amount payable to the IDNR with their bid as a performance deposit. The timber will be sold to the highest bidder, provided the bid is acceptable to the state.

Terms of Sale:

10% down payment required within 14 days of sale date. Full payment can be made within 14 days of sale. If down payment method is used balance of payment is due within 1 year of sale date or prior to start of harvest operation.

Where to Bid:

Sealed bids must be at the Ferdinand State Forest office at the time of public bid opening.

Remarks:

Individually selected timber is marked in red paint. Point sampled openings are bounded in yellow paint. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements. Loggers will need to direct traffic while felling trees next to county road. Directional felling required. This is Timber Sale #6311503.
