



Indiana Division of Forestry Group FSC Chain of Custody Certification SCS-COC-002041

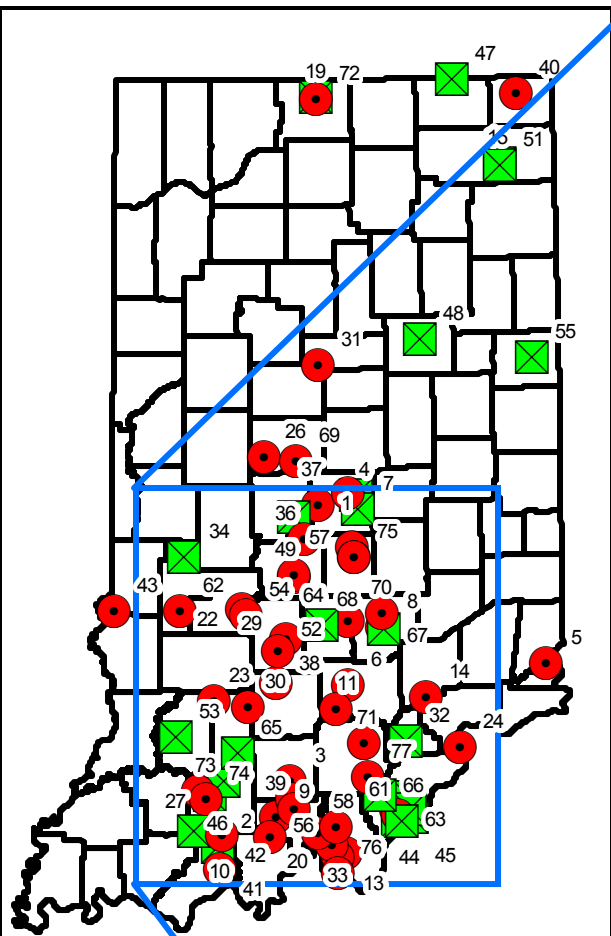
Indiana State Forests and most private forests enrolled in the Indiana Classified Forest and Wildlands Program are certified by the Forest Stewardship Council (FSC). Purchasers of that timber may market those products as FSC certified only if they have FSC Chain-of-Custody (CoC) certification. To expedite and simplify this CoC process, the Division of Forestry has achieved a Group certificate through Scientific Certification Systems (SCS). For small loggers and primary mill operators (currently defined as annual sales less than \$5 million) the Division of Forestry will cover all the audit cost. The only cost to a small operator is an annual licensing fee of a few hundred dollars per year.

Current members of the Division of Forestry's Group CoC certificate are listed on the following pages. Membership is limited to companies that meet the following qualifications:

- Located within the State of Indiana
- Engaged in logging, hauling or primary processing of forest products
- Make application to the Division of Forestry (DoF) requesting group membership
- Agree to comply with Corrective Action Requests (CARs) issued by DoF or contract auditors or the Certification Body, SCS.
- Agree to provide information (as necessary to ensure compliance with FSC CoC standards) to the DoF or the Certification Body upon request. This information may include, but not limited to: production records, internal policy documents, management records, invoices for services or products, and agreements with outside entities.
- Submit to an initial audit and to annual audits by DoF and/or the Certifying Body
- Agree to have FSC product claims for labeling, marketing, and promotion comply with the appropriate FSC standard and be approved by SCS through the DoF

Companies not meeting the definition of "small" must cover audit costs themselves, but may still call on the Division for assistance. Those companies need to apply to a certifying body, prepare a procedures manual and submit to an initial audit. This process usually takes 3-6 months and costs the typical company several thousand dollars.

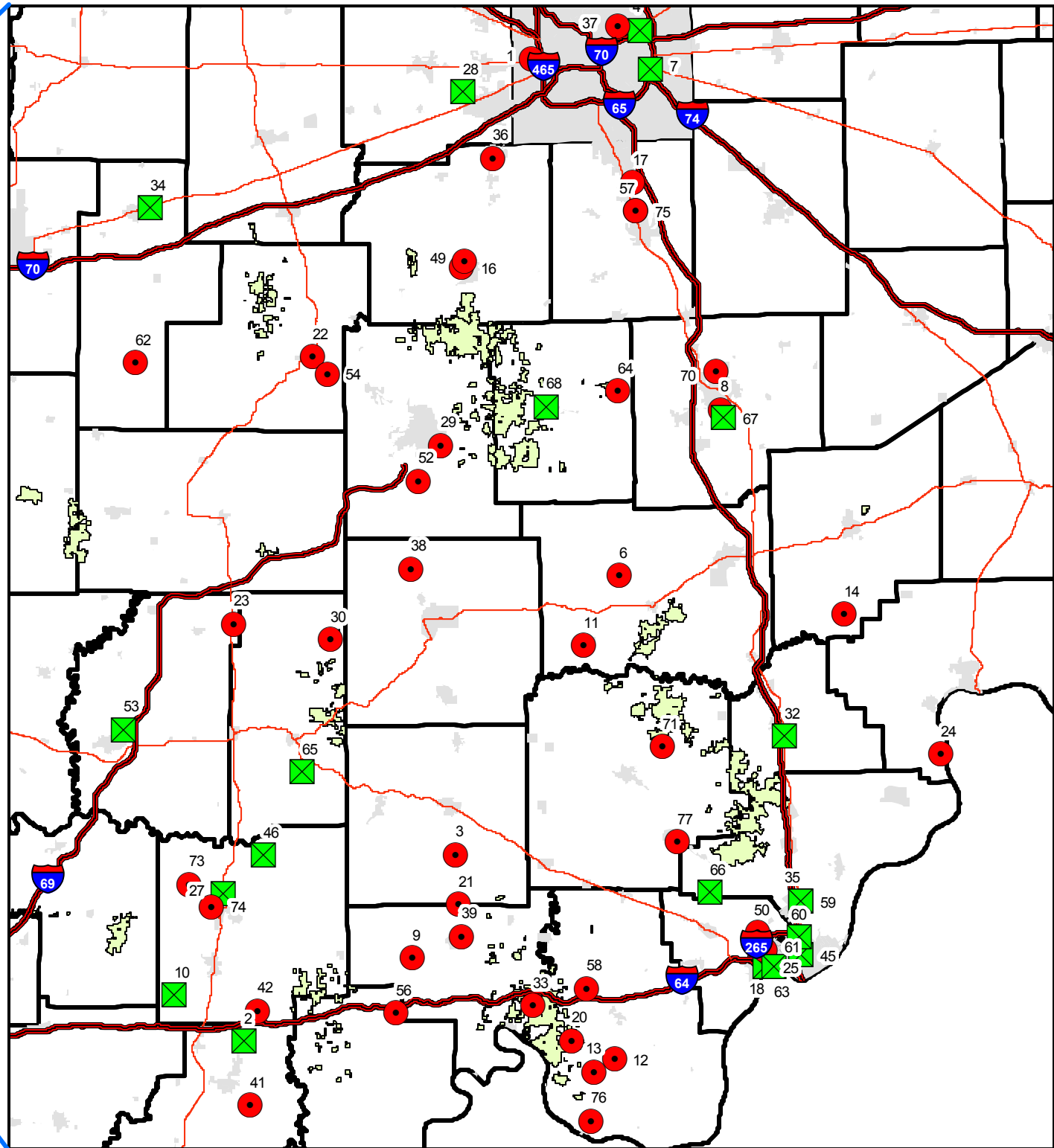
