TYPE OF SALE: SEALED BID

LOCATION OF TIMBER: NW ¼ of Sec. 5 and NE ¼ of Sec. 6, T7N, R8W in Compartment 6 Tract 1. The sale area is about 2.5 miles northeast of Pleasantville and surrounded by county roads 200S (Bucktown Rd.), 235S, 1450W and 1525W.

REMARKS: Trees marked with blue paint. Directional felling required. Logger training to meet forest certification is required. A pre-harvest conference must be attended prior to the start of any logging operations. The buyer should coordinate with the electric company for any trees that could impact power lines. A spotter should stop traffic on County Roads 225S and 1525W when trees are felled that could cause logging debris to fall in the road. The horse trails must be kept clear of all logging debris. Logging should only occur during stable soil conditions. Logger is required to seed and straw log yards. Contact resource specialist for seed requirements.
