LOCATION OF TIMBER: Greene County, Section 32, T7N, R7W, Stockton Township. The timber is located just east of Trimble Road and north of Bucktown Road. The sale can be accessed from Trimble Road. There is an iron gate at the rockered entrance approximately a 1/4 mile north of Bucktown Road. There is a log yard just inside the entrance. In the interior of the tract there are roughly 3.5 miles of skid trails dozed out along the spoil ridge tops, as well as a 1 mile section of horse trail that can be used for skidding. There are 56 logs for sale located in two areas. The first pile is located behind the forest office off of S. State Road 159. The second pile is located off of State Hwy 54, approximately 1/8 mile east of County Road 275 E.

REMARKS: Trees and logs are marked with yellow paint. Directional felling required. Logger training to meet forest certification is required. A pre-harvest conference must be attended prior to the start of any logging operations. The horse trails must be kept clear of all logging debris before close out. Logging should only occur during stable soil conditions. The buyer should coordinate with the electric company for any trees that could impact power lines. A spotter should stop traffic on Trimble and Bucktown roads when trees are felled that could cause logging debris to fall in the road. Logger is required to seed and straw log yard. Contact resource specialist for seed requirements. The logger will need to move equipment to each log pile site to load these logs.
