* These trees and volumes estimated through variable plot inventory method using a 10 factor prism. All of these trees are located within a 9ac, predominantly Virginia Pine regeneration opening. None of these trees are painted, but all trees within the opening boundary are part of the sale.

Note: White Oak logs are not included in the Tree tally, but are included in the volume.

The sale has the following conditions:

Cutting and skidding is only allowed from October 1st through March 31st of each calendar year. Logs in the yard may be moved at any time of the year. The Buyer will provide an operational bulldozer on site at all times during active operations. Wet weather may limit hauling. Buyer is required to provide any additional stone that may be needed. Timber for sale is marked with blue paint. North regeneration opening boundary is marked with purple paint and these boundary trees are not included in sale. A pre-harvest conference must be attended prior to the start of any logging operations. Grapple skidders are allowed for use on major skid trails only. Directional felling is required. Logger is required to seed major skid trails and to seed and straw log yards and water bars. Tops and other debris resulting from the harvest operation are to be removed from creeks and cleared off of the haul road. Marked timber in this tract is located within a State of Indiana generally infested EAB quarantine area. Buyer will only need to establish a compliance agreement with the Indiana Division of Entomology prior to moving any ash timber products into or through the remaining 13 nonquarantined Indiana counties or out of the State.

The timber specified in this document is Certified Wood. Indiana State Forests are certified by both the Sustainable Forestry Initiative (SFI) and the Forest Stewardship Council (FSC). Purchasers of State Forest timber may market state forest timber products as certified if they have the appropriate Chain of Custody certificate.
