

# **Completed Projects**

#### What's New?


- 2 New benches Installed (Fish Creek Pond and playground)
- Replaced several picnic tables
- Risk tree removal throughout campgrounds
- Rattlesnake Pond- vegetation was growing and made access difficult. Some of the vegetation was removed to improve access and protect the dam from root damage, which can lead to leaks.
- Staff continue to maintain clean and inviting campgrounds.
- 2020 brought a 30% increase in recreational revenue compared to 2019!





#### Horse Trail Maintenance

- The Bridle Loop Horse trail, specifically south of Atkinsonville Road, needed improvements.
- Overtime horseback riders, hikers, and mountain bikers can negatively impact trails, if not maintained. Trails can become eroded and channel water making sections difficult to navigate.
- The before and after photos to the right are of the Bridle Loop Horse Trail where it crosses the county road.







### Trails and Water

- The photos to the right show additional sections of the Bridle Loop Trail before DNR staff made improvements.
- Trails in this condition don't allow water to divert or dry properly.
  Water remains trapped and the area remains wet creating difficult situations for users.







### **Trail Improvements**

- The photos to the show the completed work on sections of the Bridle Loop Trail. A small excavator and bobcat was used to remediate these sections of trail.
- Water diversions (e.g., water bars, dips, turnouts, etc.) divert water off the trails before the water can build enough energy to create erosion. These diversions are spaced and installed based on soil type, slope, and nature feathers on trails; whether they are recreationally used trails or skid trails that are created during forest management activities.
- Lastly, a stone base was added and capped with fine stone. The stone helps stabilize the trail as well as assist with slowing any water movement on the trail.






# **Upcoming Projects**

### **Upcoming Recreational Projects**

- New signs for campground
- Continue to remove risk trees from the property and campgrounds
- Campsite and campground road maintenance including new stone.
- Sign maintenance on the property
  - Rehabbing old signs (replacing or repainting)
  - Adding new signs where appropriate
- Continue annual routine maintenance of property equipment and facilities.

- Paint forestry office and vehicle building
- Stain and chink property manager's log home residence





## Resource Management

#### Fiscal Year 2019/2020 (July '19 – June '20)

 During this fiscal year, compartment 9 tracts 1 and 3 (120 acres) were sold. \$108,126.00 in revenue.

#### 2020 Calendar Year

- Compartment 9 tracts 1 & 3 sold and harvest complete.
- Compartment 1 tract 2 harvest complete
- Compartment 8 tract 9 harvests complete

#### Fiscal Year 2020/2021 (July '20 – June '21)

 Compartment 1 tract 1 and compartment 8 tract 10 will be marked and sold.

#### 2021 Calendar Year

- Begin marking timber in compartment 8 tract 3 and compartment 2 tract 2, which are tentatively planned to be sold in 2022.
- Continue to conduct post-harvest timber stand improvement, invasive species management and forest inventories.
