### BMP Explanation:

Purchaser shall comply with the guidelines in Logging and Forestry BMP's for Water Quality in Indiana Field Guide, unless otherwise specified by the Seller. The Purchaser shall complete these guidelines within fourteen days of the removal of the last load of logs from the sale area, or the removal of harvesting equipment, whichever occurs first, or as specified by the Seller.

### How to Submit a Bid:

Bidders are required to submit a check for an amount equal to or larger than 5% of their bid amount payable to the Indiana Department of Natural Resources with their bid as a performance deposit. The performance deposit amount is not part of the total sale (bid) payment, but is a separate payment. Only current licensed buyers or their registered agents may submit bids. Buyer should satisfy himself as to volume in sale.

### Terms of Sale:

The winning bidder must make a payment equal to or larger than 10% of the bid amount within 14 calendar days of the bid opening. The remaining bid amount balance shall be paid within 1 year of the bid opening or prior to the start of harvest operations, whichever occurs first. Purchase of state forest timber sales require that at least one person (crew and/or supervisor) be on an active site at all times and have at least Indiana Cutter Level 1 training within the past 3 years and Introduction to BMP training within the past 3 years.

### Where to Bid:

**Remarks:**

Trees are marked in blue paint. Access to timber is good. Directional felling required. Access road and landings must be maintained and returned to pre-harvest condition. Logger is required to seed and straw log yard. Logger must contact Resource Specialist for seed requirements. Logger must provide forester with seed tags. Logging will only be allowed during stable soil conditions. A pre-harvest conference must be attended prior to the start of any logging operations. Logger must not disturb sensitive areas and will be required to cable some trees away from sensitive areas while not causing any ground disturbance.
