#### Psych Hub Video—Partnership with NGB

The challenges brought by the COVID-19 pandemic impact all of us. During these unprecedented times, it's critical that our fellow Service members and their families have 24/7 access to credible resources to not only protect our physical health, but our mental health as well.

The National Guard Bureau (NGB) partnered with Psych Hub—the world's largest online platform for digital mental health education—to make their COVID-19 Mental Health Resource Hub available free of charge. NGB recently produced a video providing the Guard community with an overview of this comprehensive digital library, which features more than 600 articles, videos, and other resources to support mental health and reduce stigma during and beyond the pandemic. #### **Arts Project Support**

Arts Project Support (APS) grants provide funding to Indiana 501(c)3 nonprofit organizations and public entities for a specific arts project or arts activity(ies). Some examples of eligible projects include a one-time art event, a single performance, an exhibition, an educational workshop, or series of related arts activities such as art classes or training sessions that are open to the public whether free or for a fee. APS is administered by the Regional Arts Partners (RAP) across the state. This grant program is created with a focus on the Indiana Arts Commission's Funding Imperatives.

APS applicants may request up to \$5,000 to support their arts project. Grant funds must only be used for eligible expenses only.

#### **YouthBuild Grants**

Grants to organizations providing pre-apprenticeship services that support education, occupational skills training, and employment services for at-risk youth, ages 16 to 24, while performing meaningful work and service to their communities. Training includes affordable housing construction skills and other in-demand industries, such as healthcare, information technology, hospitality, retail services, and logistics.

## <u>Enhancement and Expansion of Treatment and Recovery Services for Adolescents, Transitional Aged Youth, and their Families</u>

Grants to enhance and expand comprehensive treatment, early intervention, and recovery support services for adolescents, transitional aged youth, and their families/primary caregivers with substance use disorders and/or co-occurring substance use and mental disorders.

#### **Building Communities of Recovery**

Grants to support the development, enhancement, expansion, and delivery of substance abuse recovery support services and recovery education.

#### **NRHA Rural Health Awards**

Honors individuals and organizations that have made significant contributions to rural health.

#### Adult Drug Court and Veterans Treatment Court Discretionary Grant Program

Grants and technical assistance to enhance the operations of adult drug courts and/or veterans treatment courts. Courts should integrate evidence-based substance abuse treatment, random drug testing, equitable sanctions and incentives, and transitional services in judicially-supervised court settings with jurisdiction over offenders to reduce recidivism, substance abuse, and prevent overdoses. Rural communities are a program priority.

#### The Gus Schumacher Nutrition Incentive Program

Funding to support projects that will increase the purchase of fruit and vegetables among low-income consumers who participate in the Supplemental Nutrition Assistance Program by providing incentives at the point of purchase.

#### **Helping Hands Grant Program**

Grants to encourage medical students to participate in community service activities, particularly those focused on underserved populations; raise awareness of mental illness and the importance of early recognition of illness; and build an interest among medical students in psychiatry and working in underserved communities. Projects should focus on mental health and substance use disorder.

#### **Opioid Affected Youth Initiative**
