### Fiscal Analysis and Cost Benefit Analysis

# I. Description of Rule

The Department of Veterans Affairs is authorized to establish rules for veteran's services. These rules include providing grants for qualified entities under IC 10-17-13.4, homeless veterans. Within these rules, grants can be used for job search assistance, near-term homelessness, on the job training, and public housing assistance program, safe and secure living conditions, stable and long term renal status, and therapeutic services. The rules will also entail program and application procedures.

### II. Fiscal Analysis

The proposed rule to establish qualified entities and internal programs and procedures is funded through legislation. The funding is within Indiana Department of Veterans Affairs operational budget. \$500,000.00 is to be used to provide qualified entities the financial resources to assist homeless veterans. Grants amounts will be determined on an individual entity's need for assistance, already existing programs and new programs to help homeless veterans.

### III. Cost Benefit Analysis

The proposed rule, as stated under the fiscal analysis section is funded through legislation and totals \$500,000.00. The State of Indiana and the Indiana Department of Veterans Affairs will provide grants for veterans' services and will not generate any type of revenue. The Indiana Department of Veterans Affairs will use existing staff members to administer this program.
