Re: WARN Act Notice of Permanent Facility Closing

Dear Commissioner Payne:

This notice is being provided to you pursuant to the Worker Adjustment and Retraining Notification Act of 1988, which requires affected employers to provide notice to certain government units or officials of a permanent plant closure.

Please be advised that 19th Capital will permanently close its facility located at 9702 East 30th Street, Indianapolis, IN 46229.

While an exact date for the closure has not been established, it is anticipated to begin taking place on or after March 27, 2020, and the majority of employees will terminate employment during the 14 day period beginning April 27, 2020. When the facility is closed, 199 employees will be permanently laid-off. A list of the affected positions is enclosed.

None of the affected employees are represented by a union. The affected employees do not have bumping rights.
