Dear Ms. Garlin,

This letter is being issued in accordance with the Worker Adjustment and Retraining Notification Act (WARN) to notify you that Bell Techlogix is permanently closing its Plainfield Repair Depot operations, located at 2350 Stafford Road, Plainfield, Indiana 46168, effective December 31, 2020. This will result in the permanent layoff of 250 employees.

Bell Techlogix is not part of a union. Bumping rights do not exist.

The reason for the closure is that Epson America terminated the contract between Epson and Bell Techlogix effective December 31, 2020. Accordingly, the jobs currently performed by Bell Techlogix employees will thereafter be performed by Epson employees.
