Pursuant to the Worker Adjustment and Retraining Notification Act ("WARN"), it is with deepest regret that we inform you that CMR Partners, LLP, ("CMR Partners"), after almost twenty-four (24) years, will cease operations and terminate the employment of all employees at two (2) of its Ponderosa Steakhouse locations. Those two sites (collectively, "Locations") are located at:

- a) 5009 S. Scatterfield Road, Anderson, IN 46013 ("Anderson Location"); and
- b) 5005 S. Emerson Ave, Indianapolis, IN 46237 ("Beech Grove Location").

This action is expected to be permanent in nature and these Locations will be closed. The scheduled termination date of all employees at the Anderson location is August 24, 2020. The scheduled termination date of all employees at the Beech Grove location is August 28, 2020 This action is due to the unexpected and significant impact to the foodservice industry directly caused by the COVID-19 worldwide pandemic. More particularly, the sudden and unexpected reduction of business caused by the pandemic coupled with the additional requirements for buffet service restaurants have fundamentally changed the financial feasibility of business operations. While CMR Partners has attempted to adjust to these circumstances and the unpredictable consumer demand that accompanied them, sudden precipitous declines have rendered continued operations – as well as greater notice to employees – infeasible.

The number of workers who hold affected jobs in each job classification and the job titles of the affected positions are shown on the enclosed "Exhibit A."
