Re: WARN Act Notice – Plant Closing

Ms. Gatlin, Commissioner Saulman, and Trustee Mayfield:

This letter is provided to you in accordance with the Worker Adjustment Retraining Notification Act, 29 U.S.C. § 2101, et seq.

I sincerely regret to inform you of the closing of the entire Daramic, LLC plant located at 3430 Cline Road, Corydon, Indiana 47112 (the "Corydon Plant"). The employment of sixty-nine (69) of the seventy-four (74) employees at the Corydon Plant will be terminated effective July 31, 2020. The employment of the remaining five (5) employees will be terminated between August 1, 2020 and June 30, 2021. The Corydon Plant will cease all operation effective June 30, 2021. This plant closure will be permanent.

A list of the job positions and the number of affected employees in each position is attached to this letter.

Bumping rights do not exist for the affected employees. Fifty-four (54) of the seventy four (74) employees at the Corydon Plant are represented by the Indiana Kentucky Ohio Regional Council of Carpenters, and its Affiliated Local No. 2133 (the "Union"). The Senior Representative of the Union is Charles Davis (1245 Durrett Lane, Louisville, Kentucky 40213). Daramic, LLC has notified the Union of the Corydon Plant closure.
