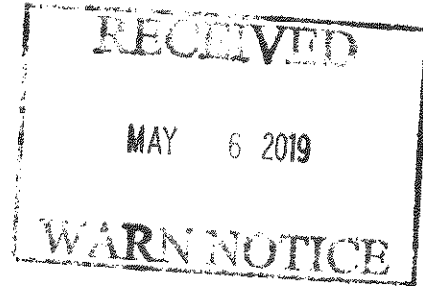

RE: WARN ACT Notification



Dear Sir or Madam:

This letter will serve as notice pursuant to the Worker Adjustment and Retraining Notification Act of 1988 ("WARN"), which requires employers to give notice to the State dislocated worker unit of a pending closure.

Fayette Memorial Hospital Association, Inc. d/b/a Fayette Regional Health System ("Fayette") has been operating in a Chapter 11 Bankruptcy since October 10, 2018. While Fayette is continuing to negotiate with various parties in the hope of accomplishing a sale of its assets, Fayette as the operating company, will be permanently ceasing operations at all facilities operated by Fayette effective no later than July 31, 2019. In conjunction with the cessation of operations, the employment of all Fayette employees will end. These employment terminations are expected to be permanent.

While the actual closure date is as yet unknown, Fayette has provided its affected employees with written notice and expects to continue those employment of those individuals through at least the 60-day period ending July 3, 2019. A list of the affected employees' job titles and classifications and the number of affected employees in each classification is attached to this letter.

Employees at Fayette are not represented by a union, and no bumping rights exist.
