Re: Notification Under the Workers Adjustment and Retraining Notification Act

Dear Sir or Madam:

We provide this letter pursuant to the Workers Adjustment and Retraining Notification Act, 29 U.S.C. 2102 et seq. ("WARN Act").

HOYA Optical Labs of America, Inc. ("HOYA") has developed plans to implement a permanent closure of its facility located at 2925 Gary Drive, Plymouth, Indiana. The specific job titles of employees affected by this closing, including the number of employees in each position, are set forth in the attached document.

On August 6, 2019, we provided notice to all affected employees that HOYA will be closing the Plymouth facility in various phases and that such closing shall be permanent. In addition, HOYA has provided notification to IUE-CWA, the Industrial Division of Communications Workers of America, AFL-CIO and its Local #84809 (the "Union"), which represents certain employees. To the extent that there are any bumping rights, they are defined in the collective bargaining agreement between HOYA and the Union.

The first phase of separations is set to occur on October 4, 2019. The plant closure will be complete as of March 2, 2020. We expect it to proceed gradually and in phases as work is transferred to other HOYA locations.
