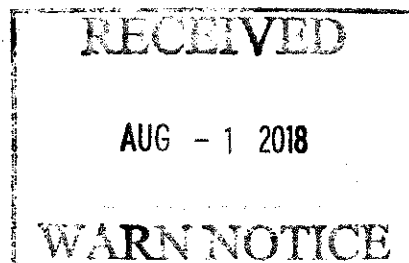

As a result of the Hospital closure, all positions at the Hospital will be eliminated. Employee separations in connection with the transaction are expected to commence during the 14-day period starting on September 29, 2018. This action is expected to be permanent.
