Re: Notice of Plant Closing and Layoffs

Dear Dislocated Worker Unit:

Regal Beloit America, Inc. ("Regal" or the "Company") will be permanently closing its entire Evans Avenue manufacturing facility located at 2300 Evans Ave., Valparaiso, IN 46383 (the "Facility"), effective on or about May 31, 2021. In connection with these plans, the Company expects that the employment of all 86 employees working at the Facility will cease and that the first 4 layoffs and/or employment separations will take place on or about November 9, 2020, when the Company also expects the plant closing to commence, or during the 14-day period beginning on that date. The Company expects an additional 6 layoffs and/or employment separations will take place on or about November 27, 2020, or during the 14-day period beginning on that date. The Company expects an additional 8 layoffs and/or employment separations will take place on or about December 30, 2020, or during the 14-day period beginning on that date. The Company expects an additional 1 layoff and/or employment separation will take place on or about February 26, 2021, or during the 14-day period beginning on that date. The Company expects an additional 67 layoffs and/or employment separations will take place on or about May 31, 2021, or during the 14-day period beginning on that date.
