The purpose of this letter is to notify you of employment losses resulting from various indefinite operational adjustments at United States Steel Corporation's ("the Company") Gary Works facility. These actions are due to the sudden, dramatic, and unexpected decline in business conditions resulting from the worldwide COVID-19 pandemic, which was both out of the Company's control and not reasonably foreseeable. - Planned Action: Indefinite operational adjustments with resulting employment losses at Gary Works.
- Names of units which are affected: The planned action is expected to result in employment losses in all departments throughout the Gary Works facility.
- Employment losses associated with the planned action will commence on May 03, 2020 and continue periodically while the underlying business conditions last.
