We are writing to inform you that, in large part due to the unforeseen, direct and significant impact of the COVID-19 pandemic on our business operations, the Wabash Valley manufacturing facility at 505 East Main Street in Silver Lake, Indiana will be permanently closing. We expect the last day of operations to be on or around April 7, 2021.

This letter is being issued in accordance with the Worker Adjustment and Retraining Notification Act (WARN) in order to notify you that we will lay off approximately 80 employees from the facility. We expect the first separation to occur during the 14-day period beginning January 15, 2021, with the separations of all remaining employees at the facility to occur during the 14-day periods beginning February 15, 2021 and March 19, 2021.

There are no employees represented by a bargaining unit at this facility, and as a result, there are no bumping rights. All affected employees have been notified.

Attached as Exhibit A is a chart of the job titles and the number of affected employees in each job category.

This announcement and the above timetable are based on the best information currently available. However, various factors may still affect the timing of any employment separations. You will be informed of any significant changes in these plans, as additional information becomes available.

We are committed to making the transition as smooth as possible for our employees, our customers and for the community.
