Subject Matter	Amends 405 IAC 1-8-3 to extend through June 30, 2021 the three percent (3%) rate reduction for covered outpatient hospital services that is currently set to expire on June 30, 2019. Amends 405 IAC 1-10.5-6 to extend through June 30, 2021 the three percent (3%) rate reduction for covered inpatient hospital services that is currently set to expire on June 30, 2019. Amends 405 IAC 1-14.6-26 to extend through June 30, 2021 the three percent (3%) rate reduction for covered nursing facilities that is currently set to expire on June 30, 2019. Effective 30 days after filing with the Publisher. IC 12-15-1-10; IC 12-15-21-1; IC 12-15-21-2; IC 12-15-21-3.
