

Letter to the Governor

Dear Governor O'Bannon:

The pari-mutuel horse racing industry moved forward at a rapid pace in 1996. Hoosier Park in Anderson was able to attract some of the top equine athletes throughout the Midwest to its live thoroughbred meet. The prize money or purses offered to attract these quality horses were greatly increased over prior years due to three year round satellite facility operations (Merrillville, Ft. Wayne and Indianapolis) as well as revenue generated by the riverboat admission tax.

As in the past, the Commission continues to focus its energies on diligently regulating the pari-mutuel industry. The results of our regulatory efforts, along with statistics of interest, are highlighted in this report.

I am pleased to report that Indiana has gained a reputation throughout the Midwest for clean, honest and competitive racing. The Indiana Horse Racing Commission is determined to provide the strong leadership that is needed to assist in the continued success and maintain the integrity of our new pari-mutuel racing industry. Each Commissioner is proud and grateful to have the opportunity to serve you in this endeavor.

Year In Review

May

The Commission unanimously approves a transfer of ownership of 10 percent of Hoosier Park to Conseco.

July

- Jenna's Beach Boy wins the \$75,000
 Dan Patch Invitational pacing to a track record of 1:49:4. The 1995 Pacer of the Year, Jenna's Beach Boy, counts the Dan Patch amongst his nine victories contributing to being named the 1996 Pacer of the Year.
- On July 8, the commission staff issues a Preliminary Report finding violations regarding unlawful telephone wagering at the Merrillville OTB. The staff recommends a \$10,000 fine for the telephone wagering and an additional \$5,000 fine for not reporting the violations. Hoosier Park does not contest the findings and promptly pays the fines.

The State of Indiana loses one of its finest harness racing drivers when Gregg Haston died in a truck accident in Anderson the afternoon of Thursday, July 11, 1996. Haston, 36, was a native of Carmel, Indiana. Gregg was the leading driver at Hoosier Park at the time of the accident.

August

 On August 17, the largest crowd of the season, 4,144 fans, turn out to witness living legend and harness goodwill ambassador, John Campbell, compete in the Kentucky Standardbred Sales Company Stakes. Campbell, displaying the skills that make him the perennial national leading driver, wins all three pacing divisions.

September

- Hoosier Park hosts the first "Indiana Day" on September 1. The 22-race card, offering \$686,000 in purses, showcases the best Indiana sired and owned standardbreds
- The father and son team of Harold and Brian Barnes capture the leading trainer and driver championships with 34 and 78 wins, respectively.
- The State's thoroughbred industry holds their inaugural Indiana Championship Day on September 22. The best Indiana owned and bred horses compete for \$471,625 in purses.

October

- After an extensive investigation, the commission staff, on October 15, issues a Preliminary Report on the former Merrillville OTB manager Ronald Green. The investigation finds numerous violations of the pari-mutuel statute and Commission rules.
- Canyon Run, with Francisco Torres in the irons, captures the second running of the \$100,000-added Indiana Derby.

November

- Hoosier Park's live race meet tops the \$1 million dollar mark for the first time in nationwide handle on three consecutive Fridays. The third such Friday, on closing weekend, a single card record of \$1,308,889 is wagered on the 14 race program.
- Jon Court captures the riding title with 91 wins. Bernie Flint takes the leading trainer honors by sending 17 horses to the winners circle from only 44 starts.

Hoosier Park statistics represent all wagering on out-of-state simulcasts (no live racing). The number of simulcast dates at Hoosier Park reflect any dates on which full card simulcasting took place. Special race simulcasting at Hoosier Park is included in the handle, but not in the number of dates. All OTB statistics represent all wagers at each location on both in-state and out-of-state simulcasting.

Admission is not charged at the Indianapolis OTB, the Ft. Wayne OTB and at Hoosier Park for simulcasting. Consequently, attendance is not counted. Attendance at the Merrillville OTB was 101,092.



Occupational Licensing

Pursuant to IC 4-31-6 and 71 IAC 5-1-1, all persons participating in pari-mutuel racing under the jurisdiction of the Commission are required to be licensed. The licensing process is the backbone of the Commission's regulatory efforts. Each prospective licensee is fingerprinted. The Federal Bureau of Investigation (FBI) and the Indiana State Police provide the Commission with criminal histories of all applicants. The Commission may refuse or deny the application for licensure of any person whose criminal or racing violation record is contrary to the public's best interest.

Equine Drug Testing

Pari-mutuel horse racing can succeed as a legitimate major league sport only if its races are perceived by the wagering public to be honest, competitive contests, free from manipulation by man or drugs. With the exception of furosemide (lasix) and phenylbutazone (bute), under regulatory restrictions, state law and commission rules prohibit the presence of any drug in horses racing at a pari-mutuel track. The Commission's drug detection program is one of the nation's most comprehensive and its laboratory one of the most respected in the racing industry.

Truesdail Laboratory in Tustin, California, serves as the primary testing laboratory for the Indiana Horse Racing Commission. Truesdail Lab has been a leader in racing chemistry and drug related research for over 50 years. Truesdail Laboratory is a member of The Association of Official Racing Chemist (AORC) and The Association of Racing Commissioners International's Drug Testing Standards and Practices Committee.

The following table indicates, by breed, the number of samples analyzed and the number of positive tests reported. In each instance, the offending horse was disqualified and placed last. In accordance with the parimutuel statute, all purse money earned is ordered returned and redistributed. The trainer of each offending horse was penalized by a suspension and/or fine.

Breed Development Programs


Overview

Pursuant to IC 4-31-11, breed development funds have been established to promote the breeding of horses while stimulating the agri-business sector of the state's economy. All breakage and unclaimed winning tickets are statutorily earmarked for breed development. In addition, twenty percent (20%) of the riverboat admission tax allocated to the racing industry is distributed to breed development funds. Standardbred and thoroughbred breed development advisory committees make recommendations to the Commission regarding the distribution of these monies.

Standardbred

The Standardbred Breed Development Advisory Committee has initiated an extensive program which allocates monies for Indiana sired, bred and/or owned, competing at Hoosier Park, the State Fair and several county fairs. In 1996, \$1,230,361 was distributed as awards and purse supplements to participating horse owners.

The highlights of the 1996 racing season was the inaugural "Indiana Day" held on September 1, which included \$695,100 in purses and the finals of the Genesis. The Genesis is a newly created lucrative series of races for two-year old fillies designed with the long term goal of enhancing the quality of breeding stock in Indiana.




Purse supplements at Hoosier Park include \$ 357,050 distributed on Indiana Day.

Breed Development Programs

Thoroughbred

The Thoroughbred Breed Development Advisory Committee has concentrated their resources in designing a program that will increase both the quality and quantity of Indiana breds that will compete at Hoosier Park in the future.

The highlight of the 1996 racing season was the inaugural "Indiana Championship Day" held on September 22. The day featured nine stake races for Indiana owned and foaled horses with purse money totaling \$471,625.



Purse supplements include \$370,000 distributed on Indiana Championship Day.

Blood Gas Analysis Program

The purpose of the Blood Gas Analysis (BGA) program is to deter and detect the practice of "bicarbonate loading" or what is known in the racing business as "milkshaking." This practice generally entails giving a horse a large quantity of a alkaline substance, usually baking soda, prior to a race. The alkaline substance neutralizes the lactic acid that is produced during exercise and, as a consequence, delays the onset of fatigue. Research has demonstrated that this practice induces some horses to race faster times. Bicarbonate loading can give a horse an unfair competitive edge and thus compromise the integrity of the sport. This practice is strictly prohibited by the rules of the Commission.

The BGA Program is operated by the Commission in a small laboratory located in the paddock at Hoosier Park. Blood samples of selected horses are analyzed prior to the race on a state-of-the-art blood gas analysis machine. Each sample is analyzed by a certified lab technician under contract through St. John's Hospital in Anderson.

Human Drug Testing

Commission regulations provide that a licensee or an applicant for licensure may be required, if reasonable suspicion exists, to submit to a drug test. Commission rules require a minimum suspension of thirty (30) days for a positive test for an illegal drug.

Riverboat Revenue

The statute permitting riverboat gaming in Indiana earmarks sixty-five (65) cents of the three dollar admission tax to the pari-mutuel horse racing industry. These funds are distributed to various segments of the racing industry in accordance with Commission rule 71 IAC 12-2-15.

Pursuant to Commission rule, the allocation between breeds for purses and breed development is determined based upon the percentage of pari-mutuel handle on each breed on live racing at all Indiana locations. Based on 1996 handle, 56.78% of available funds were distributed to standardbreds, while 43.22% was distributed to thoroughbreds.
