During the 2015 legislative session, legislation was passed which increased the funds allocated to the Thoroughbred Breed Development Fund by an additional 5%. This change results in an increase of approximately \$1.4 million dollars in slots revenue to the Thoroughbred Breed Development program annually. These additional funds gave the Thoroughbred Breed Development Advisory Committee an opportunity to make several positive improvements to the program for 2016. Additional races were added into the 2016 Program and all \$85,000 stake races were increased to \$100,000. In planning the proposal for 2017, the Thoroughbred Breed Development Advisory Committee worked closely with the racetracks, IHRC staff and horsemen associations. Public meetings were held in which horsemen had the opportunity to voice their opinions. At the recommendation of the IHRC staff, a balance of \$2.3 million in reserves is maintained in the Thoroughbred Breed Development Fund. In order to accomplish this, the remaining balance is analyzed each year when planning the program. Upon review of this year's ending balance, it is proposed to utilize \$600,000 in reserves for the 2017 program, and decrease the amount utilized by \$100,000 each year thereafter. Additionally, one of the main topics of the discussion is how to build additional flexibility into the program for 2017. Therefore, the Committee would like to request that the Executive Director have the ability to approve (after receiving a request from the Committee and IHRC Staff) the movement of funds from one line item to another should that budget amount be less than expected and/or the ability to utilize additional funds should gaming revenues be greater than projected. For example, if the amount being spent for Awards for Open Races (dependent of Indiana Bred horses winning in open races - something difficult to predict) is going to be under budget, a portion of those funds may be utilized for overnight races with IHRC Executive Director approval.

## **Proposed Program and Guidelines**

## **Scheduled Overnight Races:**

Due to the increased funding, there are 249 proposed scheduled races. Funds allocated for regularly scheduled races that do not fill may be added to the Discretionary Race Fund throughout the meet.

## **Discretionary Race Fund:**

Included in the 2017 proposal is the inclusion of a "Discretionary Race Fund" to be utilized by the racing secretary at the track. This element, added to the program in 2012, works by giving the racing secretary the authority to make adjustments to the program to accommodate the population of horses available to race. The Discretionary Race Fund gives the race track an opportunity for an additional 54 Breed Development races with an average purse of \$34,000. This will give the track an opportunity to run approximately 303 Breed Development races during the 2017 race meet, an increase of 8 from 2016. In addition, funds allocated for regularly scheduled races that do not fill may be added to the Discretionary Race Fund throughout the meet. The track will be limited to the overall Breed Development budget amount approved for the race track.

Please see Attachment A for detailed information outlining the proposed race program.

## **Indiana Bred Horses in Open Races:**

The Committee, along with the racetrack's support is proposing a rule change to 71 IAC 13.5-5-1 which will allow Indiana Bred horses to retain their Indiana Bred preference date when entering consecutive open races. This will hopefully encourage Indiana Bred horses to compete in open races. This requires a rule change and it is included in this proposal.

### **Signature Stake Races:**

The year 2012 was the inaugural year for the Signature Stake Races in Indiana. The Signature Stake races will continue as they did in 2016. The proposed stakes are as follows:

### **Remaining Stakes Program:**

The purses for these races will be contested at \$100,000. The purses for these races will be split 65/35 between the Breed Development Fund and the open purse account.

Preference for all stake races for two and three year olds will be high weights preferred, second preference lifetime earnings. Races for three year olds & older will be high weights preferred, second preference highest lifetime earnings.

In addition Breed Development will continue to contribute funding to the ITOBA Stallion Stakes. Breed Development will contribute \$25,000 to each race (for a total expenditure of \$50,000) as follows:

## **General Program Guidelines:**

- Each regularly scheduled overnight race that fills with eight (8) or more betting interests will be carded. It is the discretion of the racing secretary as whether to utilize races with fewer than eight (8) betting interests.
- Stake races are not required to have eight (8) starters to be used.
- If a regularly scheduled race fails to be carded due to a lack of eight (8) betting interest, but contains at least six (6) preferred betting interests, the racing secretary shall bring that race back the following day. Should the race not fill with eight (8) betting interests again, the purse money from that race will be allocated to the Discretionary Race Fund.
- In order for a race to be split, it must contain at least eight (8) betting interests in each.
- The racing secretary has the discretion to write Indiana-bred claiming races at a level below \$10,000 as needed. These races will not be used to replace any race in the Thoroughbred Breed Development Program.
- All stakes, with the exception of the Signature Stakes, shall be "added money" with the nomination, entry and starting fees contributing to the purse as indicated in 71 IAC 1.5-1-97.
- One-third of all allowance races, including maiden special weights, are to be written for Indiana sired horses. The racing secretary shall make every attempt to write Indiana-sired races in advance of Indiana-bred races for the same condition. In addition, the Committee would encourage the racing secretary to increase the number of Sired races in excess of this guideline as needed.
- The racing secretary shall make every attempt to provide 50% racing opportunities for colts and geldings and 50% for fillies and mares in the overnight program.
- The racing secretary shall make every attempt to write 30% of all maiden and allowance races going long.
- Recognizing the importance of turf racing for Indiana Bred/Sired horses, the racing secretary shall make every attempt to write an appropriate number of turf races.

#### **Indiana –Bred Preference:**

## Allowance and Maiden Special Weight

Preference will be given to horses that have not started for less than \$10,000 in their last five starts. A horse can regain preference by running  $1^{st}$ ,  $2^{nd}$  or  $3^{rd}$  for \$10,000 or more since last starting for less than \$10,000.

## **Indiana – Bred Maiden Eligibility:**

Horses that have not finished 5th or better in one of their last **six** starts are not eligible for Maiden Special Weight Races.

## Limited Preferred Starter Status for Indiana-Breds in Open Company Races (Stakes Excluded):

Once a registered Indiana-bred receives an R Date or E Date, it will receive Starter Preferences over Non Indiana-bred horses that have equal R Dates or E Dates. Indiana-breds will NOT receive starter preference over Non Indiana-breds with better R Dates, E Dates or when both horses have 0 dates. Preference dates will not supersede conditions of a race.

## **Exclusion of Indiana – Bred Wins in Open Other Than Conditioned Allowance Races**

The Racing Secretary has agreed to include the words "Indiana-bred Race" in all other than open Allowances.

### Examples:

- (1) Non winners of a race other than Maiden, Claiming or Indiana-bred race.
- (2) Non winners of two races other than Maiden, Claiming or Indiana-bred race.
- (3) Non winners of three races other than Maiden, Claiming or Indiana-bred race.

### **Indiana- Bred Weight Allowance:**

Registered Indiana-breds shall automatically receive a 3 lb. weight allowance when competing in races not restricted to Indiana-breds. Stakes races will be exempt from this requirement.

## **Indiana – Sired Weight Allowance in Indiana Bred Races:**

In Indiana restricted races, registered Indiana – sired horses shall receive a weight allowance of 3 lbs. when running less than seven and one-half furlongs (7 ½) and 5 lbs. when running seven and one-half furlongs or greater.

## **Applicable Rule Changes:**

## 71 IAC 13.5-5-1 Indiana bred preference

Authority: IC 4-31-3-9 Affected: IC 4-31

Sec. 1. (a) A registered Indiana bred that receives an R-date or an E-date will receive starter preference over a non-Indiana bred with an equal R-date or E-date. Such preference shall apply in all races not restricted to Indiana breds, stake races excepted. Indiana breds will not receive starter preference over non-Indiana breds with better R-dates, E-dates, or zero-dates.

(b) A registered Indiana bred that enters or races in an open race will retain their previous Indiana bred preference date when returning to a restricted Indiana bred race. Such a horse, when entering consecutive open races, shall retain the preference date of its most recent open race. Attached you find Standardbred Breed Development Advisory Committee's proposal for 2017. In planning the program for 2017, the Committee worked closely with the ISA, the racetracks and IHRC officials to determine what changes should be made. When you review the proposal, you will find that there are very few modifications for 2017. The program has become one of the most successful programs in North America, and all involved felt only minor improvements were necessary. Those improvements include:

- Payment to 6<sup>th</sup> through 10<sup>th</sup> place finishers in Indiana Sires Stakes Finals. This will further enhance our premier program in Indiana.
- Modifications to Indiana Sires Stakes Conditions and 71 IAC 3-2-9 Judge's List. These changes go together and clarify the qualifying standards for the Indiana Sires Stakes. We believe this rule change should be adopted as an emergency rule so that it is effective at the beginning of the meet. It is beneficial to horsemen participating in the Indiana Sires Stakes program.
- Changes to Late Closers earnings requirements. This was recommended after reviewing the horse's earnings in 2016 to maintain the number of horses eligible to these events.

The year 2016 was another amazing year for Indiana Sired horses in racing within and out of our great state. Horses from our Breed Development program continue to make national headlines. Most notably Wiggle It Jiggle It and Freaky Feet Pete, both earning notoriety. 2015 Horse of the Year, Indiana sired Wiggle It Jiggle It, continued to dominate headlines along with Freaky Feet Pete, Hannelore Hanover, and Always B Miki. Indiana Sired horses continue to be in high demand. At the Hoosier Classic Yearling Sale, held in October, yearlings brought 14 percent more on average than in 2015. A total of 356 Indiana-sired babies averaged more than \$16,600 with the first crop from Grand Circuit winning sire Guccio averaging over \$23,000.

In planning the Standardbred Breed Development Program for 2017, the Standardbred Breed Development Advisory Committee and Standardbred Advisory Board worked closely with Hoosier Park and the Indiana Standardbred Association. Our goal is continue to look at ways in which we can improve this already successful program, consider input from all stakeholders and try to formulate long term plans. At the recommendation of IHRC staff, and approved by the Commission in 2013, there is a goal of keeping a reserve in the amount of \$2.3 million in the fund. Due the current reserve being larger than that, the fund is utilizing a decreasing amount annually from the reserves, until the \$2.3 million is reached. After reviewing our estimated ending balance, we are proposing that \$500,000 be utilized from reserves.

## Overview of 2017 Program

## Indiana Sires Stakes

Significant changes were made to the structure of the Indiana Sires Stakes program for 2014, and 2016 marked the third year operating under this structure. We have found that it is successful and working well. The Committee recommends keeping the structure of this program the same for 2017, with the addition of paying  $6^{th} - 10^{th}$  place leg final finishers a flat \$1000. This improvement will add additional value to the program and address one of the few concerns we heard from horsemen regarding the positive and negatives of making the final versus the consolation.

- Nomination fees will be retained by the Breed Development Fund. Nomination fees will remain at \$500.
- > Entry fee for each leg will be \$500.
- > There will not be an entry fee required for each Leg Final/Consolation.
- ➤ Breed Development will contribute up to \$50,000 for each leg. If total purses for an elimination exceeds the \$50,000 allocated from Breed Development, track purse account will fund the difference.
- $\triangleright$  Breed Development will fund the purses for the Leg Finals (\$75,000) and Consolation (\$25,000), plus \$1,000 for each  $6^{th} 10^{th}$  place finisher in the leg final.
- ➤ Breed Development will fund the purse, \$200,000 for the Super Final (for top ten horses from Leg Finals) plus the \$4,000 each 6<sup>th</sup> through 10<sup>th</sup> place finisher will receive. For a total payout of \$220,000.
- A consolation will only take place is there are seven (7) or more entries. If the consolation does not take place, the horses eligible to the consolation will be refunded their \$500 entry fee from the elimination and will be eligible and given 1<sup>st</sup> preference for an overnight races for ISS eligible horses. The purse of this race will be \$25,000 minus the amount refunded from the consolation not filling.
- Hoosier Park agrees to write overnight races for Sires Stakes eligible horses to provide additional racing opportunities. These races will run concurrent with the Sires Stakes program. Breed Development will earmark a minimum of \$500,000 from the funds allocated for IS Overnight/Mini Series Budget.

Condition Changes and Applicable Rule Change:

In working with the judges at Hoosier Park, we are proposing some modifications to the conditions of the Indiana Sires Stakes and a rule change to IHRC rule 71 IAC 3-2-9. These proposed changes will help to simplify how the qualifying rules are applied and are a benefit to horsemen participating in the program. You will find the conditions and proposed change to 71 IAC 3-2-9 attached to this document.

Any Pari-mutuel track rated less than fast will receive one (1) second for good and two (2) for sloppy unless otherwise notated.

Any horse that starts in the elimination and earns their way into the final or consolation for that elimination, shall be eligible to compete in said race. Horses on the judges list due to sick, lame, injured or compromise the safety of participants are ineligible to compete until released. All horses must have a clean line in qualifying time, without a break, within the last thirty (30) days from race date to race date. and not be on the judges list at time of entry unless declared ineligible under 71 IAC 3-2-9(g) or 71 IAC 3-2-9(h). Any horse eligible to the Super Final must have a clean line in qualifying time, without a break within the last thirty (30) days from race date to race date.

Entry Fee:

To be paid at the Office of the Director of Racing at the host track at least one (1) hour prior to post time.

Money Division:

Purses for races will be divided 50-25-12-8-5 percent.

Race Conditions:

Each event is to be raced one (1) heat at one (1) mile each.

If more than twelve (12) horses declare to start, the leg will be split into divisions according to the attached chart.

If a consolation fills with less than seven (7) horses, the consolation will not take place. The \$500 entry fee that horses eligible to the consolation paid, will be refunded. The track will write an overnight race in its place. The purse for the overnight race will be \$25,000 minus the amount refunded for entry fees. Preference for the overnight race will be given to horses that were in the elimination and qualified for the consolation at time of declaration.

All finals will be raced.

All eliminations will be contested, regardless of the number of entries.

All drug testing samples, taken from horses competing in the Indiana Sires Stakes, may be frozen for future testing.

The top ten (10) horses from the elimination who declare into the box will compete in that leg final. If there is a tie for tenth (10<sup>th</sup>) place, entry will be determined by fastest time in the elimination of those horses tied. If two or more horses are tied by time, entry will be drawn by lot. Also-eligibles will also be determined by time if tied. After the leg final is determined, the next ten (10) horses from the elimination who declare into the box will compete in the leg consolation. If there is a tie for tenth (10<sup>th</sup>) place, entry will be determined by fastest time in the elimination of those horses tied. If two or more horses are tied by time, entry will be drawn by lot. Also-eligibles will also be determined by time if tied. All post positions will be drawn.

Points will be awarded in each leg final as follows:

```
1 st 50 points

2 25 points

3 12 points

4 8 points

5 5 points
```

All starters will receive one (1) point for each leg final raced. The top ten (10) point earning horses from the leg finals who declare in the box will compete in the super final. If there is a tie for tenth (10<sup>th</sup>) place, entry will be drawn by lot. Two also eligibles will be drawn. A horse must have started in at least one (1) leg final in order to be eligible for the super final.

Eliminations with eight (8) or more betting interests may be raced as non-pari-mutuel event at the discretion of the race secretary. If there are fewer than eight (8) betting interests, the race <u>may</u> be raced as a pari-mutuel race for the full advertised purse at the discretion of the race secretary.

Purses for eliminations with eleven (11) or more starters will be increased by twenty percent (20%). In eliminations with a field of eleven (11) or more starters, the sixth place finisher will receive three percent (3%) and the seventh place finisher will receive two percent (2%) of the purse. The purse payout will be distributed as follows:

1st Place	\$11,40
2 <sup>nd</sup> Place	\$5,700
3 <sup>rd</sup> Place	\$2,736
4th Place	\$1,824
5 <sup>th</sup> Place	\$1,140
6 <sup>th</sup> Place	\$720
7 <sup>th</sup> Place	\$480

Each 6<sup>th</sup> – 10<sup>th</sup> place finisher in the Super Final shall receive \$4,000.

Emergency:

If for any reason, including but not limited to, weather, it becomes impossible to race any of the events at the Host Track, it is at the discretion of the Indiana Standardbred Advisory Board (Board) to contest any of these races at a different time and place so designated by the Board. The Board reserves the right to call off the event, and return to the entrants their pro-rate share of the accumulated horsemen portion of the purse, after deducting the clerical and administrative expenses allowed in these conditions. All entrants must abide by this change or forfeit their right to participate in these races or race for any part of the purse. In all circumstances, the Board will make the final decision.

Gait:

Horses changing gait may be transferred to their adopted gait, but payments made prior to that time will not be transferred.

Rules:

Rules of the Indiana Horse Racing Commission shall govern unless otherwise specified in these conditions. Any issue not covered by these conditions or Indiana Horse Racing Commission Rules will be subject to interpretation at the discretion of the host track.

71 IAC 3-2-9 Judge's list

Authority: IC 4-31-3-9 Affected: IC 4-31

Sec. 9. (a) The judges shall maintain a judge's list of the horses that are ineligible to be entered in a race because of poor or inconsistent performance or behavior on the race track that may endanger the health and safety of the participants and for the protection of the wagering public. The reasons for a horse to be placed on the judge's list and ordered to qualify shall include, but not be limited to, the following on a fast or good track:

(1) Making a break in a qualifying race.

(2) Making a break in a race following a qualifying race unless finishing first, second, or third. Two (2) year old non-wagering purse races for three hundred dollars (\$300) or less shall be considered a qualifying race.

(3) Poor performance or failure to go in a qualifying time.

- (4) Poor performance in a qualifying race regardless of going in qualifying time.
- (5) Making breaks in two (2) consecutive starts unless finishing first, second, or third in one (1) of the two (2).

(6) Being scratched sick or lame in two (2) consecutive programmings.

(7) Numerous bad lines in its last six (6) starts regardless of being consecutive on finishing first, second, or third.

(8) Poor performance while competing in a race followed by a break later in that race.

- (b) Horses racing at all county fair race tracks that return to pari-mutuel race tracks to compete shall be bound by the same qualifying and judge's list standards as horses racing at the Indiana pari-mutual [sic] tracks. Time allowances for half-mile tracks shall be set by the race secretary at the pari-mutuel track, except as indicated in the conditions of the Indiana sires stakes.
- (c) Horses that are on the judge's list or are not eligible to compete due to the qualifying standards at the Indiana pari-mutuel race track may be allowed to compete in "paid in events" if they have a clean line in qualifying time in the last thirty (30) days (race date to race date) unless declared ineligible under 71 IAC 3-2-9(g) or 71 IAC 3-2-9(h) [subsections (g) and (h)].
- (d) Horses allowed to race in a "paid in event" under 71 IAC 3-2-9(e) [subsection (c)] that fail to show a clean line or go in qualifying time in that event shall be placed on the judge's list and show a successful qualifying race prior to competing in another "paid in event".
  - (d) (e) The judges may place a horse on the judge's list when there exists a question as to the exact identification, ownership, or trainer of a horse.
  - (e) (f) A horse may not be released from the judge's list without permission of the judges.
- (f) (g)Qualifying standards shall not be waived for non-Indiana late closers, Indiana sire stakes finals, late closer finals, and all "paid in events" if there exist [sic, exists] a compromise with the health and safety of the participants in those races.
- (g) (h) Horses that are placed on the vet's or judge's list as sick, lame, or injured for a specified number of days, which includes the race date or are required to qualify before racing by the vet or starter, shall not be eligible to race under rule 71 IAC 3-2-9(c) [subsection (c)]. ## Owner/Breeder/Stallion Owner Awards for Open Races

Over the past couple of years, the number of Indiana Bred horses competing and finishing 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> in open races has outgrown the budget allocated to this element of the program. After many meetings and lots of discussion, we have determined that a modification to the award percentage in this element of the program is best. In order to do so, the following rule change is proposed:

#### 71 IAC 14.5-3-1 Owner awards

Authority: IC 4-31-3-9 Affected: IC 4-31

- Sec. 1. (a) An owner award is the award paid to the owner of a registered Indiana bred quarter horse which places first, second, or third in any race except trials and claiming races when entered for a claiming price of less than five thousand dollars (\$5,000) or any speed index race, at a licensed pari-mutuel racetrack in Indiana.
- (b) In the event of multiple owners, the award will be paid to the individual listed first on the Equibase result chart. It is the responsibility of the individual who receives the owner award to distribute these monies to the remaining owners.
  - (c) **For Indiana Bred races** the amount of the award is twelve and one-half percent (12.5%) of the gross purse, distribution is:
  - (1) fifty percent (50%) is awarded to the winner, not to exceed five thousand dollars (\$5,000);

- (2) thirty percent (30%) is awarded to second place, not to exceed three thousand dollars (\$3,000); and
- (3) twenty percent (20%) is awarded to third place, not to exceed two thousand dollars (\$2,000).
- (d) For open races the amount of the award is six and one-quarter percent (6.25%) of the gross purse, distribution is:
- (1) fifty percent (50%) is awarded to the winner, not to exceed two thousand five hundred dollars (\$3,000);
- (2) thirty percent (30%) is awarded to second place, not to exceed one thousand five hundred dollars (\$1,500);
- (3) twenty percent (20%) is awarded to third place, not to exceed one thousand dollars.

  - (1) fifty percent (50%) is awarded to the winner, not to exceed five thousand dollars (\$5,000);
  - (2) thirty percent (30%) is awarded to second place, not to exceed three thousand dollars (\$3,000); and
  - (3) twenty percent (20%) is awarded to third place, not to exceed two thousand dollars (\$2,000).

- (b) In the event of multiple stallion owners, the award will be paid to the individual designated as the recipient on the stallion application. It is the responsibility of the designated recipient to distribute these monies to the remaining stallion owners.
  - (c) **For Indiana Bred races** the amount of the award is twelve and one-half percent (12.5%) of the gross purse, distribution is:
  - (1) fifty percent (50%) is awarded to the winner, not to exceed five thousand dollars (\$5,000);
  - (2) thirty percent (30%) is awarded to second place, not to exceed three thousand dollars (\$3,000); and
  - (3) twenty percent (20%) is awarded to third place, not to exceed two thousand dollars (\$2,000).
  - (d) For open races the amount of the award is six and one-quarter percent (6.25%) of the gross purse, distribution is:

## VERIFIED NOTICE OF THIRD SUBSEQUENT TERM

COMES NOW John S. Keeler in his capacity as Chairman and Secretary of the SEA 609 Negotiating Committee (Committee) and notifies the Indiana Horse Racing Commission (Commission) as follows:

- 1. Section 2 of the Initial Distribution Agreement between Hoosier Park, LLC, Centaur Acquisition, LLC, Indiana Horsemen's Benevolent & Protective Association, Inc., Indiana Standardbred Association, Inc. and Quarter Horse Racing Association of Indiana, Inc., which was dated September 26, 2013, filed with the Commission on September 27, 2013 and approved by the Commission on December 10, 2013 (IDA) provided for a one (1) year term commencing on January 1, 2014 and ending on December 31, 2014 (Initial Term);
- 2. Section 2 of the IDA provided for an extended term of an additional seven (7) years if the requirements of Section 4 and the conditions of Section 5 of the IDA were satisfied (Extension Term). To date, neither the requirements of Section 4 nor the conditions of Section 5 have been satisfied:
- 3. Section 2 of the IDA further provided that if the Initial Term was not extended by the Extension Term, then the term of the IDA would be automatically extended for a periods of one (1) year following the Initial Term (Subsequent Term) provided that neither the Negotiating Committee of the Licensees or the Associations gave written notice of non-renewal prior to September 1<sup>st</sup> of the Initial Term or a Subsequent Term.

- 4. On September 9, 2014, the undersigned filed on behalf of the Committee, a Verified Notice of Subsequent Term stating that neither the Negotiating Committee of the licensees nor the associations had given notice of non-renewal prior to September 1, 2014 and therefore the term of the IDA would be automatically extended for a first Subsequent Term until December 1, 2015;
- 5. On September 18, 2015, the undersigned filed on behalf of the Committee, a Verified Notice of Second Subsequent Term stating that neither the Negotiating Committee of licensees nor the associations had given notice of a non-renewal prior to September 1, 2015, and therefore the term of the IDA would be automatically extended for a second Subsequent Term until December 31, 2016;
- 6. As of September 1, 2016, no notice of non-renewal has been given or received by either the licensees' or the associations' Negotiating Committee; and
- 7. Since no notice of non-renewal has been timely given or received by September 1, 2016, a third Subsequent Term will commence on January 1, 2017 and end of December 31, 2017 without further action by the Commission or parties to the IDA.
