SETTLEMENT AGREEMENT

This Settlement Agreement ("Agreement") is entered into between the Indiana Horse Racing Commission ("Commission"), by Deena Pitman ("Executive Director Pitman"), Executive Director of the Indiana Horse Racing Commission Staff ("Commission Staff") and Shane W. Bowermaster ("Bowermaster"), a licensee (#220902) of the Indiana Horse Racing Commission. Collectively, the Commission Staff and Bowermaster shall be referred to herein as "the Parties." This Agreement is subject to the review and approval of the Commission.

RECITALS

- 1. The Indiana Horse Racing Commission ("IHRC") is the administrative agency in the State of Indiana that regulates horse racing pursuant to provisions of the Indiana Code, Title 4, Article 31.
- 2. At all times relevant to this Settlement Agreement, Bowermaster was a licensee of the IHRC.
- 3. As an IHRC licensee, Bowermaster was required to be knowledgeable of all IHRC rules and regulations.
- 4. Ind. Code 4-31 et seq., 71 IAC 5 et seq., and 71 IAC 8 et seq., set forth the IHRC standards for trainer responsibility and blood gas analysis, respectively.
- 5. On or about July 17, 2020, Bowermaster had two horses entered to race at Harrah's Hoosier Park in Anderson, Indiana. Mykindachip was entered in the fourth race and Arroya's Dance was entered in the twelfth race.
- 6. Prior to race 4, a blood sample was taken from Mykindachip for the purpose of blood gas analysis pursuant to 71 IAC 8-2-2.
- 7. Prior to race 12, a blood sample was taken from Arroya's Dance for the purpose of blood gas analysis pursuant to 71 IAC 8-2-2.
- 8. The results of the blood gas analysis, for both horses, showed readings of pH and bicarbonate above the allowable amount under 71 IAC 8-2-2. Both horses were scratched from competition pursuant to the requirements of 71 IAC 8-2-2.
- 9. On July 21, 2020, the Judges at Harrah's Hoosier Park conducted a hearing regarding possible violations of 71 IAC 8-2-1, 71 IAC 8-2-2, and 71 IAC 5-3-2. In the hearing Bowermaster maintained that he had not administered any substance to either horse that would cause a high blood gas reading.
- 10. Following the hearing, on July 23, 2020, the Judges issued Ruling Nos. HP-2020-2046 and HP-2020-2047 ("Rulings"). The Rulings set forth respective penalties of fifteen and thirty

days based upon the Association of Racing Commissioners International Recommended Guidelines ("ARCI guidelines") for a Class B violation.

- 11. On July 23, 2020, Bowermaster timely appealed the Rulings and requested a stay of the penalty until such time as an administrative hearing was held to decide the outcome of the appeal.
- 12. Bowermaster's suspension began on July 26, 2020, and was set to end on September 8, 2020.
- 13. On July 31, 2020, Administrative Law Judge Michael Buker held a telephonic hearing related to the request for stay of the penalties.
- 14. On August 4, 2020, Bowermaster's stay request was granted, effective immediately on that date.
- 15. Now, in full and complete resolution of any and all further administrative proceedings involving Bowermaster, relative to the violations referenced above, the Commission Staff and Bowermaster agree to the terms and conditions set forth in this Agreement.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing, and the promises and covenants to be performed as set forth herein, the Parties agree as follows:

- 16. Commission Staff maintains that it has sufficient evidence to prove by a preponderance of the evidence that Bowermaster committed the violations charged in the Rulings. Bowermaster contests the same and maintains that there is a lack of necessary evidence to meet the required standard.
- 17. This agreement does not cover any violations that may be discovered that are not referenced in the Judges' Rulings 2020-HP-2046 and 2020-HP-2047. However, the IHRC Staff is not aware of any other alleged violations of any kind of nature at this time.
- 18. Bowermaster agrees to dismiss with prejudice, withdraw and/or waive all related pending legal and administrative proceedings including any related appeals, and release all claims and potential claims against the Commission, the Commission Staff and/or its current or former representatives, agents and/or employees relating to the Commission actions that are the subject of this Settlement Agreement.
- 19. As a result of the disciplinary matter that was the subject of the underlying proceeding, the IHRC Staff and Bowermaster agree to the charge of a single violation of 71 IAC 8-2-2. Pursuant to the ARCI guidelines, the violation carries a penalty of a fifteen (15) day suspension.

- 20. Commission Staff acknowledges the time served by Bowermaster as part of the agreed upon fifteen (15) day suspension.
- 21. Commission Staff credits Bowermaster with ten (10) days served on the suspension period. Bowermaster agrees to serve the remaining five (5) calendar days of the suspension period beginning on October 4, 2020, and going through October 8, 2020.
- 22. No Multiple Medication Violation (MMV) points are assessed for the violation.
- 23. The Parties specifically agree that the suspension shall be governed by applicable Indiana regulations, including but not limited to 71 IAC 10, 71 IAC 5 et seq., and 71 IAC 8 et seq., and any failure to comply with those rules is subject to enforcement by the Judges and/or the Commission.
- 24. Bowermaster and Commission Staff acknowledge that this Agreement is subject to the approval of the Indiana Horse Racing Commission.
- 25. The Commission will enter a ruling consistent with this Agreement which will make clear that the sanctions set forth in Paragraphs 19 through 22 are the total sanctions for the violation referenced in this Settlement Agreement.
- 26. Any waiver of any provision of this Agreement must be in writing and must be approved by the Parties. No waiver of any provision of this Agreement shall constitute either a waiver of any provision hereof (whether or not similar) or a continuing waiver.
- 27. If and to the extent any provision of this Agreement is held invalid or unenforceable at law, such provision will be deemed stricken from the Agreement and the remainder of the Agreement will continue in effect and be valid and enforceable to the fullest extent permitted by law.
- 28. The Parties agree that this Agreement shall be deemed executed in the State of Indiana, and shall be governed and construed in accordance with the laws of Indiana, without regard to its choice of law provisions, and all claims relating to or arising out of this Agreement, or the breach thereof, whether sounding in contract, tort or otherwise, shall likewise be governed by the laws of Indiana, without regard to its choice of law provisions. Exclusive jurisdiction and venue over any and all disputes arising out of or in connection with this Agreement shall be brought only in a state court of competent jurisdiction located in Marion County, Indiana.
- 29. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, fully enforceable counterpart of all purposes, but all of which constitute one and the same instrument.
- 30. Bowermaster represents that he has carefully read and reviewed the foregoing Agreement, acknowledges its contents, has had the right to consult with his own counsel, and

agrees to be bound by its terms. Bowermaster acknowledges that he has voluntarily entered into this Agreement as of the date and year herein set forth.

IN WITNESS HEREOF, the Parties have executed this Agreement on the dates listed below.

2020 Program – Request to Amend Approved Program

Approved by the Thoroughbred Breed Development Advisory Committee on 9/14/2020

The Thoroughbred Breed Development Advisory Committee worked closely with all facets of the Industry (racetrack management, Indiana HBPA and ITOBA) in creating our amended program which the IHRC approved on May 28, 2020. In planning the program, all involved utilized very conservative projections for gaming adjusted gross receipts (AGR) for the remainder of 2020. At this time with just 2 ½ months of casino operations since the Covid-19 shutdown, the Thoroughbred Breed Development program is seeing over \$1.7 million dollars in excess of our projections. After holding meetings with racetrack management, HBPA representatives, ITOBA representatives and horsemen, the Thoroughbred Breed Development Committee would like to request additional funds be approved for the remainder of the meet. The request is as follows:

While we don't know what the exact revenue numbers will be for remaining months of October, November & December, we are fairly confident that the revenue for these months will meet our projections and most likely be higher than expected. Considering this, we would like to propose to add \$1,582,857¹ to the Thoroughbred Breed Development Program Budget to be utilized for the remainder of the meet as follows:

Purse Overnight Supplements - \$1,100,000

This would amend the overall Breed Development Budget item for BDF Purse Contribution Overnight Races to \$5,242,200.

Breeder Awards – \$482,857

This would allow the program to cover increases to Breeder awards for the remainder of the race meet due to increased races in the overnight program.

Stallion Owner Awards – While reviewing the program, we discovered due to a formula error, the amount for Stallion awards approved by the IHRC in May was overstated, therefore we would like to shift some funds from this line item to Breeder Awards for the remainder of the meet.

We would also like to request approval for the Commission to delegate to the Executive Director, the ability to approve a Stakes Bonus Program – effective for only 2020 in which the owner, breeder and stallion owner (if applicable) of the winning stakes race would receive a bonus. This would help make up for the stake purses being reduced and replace some revenue these participants lost during 2020. We

would only implement this program if combined revenues deposited in October and November were in excess of our projections. These bonus payments would be distributed to owner, breeders and stallion owners during the month of December as follows:

Request to Renew Incentive Program to Attract New Mares to Indiana

In December of 2019, the Thoroughbred Breed Development Advisory Committee implemented an incentive program to attract new mares to the state of Indiana for foaling purposes. This program provided a cash incentive to any owner who purchased a mare in foal at a public auction, registered the mare and subsequent foal in the Thoroughbred Breed Development Program. An additional incentive may be earned if that mare was bred back to a registered Indiana stallion after foaling, and produces an IHRC registered foal the following year.

Since December, applications for six mares (owned by five separate owners) have been submitted.

We are requesting approval to continue this program for the 2021 foaling season. The cost to the Thoroughbred Breed Development Program will vary based on the number of participants, but we estimate that it will not exceed \$50,000. The proposed program guidelines are as follows:

New Mare Incentive Program Guidelines for 2021 Foaling Season

The Indiana Thoroughbred Breed Development Program is offering up to \$2,000 in incentives for new mares foaling in the state starting in 2021.

For Mares In Foal Purchased at Public Auction:

To be eligible for the \$1,000 incentive, the buyer must:

- Purchase a mare in foal at a public auction between the dates of October 1, 2020, and March 1, 2021, at a minimum purchase price of \$2,500.
- Submit documentation of purchase with Indiana registration.
- Verify that the mare has not been previously registered in the Indiana Thoroughbred Breed Development Program as a foaling mare.
- Submit a 2021 mare registration with the Indiana Horse Racing Commission prior to foaling.

- The mare must foal in Indiana, and reside in the state for thirty days after foaling, if applicable.
- Fulfill breed back requirements, if applicable.
- Register foal with the Indiana Horse Racing Commission.

Incentive payment will be issued once the 2021 foal has been registered with the program and eligibility is verified.

For an additional \$1,000 incentive, the owner must:

- Breed the purchased mare back to an Indiana Sire registered with the IHRC for the 2021 breeding season.
- Submit a 2022 mare application with the Indiana Horse Racing Commission prior to foaling.
- Return the mare to Indiana to foal in 2022.
- Comply with all requirements of registration.
- Register foal with the Indiana Horse Racing Commission.

Incentives payments will be issued once the 2022 foal is registered with the program and eligibility is verified.

For Open Mares Purchased at Public Auction:

To be eligible for the \$1,000 incentive, the buyer must:

- Purchase an open mare at a public auction between the dates of October 1, 2020 and March 1, 2021, at a minimum purchase price of \$2,500.
- Submit documentation of purchase with Indiana registration.
- Verify that the mare has not been previously registered in the Indiana Thoroughbred Breed Development Program as a foaling mare.
- Breed the purchased mare to an Indiana Sire registered with the IHRC for the 2021 breeding season.
- Submit a 2022 mare application with the Indiana Horse Racing Commission prior to foaling.
- Return the mare to Indiana to foal in 2022.
- Comply with all requirements of registration.
- Register foal with the Indiana Horse Racing Commission.

Incentive payment will be issued once the 2022 foal has been registered with the program and eligibility is verified.

For an additional \$1,000 incentive, the owner must:

- Breed the purchased mare back to an Indiana Sire registered with the IHRC for the 2022 breeding season.
- Submit a 2023 mare application with the Indiana Horse Racing Commission prior to foaling.
- Return the mare to Indiana to foal in 2023.
- Comply with all requirements of registration.
- Register foal with the Indiana Horse Racing Commission.

Incentives payments will be issued once the 2023 foal is registered with the program and eligibility is verified.

Dear Deena Pitman,

I'm writing to you on behalf of the ITOBA Board of Directors. I do so to advise you of ITOBA's position regarding ADW allocation.

ITOBA believes horsemen across the midwest, especially Indiana horsemen, are extremely grateful to have live racing up and running after the Covid 19 shutdown. From the State House, IHRC, Breed Development staff, Indiana Racing Associations, track management to yourself, the IHRC Executive Director, extraordinary efforts were made to cause this to happen.

Representatives of ITOBA Board of Directors have attended and/or participated in recent Breed Development meetings. Additionally we have spoken to Eric Halstom, Jessica Barnes, and other stake holders as well as reviewed many related documents as possible in an effort to stay "tuned in". After much discussion among our directors and committees it appears clear that more needs to be done to maintain purse levels and race counts through the scheduled end of the 2020 meet.

ITOBA's ADW balance as of September 1st was \$182,990.47. ITOBA respectfully requests the following allocation of it's Thoroughbred ADW funds subject to the approval of the IHRC.

- Transfer \$148,490.47 to the Indiana Grand open purse account. This amount will help offset the added supplement Indiana Grand is paying on Indiana Bred and Sired races.
- Transfer \$20,000.00 to ITOBA. This is an amount that ITOBA has paid to cover a purse shortfall on 2 stakes on 9/2/20.
- Transfer \$9,500.00 to ITOBA. This is an amount paid out as an owners bonus on 2 stakes on 9/2/20.
- Transfer \$5,000.00 to ITOBA. This is a small portion of marketing and promotion commitments that would include, but are not limited to, a Stallion Register, Breed Development Awards and Indiana Breeders Day.

ITOBA ADW monies earned in September 2020-

• Transfer all monies earned in September to Indiana Grand open purse account.

ITOBA ADW monies earned in October 2020-

• Transfer all monies earned in October to Indiana Grand open purse account.

The delayed starting dates for training and racing has cost Owners, Trainers, Breeders and Stallion Farms hundreds of thousands of dollars with little, if any, way to recoup their losses. The strength and success of the 2020 meet for Indiana horsemen will have a HUGE impact on breeding decisions, the yearling market, retention of horses in training, etc. These decisions will impact Indiana's foal crop and race program for years to come.

The details of our request have been considered seriously and are supported unanimously by our directors and officers.

As discussed in our phone call on August 18th, Indiana Grand would like to propose a substitution within the approved 2020 capital plan. In reviewing the approved 2020 capital plan for Indiana Grand there are several items that were on our list that we do not need and would not add any value to the racing program by purchasing at this time. Instead of spending money on procuring these items, the property would like to substitute the spending to purchase items that will have a larger impact on racing.

The items that we would like to eliminate from the purchase plan are:

- 1) Ryan Aerator (\$5,202)
- 2) Turf Thyme Small Roller (\$3,121)
- 3) Crop Care Turf Sprayer (\$5,200)

Total: \$13,523

The item that we would like to substitute is a back flow device for our Trackside fire system. The issue that we've run into is that after we replaced the #1 gate valve on the trackside backflow (that work has been performed) it was found that the #2 gate valve won't shut off properly and also needs to be replaced. This is a fairly significant project in that the track side water will need to be turned off for approximately six hours to make this repair. The quote that we are likely to use states that it will be a \$15,188.10 project which we can schedule upon IHRC approval for the substitution.
