Please consider this letter as Hoosier Park, LLC's (Hoosier Park) Application for Annual Permit Renewal and for approval of 2016 Race Dates.

This application is made pursuant to IC 4-31-5-2(a) and IC 4-31-5-9 as well as the following administrative rules: (1) 71 IAC 11-1-3(b); (2) 71 IAC 11-1-7; (3) 71 IAC 11-1-21 and (4) 71 IAC 2-9-1. In support thereof Hoosier Park states that:

- 1) Hoosier Park is an Indiana limited liability company;
- 2) Hoosier Park is the holder of a recognized meeting permit to conduct pari-mutuel horse racing at Hoosier Park, 4500 Dan Patch Circle, Anderson, Indiana 46013 and that the Indiana Horse Racing Commission (Commission) has previously approved Hoosier Park for the exclusive racing of Standardbred horses;
- 3) Hoosier Park is the owner of its racing plant with a physically connected clubhouse that displays for public inspection trophies, memorabilia and instructional materials depicting the history of horse racing and is available as a repository for the collections of the Indiana Harness Horse Hall of Fame; and
- 4) Hoosier Park proposes to conduct a total of 160 days of Standardbred racing, commencing on Friday, April 1, 2016, and concluding on Saturday, November 12, 2016. Racing will take place Tuesdays through Saturdays with a post time of 5:45


p.m. A calendar of race dates is attached hereto as Exhibit A and by reference made a part hereof.


