Sec. 3.5 (1) There shall be a pole erected 330 feet in front of the starting pole.

- (2) The pole must:
- (A) have written on it "FAIR START POLE"; and
- (B) be approved by the Executive Director or Judges.
- (3) If a horse does not reach the Fair Start Pole before the field is released at the start, the judges shall display the INQUIRY sign immediately.
- (4) Any horse not reaching the Fair Start Pole before the starter releases the horses at the Starting Pole shall be declared a non-starter for wagering purses. All monies wagered on that horse shall be refunded.
 - (5) All drivers must make a reasonable effort to reach the fair start pole.
- (6) Any horse which fails to reach the Fair Start Pole more than one (1) time in a calendar year may be placed on the qualifying list.

Please find this correspondence as Hoosier Park's position on the Fair Start Pole that we understand is currently being considered by the Indiana Horse Racing Commission ("IHRC").

We are very much in favor of a Fair Start Pole even though we realize that it is not currently in use at any harness track in the USA. However, we feel the time has now come for the Fair Start Pole to be introduced to harness racing at Hoosier Park Racing & Casino.

We believe the Fair Start Pole answers the question of fairness when one juxtaposes the interests of horses competing in a race with the betting public wagering on that race. We further believe that anything that can be done under IHRC rules to ensure that the bettor is being given a "fair shake" is a good thing. After all, the bettor is the backbone of our sport and all too often racing takes the bettor for granted.

We hope that with implementation of the Fair Start Pole in Indiana, the harness racing world will see that all stakeholders in the Indiana harness racing industry are committed to the advancement of our wonderful sport.

In closing, we understand that there may be pushback from some quarters. For example, we have heard from some other track owners/operators that find the possibility of issuing more refunds to be a negative. It should be stated that this is the only negative we have come across. To allay any concerns over the Fair Start Pole we would suggest a trial period that would run through the remainder of the 2015 Hoosier Park racing season. Once racing ends, all parties
