The Indiana Board of Tax Review ("Board") issues this determination, finding and concluding as follows:

PROCEDURAL HISTORY

- 1. Nowacki contested the 2013 and 2014 assessments of his property located at 4843 W. 28th Avenue in Gary. The Lake County Property Tax Assessment Board of Appeals ("PTABOA") issued its determinations valuing the vacant lot at \$2,200 for 2013 and \$1,400 for 2014.
- 2. Nowacki filed Form 131 petitions with the Board and elected to proceed under our small claims procedures. On November 12, 2019, Ellen Yuhan, our designated Administrative Law judge ("ALJ") held a hearing on Nowacki's petitions. Neither she nor the Board inspected the property.
- 3. Nowacki appeared pro se. The Assessor appeared by hearing officers Joseph James and Robert Metz. They were all sworn as witnesses.

b. The record for the matter also includes the following: (1) all pleadings, briefs, motions, and documents filed in this appeal; (2) all notices and orders issued by the Board or our ALJ; and (3) an audio recording of the hearing.

BURDEN OF PROOF

- 5. Generally, a taxpayer seeking review of an assessing official's determination has the burden of proof. Indiana Code § 6-1.1-15-17.2 creates an exception to that general rule and assigns the burden of proof to the assessor in two circumstances--where the assessment under appeal represents an increase of more than 5% over the prior year's assessment, or where it is above the level determined in a taxpayer's successful appeal of the prior year's assessment. I. C. § 6-1.1-15-17.2 (b) and (d).
- 6. Here, the assessment remained unchanged from 2012 to 2013. Nowacki therefore bears the burden of proof for 2013. The burden of proof for 2014 depends on the outcome for 2013.

SUMMARY OF CONTENTIONS

7. Nowacki's case:

- a. This subject property is in a platted subdivision that has no development. The PRC shows the roads are paved and utilities are available, but it incorrectly shows the neighborhood life cycle as static. The assessed value has decreased from \$3,600 in 2010 to the current \$1,200, indicating a declining neighborhood life cycle. Nowacki believes that the property's value is considerably less than \$1,400. He thinks its fair market value is \$500 for both years. *Nowacki testimony; Pet'r Exs. A, B, C, D.*
- b. He acquired the property 10 years ago for a nominal bid at an auction attended by hundreds of people. He has been appealing the assessment ever since. The process is slow because the Assessor has no urgency to correct the assessments. The assessment is getting closer to market value, but it is only changing by trivial amounts at a sloth-like pace. *Nowacki testimony*.
- c. U. S. Steel was over-assessed and it was able to get its property reassessed. After the reduction, the response of the Calumet Township Assessor's Office was to raise everyone else's assessment to make up for the loss. The taxing bodies' response was then to take the over-assessment and raise taxes to fund the bloated budgets of various taxing units. Higher taxes and higher assessments lower market value. This is manifested year after year as the city continues into free-falling collapse. Schools are closed. Libraries are closed. Streets are unpaved. Parks are not maintained. The crushing weight of over-assessment has destroyed the city, making it almost impossible to live there. *Nowacki testimony*.

8. The Assessor's case:

a. The Assessor recommends the 2013 assessment be reduced to \$1,400, and that the 2014 assessment remain at \$1,400. *James testimony*.

ANALYSIS

- 9. Nowacki failed to make a prima facie case for reducing the property's 2013 or 2014 assessments. However, we accept the Assessor's concession that the 2013 assessment should be \$1,400. The Board reached this decision for the following reasons:
 - a. The goal of Indiana's real property assessment system is to arrive at an assessment reflecting the property's true tax value. 50 IAC 2.4-1-1(c); 2011 REAL PROPERTY ASSESSMENT MANUAL at 3. "True tax value" does not mean "fair market value" or "the value of the property to the user." I.C. § 6-1.1-31-6(c), (e). It is instead determined under the rules of the Department of Local Government Finance ("DLGF"). I.C. § 6-1.1-31-5(a); I.C. § 6-1.1-31-6(f). The DLGF defines "true tax value" as "market value in use," which it in turn defines as "[t]he market value-in-use of a property for its current use, as reflected by the utility received by the owner or by a similar user, from the property." MANUAL at 2.
 - b. All three standard appraisal approaches—the cost, sales-comparison, and income approaches—are "appropriate for determining true tax value." MANUAL at 2. In an assessment appeal, parties may offer any evidence relevant to a property's true tax value, including appraisals prepared in accordance with generally recognized appraisal principles. *Id.* at 3; *see also Eckerling v. Wayne Twp. Ass'r*, 841 N.E.2d 674, 678 (Ind. Tax Ct. 2006) (reiterating that a market value-in-use appraisal that complies with the Uniform Standards of Professional Appraisal Practice is the most effective method for rebutting the presumption that an assessment is correct). Regardless of the appraisal method used, a party must relate its evidence to the relevant valuation date. *Long v. Wayne Twp. Ass'r*, 821 N.E.2d 466, 471 (Ind. Tax Ct. 2005). Otherwise, the evidence lacks probative value. *Id.* For 2013 and 2014, the valuation date was March 1st of each respective year. Ind. Code § 6-1.1-2-1.5(a).
 - c. Nowacki contends the 2013 assessment should be \$500, but he failed to present any probative market-based evidence to support that value. Statements that are unsupported by probative evidence are conclusory and of no value to the Board in making its determination. *Whitley Products, Inc. v. State Bd. of Tax Comm'rs*, 704 N.E.2d 1113, 1118 (Ind. Tax Ct. 1998).
 - d. We also give no weight to his claims regarding the property's decreasing assessment. The Assessor's decision to decrease the property's assessment between 2010 and 2018 does not prove that the 2013 or 2014 assessments are incorrect. As the Tax Court has explained, "each tax year---and each appeal process--- stands alone." *Fisher v. Carroll Cnty Ass'r*, 74 N.E.3d 582 (Ind. Tax Ct. 2017). Evidence of a property's assessment in one year, therefore, has little bearing on its true tax value in another. *See e.g. Fleet Supply, Inc. v. State Bd. of Tax Comm'rs*, 747 N.E.2d 645, 650 (Ind. Tax Ct. 2001); *Barth, Inc. v. State Bd. of Tax Comm'rs*, 699 N.E.2d 800, 805 n. 14 (Ind. Tax Ct. 1998).

- e. Because Nowacki offered no probative market-based evidence to demonstrate the property's correct market value-in-use for 2013, he failed to make a prima facie case for a lower assessment. Nevertheless, the Assessor conceded that the 2013 assessment should be \$1,400, and we accept the Assessor's concession.
- f. We now turn to the 2014 assessment. Following the reduction to the 2013 assessment, the property's assessment remained unchanged from 2013 to 2014. Nowacki therefore retains the burden of proof for 2014. He relied on the same evidence and arguments and we therefore reach the same conclusion—he failed to make a prima facie case for a lower assessment.

FINAL DETERMINATION

In accordance with the above findings of fact and conclusions of law, we order the 2013 assessment reduced to \$1,400. For 2014, we find for the Assessor and order no change.
