



## Community Corrections Division

The Community Corrections Division is a unit under the Indiana Department of Correction (IDOC) Re-Entry Division. The division is primarily responsible for providing state aid through the **Community Corrections and Justice Reinvestment Funding** and administration of the **Community Transition Program (CTP)**.

The Community Corrections Division, in partnership with state and local criminal justice agencies and Community Corrections Advisory Boards, work collaboratively to develop community corrections programs utilized by local courts and the Department of Correction (IDOC) to supervise, sanction and treat offenders in the community as an alternative to incarceration.

**COMMUNITY TRANSITION PROGRAM (CTP)**

The Community Transition Program department is responsible for the oversight of the Community Transition Program (CTP) under the authority of IC 11-8-1-5.5. CTP is the assignment by the court of an offender from the Indiana Department of Correction (IDOC) to a Community Corrections program or, in a county that does not have a Community Corrections program, supervision by another approved agency from the offender's CTP commencement date until the offender completes his/her fixed term of imprisonment, less any applicable credit.
