- 1. The completed table below beginning with the original family owner and continuing to the present owner(s).
- 2. A document illustrating each transfer of ownership. The copy may be either of an original instrument, records maintained in a courthouse, or the page(s) from an abstract of title covering the real estate. The copies must demonstrate an unbroken familiar chain-of-title from the date that a member of your family originally acquired an interest in the real estate to the present.
- 3. A copy of the most recent property tax bill showing taxes are current.
