**Q1. Do you need one application if you are applying for several programs or do you need an application for each program?**

One application per agency. Please follow section *IX. Application Instructions* as some sections are required for each propose service requested. (For example: if applying for two services, two Statement of Need sections are required, one per service.)

**Q2. Is the SUID Prevention replacing the pack and play distribution through ISDH?**

Yes. This funding opportunity will replace the previous crib distribution style for all partners, with the exception of first responder programs (like DOSE) that include crib distribution.

**Q3. The up to 45% match does that have to be a cash match? Can the match come in the form of in kind or shared services similar to how Head Start allows for their grants?**

The match provided has to be:

- (1) Spent on project activities allowable under Title V subaward
- (2) Non-Federal in source
- (3) Cannot be used to match any other Federal grant.

**Q5. Is my agency able to apply for several of the options mentioned in the separate service standards?**

Yes. You may apply for all opportunities your agency is interested in participating in.

**Q6. Will funding still be available outside of this opportunity for first responder SUID Prevention resources?**

Yes. This program will remain separate at this time.

**Q7. How do I know if my area has a high SUID rate?**

**Q8. How do I know if anyone else in my area is applying?**

Though we will not have that information until applications are due and submitted, you may use the outreach site map (<https://gis.in.gov/apps/isdh/safesleep/>) to gather contact information on agencies that have historically provided safe sleep outreach in your communities. It may be helpful for you to reach out to and discuss opportunities for collaboration.
