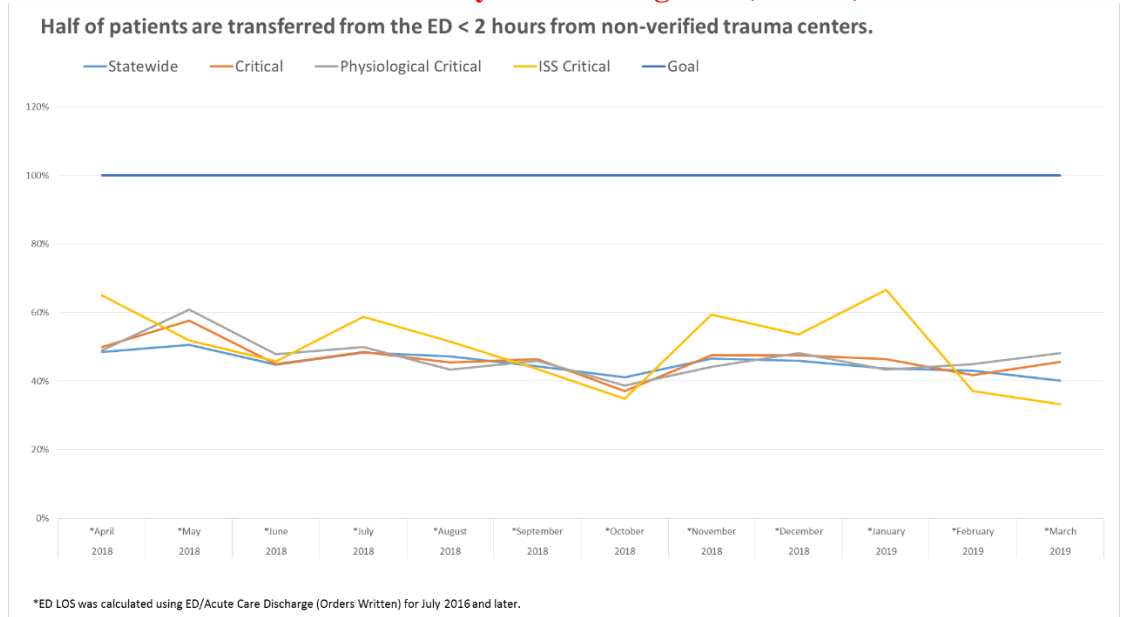

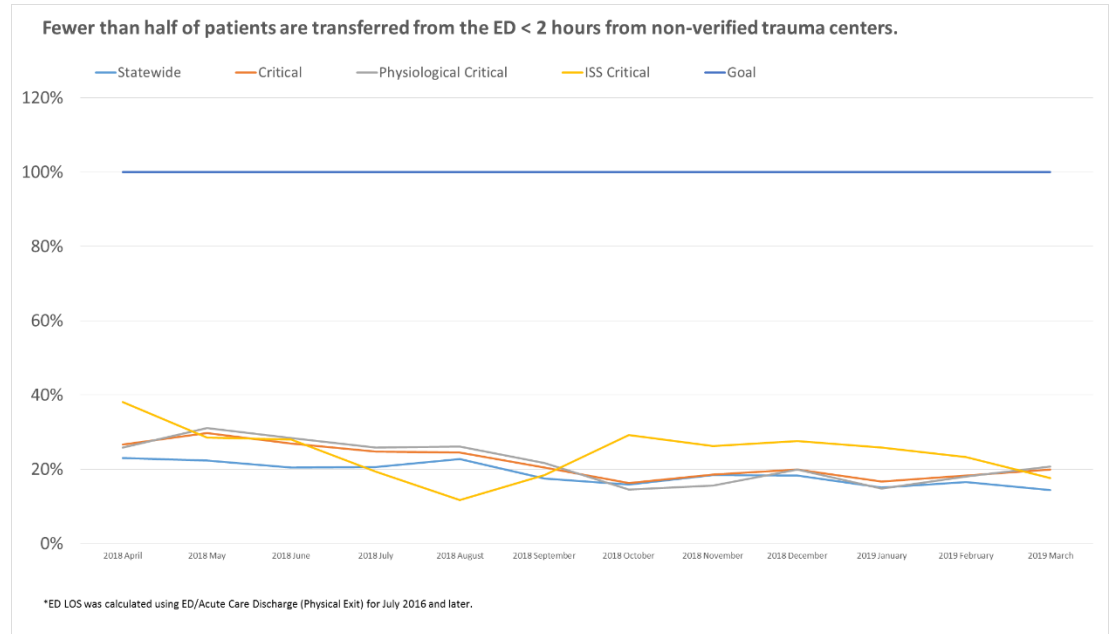

2. 2019 Goals
 - a. Decrease ED LOS at non-trauma centers
 - b. Increase trauma registry quiz participation
 - c. Collect hospital level variables – Dr. Jenkins
 - i. We have >90% response rate from all the hospitals. Thanks to everyone who helped make this happen. Dr. Jenkins will work with Ramzi on this.
ACTION: Katie – mention this to the trauma committee.

- ii. Ramzi has a spreadsheet of contacts at each hospital and there has been staff turnover, so this project has helped with updating contact information.
- d. Continued EMS run sheet collection
- 3. Decrease ED LOS at non-trauma centers
 - a. Transfer delay reporting – this started in 2019
 - b. Letters to hospitals about ED discharge date/time
 - i. Quarter 1 2019: 16 letters were sent and 7 received back at ISDH by 9/9
 - 1. Katie – most of the reasons for long ED LOS are due to clerical/typing errors.
 - ii. Quarter 2 2019: the letter are going out (next meeting)
 - c. ED LOS (Orders Written)
 - i. Jill asked why we are below the goal? ISDH recommended looking at transfer delay responses.
 - ii. **ACTION: ISDH needs to add a key for the categories (ISS>15).**

4. Increase trauma registry quiz participation
 - a. Looked at all August 2018 to August 2019 quizzes
 - b. 35 people took the quiz at least 5 times (the quiz goes to 50 people)
 - i. Result (for June 2019 quiz): 69% (was 55% last meeting)
 - c. Someone asked how we can increase the percent participating?
 - d. **ACTION: ISDH will contact all of the registrars.**
5. Collect hospital level variables
 - a. This request was approved at the February ISTCC meeting.
6. Continued EMS run sheet collection
 - a. Please send Murray Lawry (mlawry@isdh.in.gov) a list of EMS providers not leaving run sheets.
 - b. Discussed EMS providers starting with new EMRs and that is improving the run sheet collection process.
 - i. Concerns with hospitals having to go into the EMRs and pull all the run sheets because they are not in the charts.
 - c. Discussion around EMS run sheets being pushed to trauma centers vs. pulled.
 - d. Discussion about integration going between hospital and EMS interfaces. Cost is a factor.
7. Quarterly updates

b. Who can reach out to non-reporting hospitals by district? What are the hospital’s barriers to reporting?

c. Transfer delay

i. New options are required for non-trauma centers starting Q1 2019.

ii. Transfer Delay – main categories

1. Discussion around what is contributing to the high ‘missing’ and ‘null’ counts. The reason may be that it’s hard to find the transfer delay details sometimes.

2. Discussion around the lack of infrastructure at NTCs to collect this information.

a. ACTION: Dr. Jenkins will create a group to focus on data entry. He’s waiting to hear back on funding. He wants IRB approval by November.

3. Discussion around the age of the patient impacting the transfer delay.

a. ACTION: Can ISDH look at cause of injury and patient age?

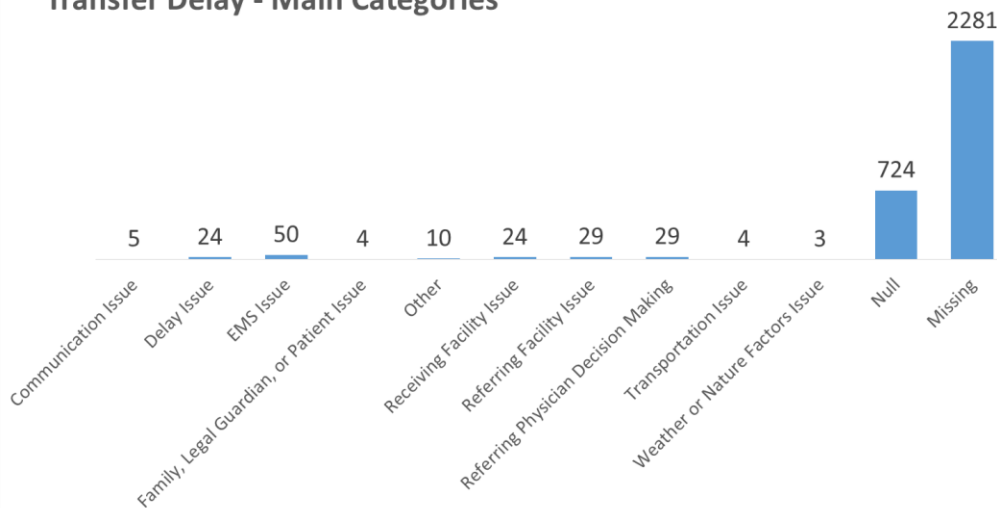
4. Discussion that Dr. Jenkins’ project may uncover some factor that we can look at here.

5. Discussion around not lumping the NTCs. What if they are broken out? One project he is working on is hospital variation among NTCs. Look at missingness, transfer data, etc. See which hospitals are doing well and get peer mentorship going on.

6. ACTION: Discuss capturing transfer delay reasons at the TRACs and have it an agenda item at each TRAC. Engage the registrars.

a. ACTION: ISDH can create a one-pager on why capturing this information is important and what the state’s goal is.

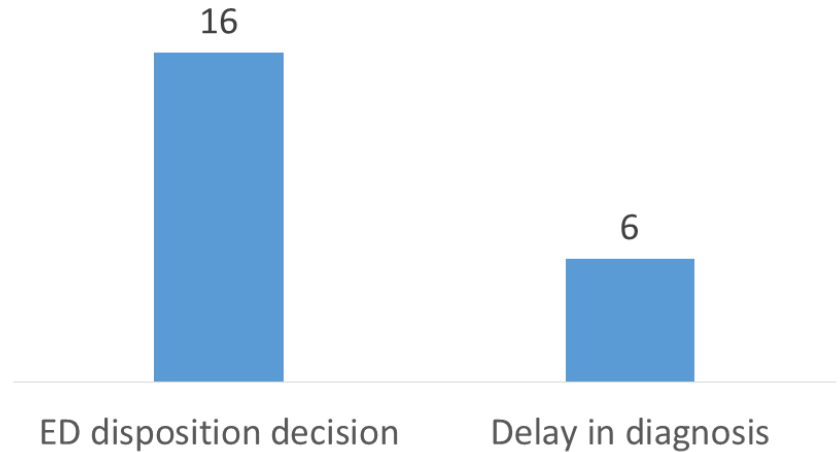
Transfer Delay - Main Categories

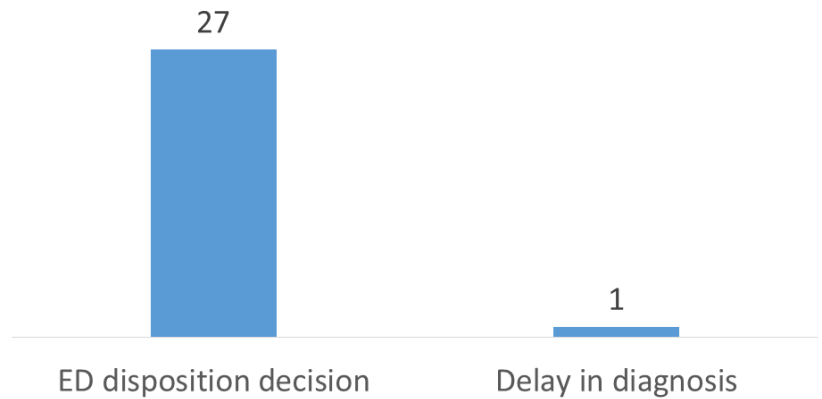
