Re: Administrative Cause Number 19-114L
Petition for Rule Change – Boat Speed Limit

Commission Members:

On September 2, 2020, the City of Fort Wayne through the City's Department of Parks and Recreation filed a petition for rule change with the NRC under Indiana Code section 14-15-7-3. The NRC accepted the petition and initiated the procedure under Information Bulletin #7. The Director of DNR assigned a Committee comprised of Lt. Kenton Turner and Lt. Erick Bolt, of the Division of Law Enforcement, and Rebecca McClain, of DNR Legal Counsel. The Committee members provide the following recommendation:

Background

The City requests a no wake zone along the Riverfront Development Area. This Designated Area (see Exhibit A attached to the Petition) stretches along portions of three rivers: St. Mary's River, St. Joseph River, and Maumee River. Petitioners claim an increase in boating and pedestrian activities in the Designated Area. The City claims that activities such as boating, kayaking, and other watercraft activities create safety hazards due to blind curves. In addition, the City states that Promenade Park recently opened increasing pedestrian use within the Designated Area. Petitioners also believe a no wake zone will prevent disturbance to wildlife habitats in the area. More development activities are anticipated along the Designated Area in the coming years.

Legal Standards

IC 14-15-7-3 Adoption of rules; violations

Sec. 3. (a) The department may adopt rules under <u>IC 4-22-2</u> to implement this article concerning the following:

(4) The safe operation of watercraft upon public water where unusual conditions or hazards exist, such as any of the following:

- (A) An obstruction in or along public water.
- (B) Watercraft traffic congestion.
- (C) A beach, boat launch, marina, dam, spillway, or other recreational facility on or adjacent to public water.

- (6) The establishment of zones where the use of watercraft may be limited or prohibited for the following purposes:
 - (A) Fish, wildlife, or botanical resource management.
 - (B) The protection of users.

- (b) In a rule adopted under subsection (a)(4) or (a)(6), the department may establish a zone where:
 - (1) the operation of all or some types of watercraft is prohibited;
 - (2) particular activities are restricted or prohibited; or
 - (3) a limitation is placed on the speed at which a watercraft may be operated.
 - (c) A person who violates this section commits a Class C infraction.

Analysis

The Committee provides the following analysis and supporting evidence from the Divisions of Law Enforcement and Fish & Wildlife.

1. <u>Increased boating traffic</u>

The City has provided affidavits from private and public individuals and entities in support of the petition that there is an increase in watercraft traffic congestion in the Designated Area. DNR's Division of Law Enforcement also provides information from local boating businesses.

The numbers below represent activity from the Sweet Breeze and the Tri-State Watershed passenger cruises, provided by Robert Menze of Friends of the Rivers:

2017 season: 38 tours with 1,200 riders 2018 season: 98 tours with 3,171 riders

2019 season: Before Promenade Park opening – 28 tours with 743 riders

After Promenade Park opening – 112 tours with 3,852 riders

2019 Season total: 140 tours with 4,595 riders

The Fort Wayne Parks and Recreation Department stated it is in the process of negotiating with Friends of the River to operate the Sweet Breeze Canal boat in downtown Fort Wayne. Both parties anticipate at least a 20% or more increase of scheduled tours on the downtown rivers. However, due to the COVID-19 emergency in 2020 there are no numbers to indicate this trend as the passenger cruises were unable to run. No further information was provided on running the passenger cruises in 2021.

The following numbers represent boats launched downtown by Fort Wayne Outfitters, provided by Cara Hall. Ms. Hall also provided information to compare just one day, the last Saturday in both July 2019 at 45 boats launched and July 2020 at 176. Numbers were unavailable for 2017 and 2018. Ms. Hall also provided information there were low numbers in May and June of 2019 due to flooding.

The information provided by boat retailers shows an increase in boat traffic for 2019 and 2020, due in part to recent development in the Designated Area. In addition, Phase 2 of the development in the area includes a concrete dock near the Martin Luther King Jr. Bridge and a floating boardwalk just upstream from there. For these reasons, the Committee believes regulation due to watercraft traffic congestion is necessary.

2. Safety issues

The City also asserts that for the protection of pedestrians and boaters a no wake zone is necessary along the growing Riverfront Development Area. DNR's Division of Law Enforcement provided information going as far back as 1995 that no pedestrian accidents involving boaters have been reported and only one boating accident involving a cruise boat and speedboat was reported in 2020. The speedboat was cited for reckless driving. No further evidence has been provided by local law enforcement to support the claims of safety hazards. However, safety of users is of utmost concern where traffic is steadily increasing.

3. Impacts to fish and wildlife

Finally, the City claims that the no wake zone would prevent disturbance to fish and wildlife and surrounding habitat. No evidence in support of this claim was provided. DNR's Division of Fish & Wildlife believes that a speed limit to reduce wake may reduce effects that can potentially cause erosion and habitat degradation. The Division also supports efforts for habitat protection and restoration in the area to prevent further disturbance.

4. Nonnavigable waterway

Currently, 312 IAC 5 contains boating regulations for public waters of Indiana. Under the code, rules have been established for specified public freshwater lakes, specified navigable waterways (other than Lake Michigan), Lake Michigan, specified waters owned by public utilities, and specified lakes and reservoirs with state or federal funding. This situation is unique because St. Mary's River has been declared by the US Congress as nonnavigable. Therefore, it does not fit neatly under 312 IAC 5-7. For this reason, the Committee finds that a no wake zone or speed limit for the Designated Area cannot be added to the specified navigable waterways. Instead, a new category of boating regulations for "other public waters" would need to be proposed for rule adoption.

5. Enforcement

DNR along with local law enforcement would be authorized to enforce a no wake zone.

Recommendation

The Committee has determined that there is an increase in boat traffic, which is likely to further increase with development and cause safety hazards along the Designated Area. DNR understands the need to regulate and provide safe recreational activities within the urban Designated Area. In addition, fish and wildlife in the area may benefit from speed regulation along with continued local efforts for habitat management.

Instead of a "no wake" zone, the Committee recommends an "idle speed" zone. Indiana Code section 14-8-2-129 defines "idle speed" as "the slowest possible speed, not exceeding five (5) miles per hour, that maintains steerage so that the wake or wash created by the watercraft is minimal." Indiana Code section 14-15-3-17 provides that "a person may not operate a motorboat within two hundred (200) feet of the shore line of a lake or channel of the lake at a speed greater than idle speed." Idle speed allows for safe steering while creating the smallest wake and slowest possible speed. A "no wake" speed limit could create a hazardous situation because in order to comply with no wake you may sacrifice being able to steer/navigate safely, especially on a river where there is a current. Some vessels because of their size or design would have to create some wake in order to be able to steer. Idle speed is commonly used as the speed restriction in the law for areas where there is high congestion such as in channels or within 200 feet of shore where there are swimmers, piers, boat lifts, swim rafts etc. *See e.g.* 312 IAC 5-6-6; 312 IAC 5-7-2.

If the NRC chooses to adopt a rule, it should create a new category of boating regulations applied to "other public waters" at 312 IAC 5-7.5 to accommodate the City's request along the Designated Area that includes the St. Mary's River.

Dear Commission Members:

The purpose of this letter is to petition the Commission under IC 14-15-7-3 to limit boat traffic speed within a section of the St. Marys and St. Joseph Rivers and their confluence with the Maumee River in the City of Fort Wayne, Indiana (the "City) thorough the creation of a "no wake zone". The specific area over which the no wake zone is requested is depicted in the City's 2015 River Study attached hereto as Exhibit A (the "Designated Area"). The full plan can be found at http://riverfrontfw.org/about/#history under Riverfront Planning/Riverfront Fort Wayne Conceptual Plan.

The City's request for a no wake zone in the Designated Area derives from the large increase in boating and pedestrian activities in the Designated Area following from the City's opening of Promenade Park as Phase I of the City's Riverfront Development and the anticipated increase in such activities as Phases II and III of the Riverfront Development are developed.

Subsequent to the opening of Promenade Park in 2019, the Designated Area has experienced a significant increase in commercial and private boat traffic and pedestrian activities, the combination of which has created multiple issues requiring the implementation of a no wake zone.

The Designated Area is now populated by: (a) "Sweet Breeze" (an authentic canal boat replica providing boat rides for the public in the St. Mary's River with mooring privileges in the Designated Area); (b) kayaks, canoes and stand-up paddle boards which are rented by the public from "Fort Wayne Outfitters "(a recreational personal watercraft business) and used in the Designated Area; commercial boat operators which provide boat rides for the public in the Designated Area; (c) a variety of special events which are held within or in the proximity of the Designated Area; (d) privately owned boats, kayaks and other watercraft which utilize the Designated Area; and (e) a significant segment of the general public who regularly frequent Promenade Park and use the shoreline bordering the Designated Area for recreational activities.

The increase boat traffic and increased pedestrian activities in the Designated Area are not compatible with watercraft navigating the Designated Area at an unregulated speed. Increased noise levels, the disturbance of wildlife habitats and safety concerns due to blind curves in the rivers are also issues of concern which have increased due to unregulated boat speeds in the Designated Area. The imposition of a no wake zone in the Designated Area is required to achieve compatibility between watercraft use in the Designated Area and the current and anticipated increase in the many Riverfront Development activities.

Attached hereto are letters of support from both public and private sector interests which express concerns regarding the current situation and the need to regulate boat speeds in the Designated Area through the adoption of a rule by the Natural Resources Commission which establishes a no wake zone for the Designated Area.



Subsequent to the opening of Promenade Park in 2019, this area of the rivers has experienced a significant increase in commercial and private boat traffic and pedestrian activities, the combination of which has created multiple issues requiring the implementation of a *no wake zone* and watercraft speed regulation. There are many new boaters with little to no experience who are now using the rivers, and they are often unfamiliar with safe boating practices.

Increased noise levels, the disturbance of wildlife habitats and safety concerns due to blind curves in the rivers are also issues of concern which have increased due to unregulated boat speeds. The creation of a *no wake zone* in the area is required to allow for the anticipated increase in many Riverfront Development activities, which we also support as residents, and to maintain the comfort and safety of our neighborhoods.

The Board of Friends of the Rivers, Inc. enthusiastically support the "no-wake zone" petition of the City of Fort Wayne Department of Parks and Recreation for the discussed designated area portions of the downtown Fort Wayne rivers.

Fort Wayne has been blessed by an abundance of river traffic in these last 3-4 years. Adequate river space exists only for that traffic while a safe and no wake speed is maintained.

Our non-profit 501(c)(3) operates the largest vessel on the three rivers...by far! Our replica Wabash & Erie Canal boat is 54' long 11'wide weighing over 27,000 pounds. Our boat, Sweet Breeze, carries 40 passengers for public tours of the designated areas of the St. Marys, St Joseph and Maumee Rivers. We employ licensed and trained captains. We move slowly...by design. If a fast-moving vessel strikes our boat the risk of significant damage to our boat is small. The risk to our less agile or disabled passengers would be significant if we must abandon ship. The risk of a fast moving craft striking a self-propelled personal watercraft is much greater. Many of those individuals on personal watercrafts are first time on the water experiencing kayaking, canoeing and stand up paddle boarding sometimes in erratic fashion. They would be and are in great danger with great risk of personal injury with the current no speed limit rules.

For the safety of our rivers and for those many enjoying them, Friends of the Rivers support the "no wake zone" for Downtown Fort Wayne.



The city's request for a no wake zone in the designated area derives from the large increase in boating and pedestrian activities, following the opening of Promenade Park as a Phase I of the city's riverfront development efforts. SOP #: S03 INCIDENT REPORTING AND INVESTIGATION PROCEDURES

CATEGORY: Safety PREPARED BY: Lozo DATE: March 20, 1995

Revised: February, 2015; July, 2018

PURPOSE: Provide guidance for employees and supervisors reporting or investigating incidents resulting in employee injuries and/or vehicle or equipment damage. This SOP and the attached forms replace all previous SOPs, injury report cards and vehicle accident cards.

REQUIRED PROCEDURES, PROCESS OR ACTIONS:

- A. General.
- B. Forms Used
- C. Reporting Incidents

APPLICABILITY: All Park Department employees and volunteers.

REFERENCES AND FORMS:

City of Fort Wayne Policy and Procedure Manual – 6.10 Drug and Alcohol Testing Procedures.

City of Fort Wayne Policy and Procedure Manual –6.04 Safety and Health City of Fort Wayne Accident/Injury Investigation Report (IAIR). FWPRD Patron Injury Report.

FORT WAYNE PARKS AND RECREATION INCIDENT REPORTING AND INVESTIGATION STANDARD OPERATING PROCEDURE

A. GENERAL. An incident is a situation occurring during completion of official department business that had potential (near miss) to or result in:

An employee injury or illness;
Damage to department facilities, equipment or vehicles;
A patron injury; or,
Damage to private property.

Incident examples are: vehicle accident, rolling a mower, sudden equipment component failure, chemical splashes on skin, a grinding wheel blowing up, engine seizing, etc - anything out of the ordinary.

Incident reporting alerts and informs management and employees about the circumstances surrounding an accident. Incident investigation determines the causes of an accident and recommends corrective actions to eliminate or minimize future incidents.

B. FORMS USED.

City of Fort Wayne Accident/Injury Investigation Report (IAIR) dated 7/18 (Attached) - provides a record of the circumstances relating to an incident involving department equipment, vehicles, employees or volunteers. The front side of the report is completed by the individual reporting the incident. The supervisor then completes the investigation and notes findings on the back side of the report.

Patron Injury Report - is used to report pool pullouts and injuries incurred by department facility and program patrons. The report is completed by any park representative.

C. REPORTING INCIDENTS.

General. Minor first aid incidents shall be reported to the supervisor daily or the first working day after the incident. For any other incident, the immediate supervisor and the Manager of Safety and Operations Support must be informed immediately, regardless of day or time as per the memorandum "Medical Service for On The Job Injuries. For serious or life threatening injuries, call 911 first! The Manager of Safety and Operations Support or designated representative will coordinate medical aid and investigate the incident as soon as possible. The Lawton Office will notify the next of kin for injured employees.

Employee actions if involved in an accident or injury:

FORT WAYNE PARKS AND RECREATION INCIDENT REPORTING AND INVESTIGATION STANDARD OPERATING PROCEDURE

- 1) Initiate the appropriate first aid steps for injured persons. If the injury is considered serious (chest pains, loss of consciousness, possible fracture, severe bleeding, etc) call 911 direct, if possible, and notify Lawton Park/Forestry. You may also go to Channel 16 on the park Motorola radios, identify yourself as a Park Department employee and that you have an emergency. For other injuries requiring medical attention, call the Manager of Safety and Operations Support or your supervisor for further instructions. For after hours treatment, you must refer to the Medical Services for On the Job Injuries memorandum for the appropriate medical facility.
- 2) For city owned vehicle/equipment accidents, summon City Police to the scene and request assistance from Lawton Park/Forestry, regardless of the amount of damage; or where the accident occurs; or who is involved.
- 3) Do not move vehicles until your supervisor has photographs of the scene and damage, unless directed to do so by the police.
- Do not assume liability for the accident.
- 5) Get names, address and telephone numbers of any witnesses.
- 6) Complete the Incident Investigation Report (IIR) to the best of your ability and give to your supervisor the day of the incident or first working day after.
- 7) Complete any actions required in accordance with City of Fort Wayne Policy and Procedure Manual 6.10 Drug and Alcohol Testing Procedures.

Supervisor Actions. If possible, employees with other than a minor injury will be accompanied to medical treatment by a supervisor. Ensure the employee completes the front of an IIR for each incident. Complete the backside of the IAIR and forward it to the Manager of Safety and Operations Support. If circumstances prevent completion of the IAIR, then forward an "as is" copy to the Lawton Office and follow up with a completed IAIR as soon as possible. Contact the Manager of Safety and Operations Support if any assistance is required. The Manager of Safety and Operations Support or the supervisor must contact Risk Management for drug testing guidance for each incident. Drug testing is administered on the recommendations of a Risk Management representative AND a department supervisor.

Administrative Actions - The Lawton Office shall maintain a log of all employee and patron injuries and accidents. The first received copy of the IAIR (complete or incomplete) shall be sent to Risk Management within two days of the incident. The original IAIR shall be retained in a suspense file at the Lawton Office. Completed IAIRs will be placed into the suspense file and the incomplete IAIR discarded. All completed IAIR s and exhibits shall be reviewed by the Safety Committee monthly. Completed and reviewed IAIR s shall be placed in the permanent record file at Lawton and a copy forwarded to Risk Management and one copy to the responsible supervisor.

Safety Committee Actions - The safety committee shall review all IAIR s to

determine if a department safety rule has been violated. The safety committee will not recommend disciplinary action. Committee findings shall be noted on the incident report. For an employee incurring two or more "at fault" incidents in a six month period, that employee/employee's supervisor shall attend the next safety committee meeting and explain corrective actions implemented so the employee works safe.

POLICY 604: Safety and Health Effective as of 01-01-16

PRACTICE

- Safety is a shared responsibility between employer and employee, with the employer being responsible for establishing and enforcing necessary safety practices and for maintaining a safe, healthy workplace, and with the employee responsible for following safety practices, acting in a safe, responsible manner, and for reporting hazards when observed. The City will follow all OSHA standards and any federal, state or local laws that apply.
- 2. To assist in this process, the following positions and groups have been established:
 - a. The City's Risk Management Department and staff which is responsible for all safety in City departments. The Safety Investigator in Risk Management will also head the safety team for the City, and participate on all safety teams throughout the City.
 - b. Department safety committees will define their particular areas of hazard and to work with management in minimizing such hazards.
- 3. The City maintains insurance coverage in accordance with current Indiana State Workers Compensation and Hurt on Duty Laws.

SAFETY RULES AND ENFORCEMENT

When management observes an employee disobeying safety rules, and where he/she endangers his/her own life and/or property and the lives and/or property of others, prompt action will be taken, which may include disciplinary action, up to and including termination, according to Policy 304: Disciplinary Actions. Supervisors are to be held accountable for overseeing this policy.

GENERAL WORK RULES

 All vehicular accidents involving property or personal injury will be reported immediately to the Risk Management Department and the Fort Wayne City Police (Sheriff's Department in accidents within the county jurisdiction). The Risk Management Department will assure that adequate documentation is obtained, including interviewing witnesses, where appropriate.

POLICY 604: Safety and Health

Effective as of 01-01-16

- In cases of on-the-job injury or illness, it will be the employee's responsibility to report
 the incident to his/her supervisor and to Risk Management and complete relevant
 paperwork as required by Risk Management and in accordance with City Policy 621.
- 3. Employees are prohibited from altering, nullifying, or changing design, or in any manner restricting, or interfering with the normal function of any device or equipment.
- 4. As stated in the City's Drug and Alcohol Testing Procedure (Policy 610), being under the influence of alcoholic beverages, intoxicants, or illegal substances while working or having them in your possession, is prohibited and will result in immediate disciplinary action, up to and including termination.

PERSONAL PROTECTIVE EQUIPMENT

- 1. In designated areas and on worksites where protective equipment is required, the equipment will be provided by the City and must be worn at all times.
- 2. The following are the personal protective equipment (PPE) minimum requirements. Individual departments may require a higher level of protection under defined circumstances:

Head Protection

- a. A hard hat must be worn within a City of Fort Wayne work zone.
- b. Hard hats must be worn during excavation, construction, or when any overhead work is taking place.
 - i. Per OSHA CFR 1926.100(a): "Employees working in areas where there is a possible danger of head injury from impact, or from falling or flying objects, or from electrical shock or burns, shall be protected by protective helmets."
 - ii. Hard hats are to be Class I Type E by ANSI standards or greater.
- c. Hard hats with any of the following defects should be replaced at City cost:
 - i. Perforation
 - ii. Cracking
 - iii. Deformity of the brim or shell

POLICY 604: Safety and Health

Effective as of 01-01-16

iv. Indication of exposure to heat, chemicals, or UV light such as loss of surface gloss, chalking, or flacking.

Worker Visibility

- a. All employees must wear a safety vest or shirt carrying an ANSI Class 2 rating or higher when any work is performed within or in the near vicinity of the rightof-way during daytime work. Any employee who is within fifteen feet of a City curb or within a City worksite is to be wearing a safety vest at all times.
 - i. Per Federal Highway Administration, Municipal Uniform Traffic Control Devices 2009 Edition: "All Workers within the right-of-way who are exposed to either traffic or to work vehicles and construction equipment within the traffic control zone shall wear high visibility safety apparel that meets the Performance Class 2 or Class 3 requirements of the ANSI/ISEA 107-2004 standard."
- b. High visibility must be replaced at City expense when it becomes faded, torn, dirty, soiled, worn, or defaced, and cannot be adequately cleaned.

OPERATION OF VEHICLES

- An employee is required to have a valid Indiana operator's or Commercial Driver's License (CDL) to operate licensed vehicles owned by the City of Fort Wayne or any leased vehicle.
- The driver shall observe all state and local traffic laws and ordinances.
- 3. All City employees who operate, or are occupants in, a City vehicle are required to use a safety (seat) belt at all times that the vehicle is in motion.
- Individual employees shall be responsible for any fines they receive for speeding or other traffic violations.

CONFINED SPACE CERTIFICATION

1. The City will reimburse the cost of a confined space physical for those employees whose position with the City requires valid confined space certification.

POLICY 604: Safety and Health Effective as of 01-01-16

2. Employees whose position and job description does not require confined space certification or a CDL may be reimbursed for a confined space physical with Division Head approval only.

SMOKING AND TOBACCO POLICY

- Pursuant to local ordinance, it shall be the policy of the City of Fort Wayne to provide a
 smoke and tobacco-free environment for all employees and visitors. This policy covers
 the smoking of any tobacco product and the use of oral tobacco products or "spit"
 tobacco as well as electronic "vaping" devices. Use of these products is prohibited in
 the Citizens Square Building and all City-owned and/or operated buildings.
- This policy applies to all employees, clients, contractors and visitors. Use of such products is also prohibited in all City and County vehicles and transportation equipment.

3. Enforcement:

- Any violations should be brought to the attention of management and/or Risk Management.
- b. Employees who are found to be in violation of this policy are subject to disciplinary procedures up to and including termination.
