
GMS Claims Training Document

- Note: You will need approval from the grantee before submitting a claim
 - Have the grantee send you an email stating their approval to submit this claim
 - This "Grantee Approval Email" will be uploaded to the claim before submitting it
- This document will walk you through the steps to submit a claim within the Grants Management System (GMS)



 Once you login, click on Account Details. Then click on Grant Administration. Select the grant you would like to submit a claim for.




