Per invitation, Mark Downey, a representative of the Engineering Board, came to discuss the issue with landscape architects and architects and review of complaints and thus the scope of practice of each profession. Is there a problem with how these are handled? Donna clarified the complaint process for the board and Mr. Downey. The board prefers that any overlap areas in accusations of practicing without a license be brought to the attention of both board liaisons so as to render a fair decision. A meeting between the board staff, IPLA legal, executive staff and the AG's office would be the best way to implement this change. The engineering board will discuss this issue tomorrow.

Mr. Downey recommended the on-line ethics quiz to the Architect board for CE ethics that the engineering board is in favor of.

Point of clarification, David wants to send a "reminder" letter to anyone practicing without a license rather than going through the process of an injunction. Donna advised that the Board cannot do that and it would have to be done by the AG's office.

XIV. OLD/NEW BUSINESS

A. Proposed Amendments to Indiana Code 25-4 and Title 804 of the Indiana Administrative Code

The Architect board will need to amend its rules to conform to and implement SEA 302 – which goes into effect July 1, 2008.

- Admitted without degree in design discipline and
- Allow exam before IDP, license after IDP completed (combine training and experience to be the equivalent of a degree must be defined by the board.)
 - Renewal of registration expired more than five years (804 IAC 1.1-2-6) we have to change the rule to conform to the statute.
 - out-of-state reciprocity – possibly define combination of training and experience that is equivalent to bachelor's degree in design discipline

B. Requirements for ARE Exam – Timing
This was discussed previously.

There is nothing new to report, if the board wants any legislative changes they must be presented to Angela for the Legislative Team by the July meeting.

There was nothing new discussed.


F. Matt Kely will attend the NCARB conference in June in Pittsburg. He is the delegate.
