I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM

II. ADOPTION OF THE AGENDA

A motion was made and seconded to adopt the agenda as amended. Laux/Burghduff 8-0-0, motion carries

III. ADOPTION OF THE MINUTES FROM THE MARCH 21 and MARCH 22, 2012 MEETINGS OF THE BOARD

A motion was made and seconded to adopt the March 21, 2012 and March 22, 2012 nursing board minutes Laux/Hall 7-0-1 (Presley abstains)

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Roxanne Thomas and Ernie Klein appeared on behalf of the Indiana State Nurses Assistance Program ("ISNAP"). The March 2012 monthly report was presented. ISNAP reported 23 recovery monitoring agreements returned, 13 successful closures, and 4 non-compliant closures. ISNAP staff completed 20 new intakes and 3 readmissions.

Roxanne reported on the implementation of Phase 2 of the Affinity Online System ("AOS") where nurses can directly upload paperwork to the system. Ms. Laux asked if ISNAP is utilizing Facebook and/or social media. Ms. Laux asked that ISNAP post a film on Youtube about their program, signs and symptoms of addiction, etc. that could also be utilized in the classroom.

Ms. Ogle asked a question about AOS and its financing. Roxanne indicated that AOS is financed through urine drug screening and that AOS works directly with Witham on the cost issues. ISNAP is not involved in the financial piece at all. Ms. Ogle asked if there would be an increase in UDS costs to nurses to support this system. Mr. Klein indicated there was an increase in the cost of urine drug screens but it was the first in six years. Mr. Klein indicated the panels are not determined by Witham but by ISNAP. Ms. Ogle wanted to know if participants understand they are paying for the software with their UDS. The increase in UDS was \$5-15 per screen depending on the type of screen. However, the etG is split out now which may result in some savings. Sites vary costs depending on observed screens but ISNAP has no control over site costs. Affinity's costs are documented for the licensee so that when they choose collection sites they can see the fees up front when making their collection site choice. Mr. Burghduff indicated that if the increase in ISNAP failure is attributable to the increase in UDS cost the Board wants to be aware of that immediately. Ms. Ogle indicated that there need to be conversations about ISNAP ownership, etc. how upgrades would work, etc. Mr. Klein indicated the AOS costs are spread out between multiple state providers.

Mr. Klein then gave a brief presentation on the AOS system. Participants receive a pin number and login to complete daily for UDS screens. This can be completed via computer or phone. Participants can also see their own history at that time and this eliminates the opportunity for excuses for lack of calling in. Participants must keep a balance in the program so that when they do a screen it is already paid for. ISNAP can also transfer funds into participant accounts through the Needs Assistance Fund electronically. There is now a HIPAA compliant communication link/instant messenger for ISNAP and participants as well. ISNAP is still doing a combination of hard copy and PDF uploading of reports at this point in time. Roxanne went through a series of screen shots that the participants see. ISNAP is able to staff failures to complete UDS's more quickly than they could previously due to a daily alert system and a snapshot screen that immediately shows a licensee's complete UDS history so that ISNAP staff does not have to calculate this information manually. Mr. Burghduff wondered if the Board would see reports out of the AOS in OTSC and full hearings so that all information is available electronically during hearings. Mr. Klein indicated that is their goal. The Board thanked the ISNAP staff for their time.

V. EDUCATION

A. Correspondence from Chamberlain College of Nursing re: post-licensure nursing program approval and clinical sites for out of state nursing students

Staff appeared from Chamberlain College. The college expects to extend online post-licensure programs to all states in the near future. They sent surveys to states affirming that they do or do not regulate post-licensure programs. They also sent a second survey for pre-licensure campuses where they are close to other states to see whether their clinicals could extend across state lines. For example, if there is a student at the Indianapolis campus could they go across state lines to complete clinicals. Ms. Laux asked that all faculty and clinical preceptors need to be licensed if they are in Indiana even if post-licensure. Staff indicated that current post-licensure programs have no clinicals but the FNP program they anticipate bringing on Board will have a clinical component. They do not have a clinical component with their DNP program, they have a practicum only. The only individuals admitted to their DNP program are already nurse practitioners. The Board took this matter under advisement; no Board action was necessary as this matter contemplates post-licensure programs that the Board has no jurisdiction over.

B. Medtech College Fort Wayne Site Visit conducted March 5, 2012 (Connie/Jerry)

Staff appeared from Medtech College Fort Wayne. Ms. McIntosh reported on the site visit completed on March 5, 2012 related to an anonymous complaint sent to the BON. The complaint surrounded the fact that students could start their program without a HS transcript or GED. Board members found incidences of students starting classes without proper verifications. The issue is that the Board does not understand why they let students start school at all without verification of the HS diploma or transcript. Staff indicated students attest to this information and they seek immediately upon enrollment an unofficial high school transcript. Their policy states that the official transcript must be had within 30 days of starting classes. Ms. Laux expressed concerns as to why they don't wait to have an official transcript before starting. Ms. Cannon indicated they will review their policy and that it should be changed immediately. It is 30 days from when they start classes not 30 days from enrollment. Ms. McIntosh indicated they spoke to both faculty and students. The other part of the complaint was that a nursing faculty member was not participating in the interview process for students even though it was clearly outlined in the policy. Staff indicated very little participation in the application and admission process. The staff indicated they now do group sessions and talk to students about becoming a nurse, etc. They take notes during the interview process but do not do independent interviews. Ms. Laux expressed concerns about the lack of a standardized tool for interviewing, giving each student the opportunity to respond, etc. Staff indicated they speak to each student individually while within the group. Ms. Hall indicated that when students are in a group setting they may not feel comfortable responding to questions. Ms. Hall also expressed concerns for the 30 day window to receive the GED copy, etc. that it gives the feel that the importance is the number of students admitted vs. the quality of students which is a disservice to the students and the school. Staff indicated students complete an interview questionnaire, TEAS testing is completed during that time as well. The Program Director then reviews that file for flags and an individual interview is scheduled if there are flags. The group interview is then scheduled which looks at things like timeliness, appropriate dress, etc. Mr. Burghduff indicated there was a complaint filed that this process was not completed and students also indicated that Nursing was not involved in their interviews and faculty echoed the same thing. Ms. McIntosh indicated there were a whole series of communication issues with faculty, privacy issues for student/faculty communication, announcement of grades in front of other students, comments about embarrassing students in the hallway while others were passing in the halls, etc. Board staff could hear comments from the vents about them being there, etc.

Board recommendation: Conditional accreditation based on the complaint and go back in 3 months to see if their plan of correction is working. Ogle/Hall, 8-0-0, motion carries

VI. DISCUSSION

A. Correspondence from NLNAC regarding various nursing programs

The Board requested a site visit based on this correspondence to Medtech Greenwood PN and RN programs. Hall/McIntosh, 6-0-0, motion carries McIntosh/Laux will do the site visit. Indiana State will continue on a plan of correction.

B. Supplemental Information received from Philippine Nurses Association of Indiana, Inc.

Board Action: The Board requested that Mr. White review the appropriate statutes and rules to insure this is a rule change only and the matter will be tabled for a report at the May full Board meeting.

VII. BOARD DIRECTOR REPORT

Ms. Kiefner Crawford reported on the following:

1. Carri Burke started as Compliance Director on April 19, 2012 replacing Lori Grice.
2. The NCLEX scores for the first quarter of 2012 are as follows: NCLEX PN: 353 first time test takers, 320 passed for a 90.6% pass rate. NCLEX RN: 826 first time test takers, 741 passed for a 89.7% pass rate.
3. The education subcommittee will begin meeting next month with the first task being the overhaul of the annual report form. Members of the Board will partner with members from the Indiana Center for Nursing/Indiana Action Coalition education subcommittee to complete this task.
4. The Board received a copy of a "Decision Tree" utilized by the Nevada Board of Nursing regarding scope of practice. Ms. Kiefner Crawford asked the Board to review the document and decide whether they would like to utilize a similar model in Indiana as our laws are very broadly written regarding scope of practice.
5. The Board discussed schools of nursing that are currently on plans of correction. Ms. Kiefner Crawford recommended that schools that are above 80% for 2011 come to the Board for a personal appearance with an updated assessment of their plan of correction. Schools that are below 80% for 2011 and on a corrective action plan will receive a site visit.
6. The APN audit is ongoing. Approximately 96 licensees were selected for the audit. To date, 40 have not responded and will be given a mailed notice (the first notice was via email) to respond by May 21, 2012. If they fail to respond by that date a Notice of Noncompliance will be issued.
7. All ISNAP financials and other ISNAP-related information is now available on sharepoint.
8. A discussion was held regarding a long term strategic planning session for the Board. Ms. Kiefner Crawford is in the process of obtaining a facilitator. Additional details will follow.

A. Appearances by Applicants for Licensure

1. Crystal Combs LPN examination 6 failures; completed school in 2008
The Applicant appeared in person regarding her application for licensure. She reported failing the NCLEX 6 times. A year ago she took an online review course. The ALJ recommended that she be allowed to test once she provides documentation of successful completion of a review course and a 95% probability of passing the examination.
2. Terrie Breedlove LPN examination 3 failures; completed in 2009; license to be issued on probation
The Applicant appeared in person regarding her application for licensure. She reported failing the NCLEX 3 times. She has enrolled back in school to get a personal tutor. The ALJ recommended that she be allowed to test once she provides documentation of successful completion of a review course and a 95% probability of passing the examination. Upon successful passage of the NCLEX her license is to be issued on probation.
3. Danyle Johnson LPN examination positive response; background check hit
The Applicant appeared in person regarding her application for licensure. She reported multiple arrests for misconduct, trespassing, fictitious id, and retail theft. She has had no legal issues since 2006. The ALJ recommended that she be allowed to sit for the NCLEX and upon successful passage, her license be issued on indefinite probation for six months. Employer reports need to be submitted to the board.
4. Moses Herrera LPN endorsement answered no; background hit
The Applicant appeared in person regarding his application for licensure. He reported in 2000 and 2001 he had been arrested for domestic violence in Colorado. He has had no legal issues since 2001. The ALJ approved his endorsement.
5. Benita Thomas LPN endorsement positive response; background hit
The Applicant appeared in person regarding her application for licensure. She reported a domestic violence arrest in 2008, in Ohio. She has had no legal issues since 2008. Her license is currently on probation in Ohio. The ALJ approved her endorsement with the condition that her license be on probation that is to mirror the probationary terms of her Ohio license.
6. Tangie Wilson LPN endorsement positive response; background hit
The Applicant did not appear. Matter needs to be rescheduled.
7. Miranda Tedder RN examination 3 failures; completed school in 2009
The Applicant appeared in person regarding her application for licensure. She reported failing the NCLEX 3 times. She has completed the review at Kaplan. The ALJ approved her to set for the NCLEX.
8. Biljana Mrdan RN examination positive response; background check hit

The Applicant appeared in person regarding her application for licensure. She reported receiving a DUI in 2010, while she was in nursing school. She did not report the incident to the school. She does not qualify for monitoring. The ALJ recommends receiving a letter from her ex-employer and be allowed to sit for NCLEX.

9. Susan Paterson Midwife positive response
The Applicant appeared in person regarding her application for licensure. She reported she does have an addiction to Ambien. She is currently licensed in Wisconsin. She has been in monitoring in Wisconsin since 2010. She has been in touch with ISNAP and will have a RMA that will mirror her monitoring agreement in Wisconsin. The ALJ approves her midwife license.
10. Kenisha Williams RN examination 2 exam failures; completed school in 2002
The Applicant appeared in person regarding her application for licensure. She reported she graduated in 2002 and has failed the NCLEX twice. The ALJ recommended that she be allowed to test once she provides documentation for successful completion of a review course and a 95% probability of passing the examination. Before she can be issued a license, she must complete a skills refresher course.
11. Christina Hook RN examination 6 exam failures; completed in 2008
The Applicant appeared in person regarding her application for licensure. She reported she has failed the NCLEX 6 times. The ALJ recommended she be allowed to test once she provides documentation of successful completion of a review course and a 95% probability of passing the examination.
12. Jason Gilliland RN examination returning as requested for 2nd personal appearance after ISNAP evaluation
This personal appearance was conducted by the full Board. Mr. Gilliland received a subsequent DUI in February 2012 after completing his criminal background check. He pled guilty to the DUI in April 2012. He has been evaluated by ISNAP and is in an 18 month RMA. Board Action: A motion was made and seconded to issue his license on probation for six months of full compliance with an ISNAP RMA. Burghduff/Ogle, 7-0-0, motion carries
13. Nicole Ann Laas LPN examination background check hit
The Applicant appeared in person regarding her application for licensure. She reported in 2006 she received a citation for underage drinking. In 2008, she received an OWI that was dropped to reckless driving. The ALJ recommended she be allowed to set for NCLEX. Upon successful passage she needs an assessment with ISNAP.
14. Jennifer Sknerski LPN examination 4 failures; previous board appearances in 2010 and 2011
The Applicant appeared in person regarding her application for licensure. She reported she has failed the NCLEX 4 times. She had taken a review with Kaplan and ATI where she received a 98% probability of passing. The ALJ denies her taking the NCLEX and recommends her seeing a physician for a formal diagnosis.
15. Amanda Lynn Chiszar RN examination background check hit
The Applicant appeared in person regarding her application for licensure. She reported in 2005, she was charged with disorderly conduct and public intoxication. She has had no legal issues since 2005. The ALJ recommends she be allowed to set for the NCLEX.
16. Deanna Books LPN examination Passed exam on 02/16/2012, has yet to have ISNAP eval.
The Applicant appeared in person regarding her application for licensure. She reported she passed the NCLEX and has signed RMA with ISNAP. The ALJ recommends she receive her license.
17. Lea Anne Kraus RN Examination positive response
The Applicant appeared in person regarding her application for licensure. She reported multiple alcohol arrest: 1998 minor consumption; 2000, OWI in Kentucky; and in 2001, minor consumption. In 2009, she was terminated as a CNA due to positive drug urine screen (marijuana). She stated she does not recall smoking the marijuana but may have while she was drinking. The ALJ recommends she receive an ISNAP evaluation and be allowed to set for the NCLEX.
18. Paul Murphy RN Examination 10 exam failures; completed school in 2007
The Applicant did not appear. Need to reschedule for May.
19. Eric a Dawson RN Examination 4 exam failures; completed school in 2009
The Applicant appeared in person regarding her application for licensure. She reported failing the NCLEX 4 times. She is currently taking the Kaplan review course. The ALJ recommended she be allowed to set for the NCLEX once she provides the documentation for 95% probability of passing the examination.
20. Cheryl Dulin RN Endorsement background check hit; positive response CONTINUED
21. Christian McNeal LPN Examination background check hit; positive response
The Applicant appeared in person regarding her application for licensure. She reported in 1999 a conviction of theft; 2006 fraud; and 2011 driving on suspended license. Her license was suspended due to failure to pay tickets. The ALJ recommended she be allowed to set for the NCLEX.
