I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM

Natalie Hall, President of the Indiana State Board of Nursing, called the meeting to order at 8:34 a.m. and established a quorum in accordance with IC § 25-23-1-5(b).

III. ADOPTION OF THE MINUTES FROM THE JULY 21, 2016 MEETING OF THE BOARD

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Chuck Lindquist went over the monthly report that was provided to the board. He addressed the students to discuss with them what ISNAP is.

V. EDUCATION

A. Brown Mackie South Bend quarterly in person report (Ellen Noll MSN, RN)

Board member Hall recused herself and left the room based on her current employment with Brown Mackie. Ellen Noll and Darla Silverman appeared on behalf of the program. Ms. Noll was asked how many graduates had tested this quarter and she replied one (1) had tested and four (4) were scheduled to test this week. Eleven (11) graduates were invited back for NCLEX prep and nine (9) responded. Ms. Noll asked the Board if they could discontinue monthly reports and quarterly in person appearances since they felt they had met the requirements as put forth after the latest site visit. Board member Coto stated that they were on the right track but the Board wants to see the progress through the end of 2016. When 2016 annual scores are available, and they remain improved, the board would feel comfortable at that point relaxing the requirements. Board votes to accept report as submitted. Owens/Presley 5-0-0

B. Fortis College quarterly in person report (Cinnamon Bell-Williams MSN, RN)

Board member Hall recused herself at the request of the program. Cinnamon Bell Williams and Dr. James Cox appeared on behalf of the program. Ms. Bell-Williams asked that a sheet listing current NCLEX progress be shared with the Board – and it was done. Dr. Coto asked about the apparent turnaround in scores. Ms. Bell-Williams said that benefits from the NCLEX success initiative has been obvious in their readiness to test. The increased rigor of admission testing has resulted in an overall decrease in admissions according to Dr. Cox. The Board congratulated Fortis on a good job. Board voted to accept report as submitted. Owens/Presley 5-0-0

C. VR Ashwood School of Nursing quarterly in person report (Dr. Nellie Smith EdD, MSN, RN)

Dr. Nellie Smith appeared on behalf of the program. Ms. Hall rejoined the board. Ms. Hall asked Dr. Smith if the school was closing or not – it was unclear to her from reading the report. Dr. Smith stated that she planned to teach out the present cohort and close after their NCLEX preparation is complete on or around June 2017. Ms. Hall advised Dr. Smith to review the Board of Nursing rules and regulations closely as it states fairly clearly what must be done to close a program. Dr. Smith stated that only 9 of 34 students have paid their tuition in full since the program opened and it is a financial strain to all involved to continue. Dr. Smith states there are 9 students in the present cohort and they are progressing well. Board voted to accept the report as submitted. Hall/Owens 6-0-0

D. MJS College quarterly in person report (Annette Murray MSN, RN)

Ms. Annette Murray and Dr. Oranu Ibekie appeared on behalf of the program. Ms. Hall asked Ms. Herron about 2nd quarter testers and Ms. Herron replied that there had not been any for 2nd quarter. Ms. Murray stated that there would be third quarter testers but that they wouldn't test until September. Ms. Hall asked Ms. Herron about the student complaints that were received by the Board and included for Board member review in the packet. Ms. Herron stated that she had received about 5 unsolicited letters of complaint from students and had three (3) students appear in person at the nursing offices to speak with her in person. Dr. Coto stated that the student letters contained strong allegations based on the terms used. Dr. Murray stated that the students are upset because of the number of changes to the program that have been made in an effort to improve the student outcomes. Dr. Murray was asked what notice the students receive prior to the change and Dr. Murray stated that they receive notice a minimum of thirty (30) days and usually sixty (60) days. Dr. Murray stated that many of the students are LPNs and are informed in the admission process, in order to be successful, that they cannot work more than two (2) days a week on the weekend. Most are working more than that, even getting up before the class is over and leaving because they have to get to work. This also limits their ability to use tutoring that is available. Ms. Hall asked if the tuition created financial hardship for the students and Dr. Ibekie stated that they pay no more than \$400 per month even though the total tuition is \$43,000. Ms. Hall stated that the students are frustrated that this is not the program they signed up for due to the numerous changes that have been made, even though the changes are to benefit the student. Ms. Hall stated the reason for the changes is not being communicated in a manner so that students understand the reason and value for the change. Dr. Coto stated that a review of the admission process to better screen for success might be in order. Ms. Hall requested that a site visit be made prior to the next meeting by Ms. Herron. Ms. Hall made a motion to accept the report as submitted with the addition of a site visit prior to the next meeting. Mr. Morrison seconds. Motion passed 6-0-0.

E. University of St. Francis Request for Curriculum Change (Dr. Mindy Yoder)

Board member Owens recused herself and left the room due to her relationship on the Advisory Board for the school. Dr. Mindy Yoder, Megan Winegarden and Allison Sabin appeared on behalf of the program. The school is asking for approval of a change in curriculum to become effective August 29th with the beginning of the upcoming fall semester. Dr. Coto asked the reason for the change and it was stated that a realignment across the college had occurred with regard to general education outcomes and this revision brought the nursing program into alignment with the rest of the college. The curriculum remains at 120 credits. Dr. Yoder stated that the NCLEX pass rates were 84% for Quarter 1 and 100% for Quarter 2. Ms. Hall motioned to approve the curriculum change as submitted and Mr. Morrison seconded. Motion passed 5-0-1.

VI. DISCUSSION

A. Stephanie Hardister - Request to sit for NCLEX

The board felt it was not their place to intervene to NCSBN on the behalf of Ms. Hardister. A motion was made and seconded not to grant her request. Morrison/Hall 6-0-0, motion carries.

B. Brandy Moore- Correction to Order

A motion was made and seconded that the order will not be changed but if Ms. Moore can show it was wrong it will be looked at again. Hall/Morrison 6-0-0, motion carries.

C. Madonna Marie Collins- Correction of Order

A motion was made and seconded to correct order, Hall/Presley 6-0-0, motion carries.

Interim Director Michael Minglin informed the board that a new board director was hired and would be starting on August 29, 2016.

A. Appearances by Applicants for Licensure

1. Charlotte Renfrow LPN Exam Military App-FULL BOARD- CONTINUED

2. Yvetta Vega RN Endo Failure to Disclose

Ms. Vega appeared for a personal appearance. Ms. Vega applied for an RN license by endorsement and failed to disclose a criminal matter that occurred in 1997. While going through a divorce, she states her ex-husband harassed her and went as far as to record conversations between them so that she incriminated herself. Charges were filed and since then she has had no other trouble or legal issues. Ms. Vega holds a license in Florida and Hawaii. ALJ Owens recommends Ms. Vega license be issued free and clear.

3. Tiarra Gardner LPN Endo Failure to Disclose

Ms. Gardner appeared for a personal appearance. Ms. Gardner applied for an LPN license by endorsement and failed to disclose a criminal matter. Ms. Gardner states she misunderstood the question on the application. She was never found guilty for the incident that occurred in 2007 where she was pulled over by police for driving slowly due to having a flat tire, at this time she was also given a ticket for not having auto insurance. In 2015, Ms. Gardner was arrested for a DUI and driving without a license. She hit a pole but states she hadn't been drinking, no sobriety test was performed and she was charged with having no insurance because her license was expired according to the officer. This was thrown out but currently has an open case. She holds a license in Illinois and has had no issues with her Illinois license. ALJ Owens recommends her license be issued on probation for the duration of her criminal probation with submitting quarterly reports and keeping the board abreast of any other criminal activity.

4. Leah Groeger RN Exam Grad Date 2013/Previous Testing Attempts

Ms. Groeger appeared for a personal appearance. Ms. Groeger applied for an RN license by examination. She graduated in 2013 and has taken the NCLEX exam three times. Ms. Groeger has set a goal to take the exam in October and she states she's taken Kaplan online and her instructor is giving her up to date books for studying. ALJ Owens recommends that Ms. Groeger completes a review course with a 95% probability of passing. She may be issued a license free and clear upon passing the NCLEX.

5. Marretta Geans RN Exam Previous Testing Attempts

Ms. Geans appeared for a personal appearance. Ms. Geans applied for an RN license by examination. She graduated in March 2014 and has taken the NCLEX the first time in 2015, 1 year after graduation. She states she was going thru a divorce and paying back taxes when she received a letter stating her license is suspended, she thought she couldn't test, she found out that she could but wouldn't receive a license until her taxes are paid. Ms. Geans has a mentor that is helping her with critical thinking and anxiety issues. ALJ Owens recommends that Ms. Geans completes a review course with a 95% probability of passing. She may be issued a license free and clear upon passing the NCLEX.

6. **Alyssa Seitz** **LPN Exam** **Positive Response**
This matter will be rescheduled one time.
7. **Kelly O'Shaughnessey** **APN App** **Failure to Disclose CONTINUED**
8. **Christina Smith** **RN Exam** **Previous Testing Attempts**
Ms. Smith appeared for a personal appearance. Ms. Smith applied for an RN license by examination. She graduated in 2014 and has taken the NCLEX three times. She currently holds a valid LPN license. Ms. Smith states she had a lot of personal issues going on, she worked full time and barely passed her class and she has anxiety. She currently works in memory care. ALJ Owens asked if she has audited the class that she barely passed to see if she can sit in. Ms. Riebsomer with ISNAP suggest that she talks to her doctor to see if she can get something for her anxiety. Ms. Smith provided transcripts to ALJ Owens, ALJ Owens suggest that she beef up her study on areas where she did poorly. ALJ Owens recommends that Ms. Smith completes a review course with a 95% probability of passing. She may be issued a license free and clear upon passing the NCLEX.
9. **Christine Leslie** **RN Exam** **Previous Testing Attempts**
Ms. Leslie appeared for a personal appearance. Ms. Leslie applied for an RN license by examination. She graduated in 2015 and failed the NCLEX three times. She states she is completing a three week ATI portal and has cut back on hours at her employment. Ms. Leslie decided to teach English in Spain instead of preparing to take the exam again for the third time. ALJ Owens recommends that Ms. Leslie completes a review course with a 95% probability of passing. She may be issued a license free and clear upon passing the NCLEX.
10. **Cami Simmons** **RN Endo** **Positive Response**
This matter is to be rescheduled one time.
11. **Lacey Giriggs** **RN Exam** **Grad Date 2013**
Ms. Giriggs appeared for a personal appearance. Ms. Giriggs applied for an RN license by examination. She graduated in 2013 and has taken and failed the NCLEX two times. Ms. Giriggs states she developed test anxiety after second attempt to pass the exam. At such time she was married, had daughter, and 6 months ago decided to retake test. Ms. Giriggs has gotten books to study and taken ATI portal. She states she received 96% probability. Ms. Giriggs states she works processing bio medical waste. Ms. Owen asked if she knew what she wanted to do once she received her license. Ms. Giriggs states she wants to work in OB or the ER. ALJ Owens recommends that Ms. Giriggs completes a review course with a 95% probability of passing. She may be issued a license free and clear upon passing the NCLEX.
12. **Amanda Roach** **RN Exam** **Positive Response**
This matter is to be rescheduled one time.
13. **Leanna Bailey** **RN Exam** **Positive Response**
Ms. Bailey appeared for a personal appearance. Ms. Bailey applied for an RN license by examination. She graduated in May 2016. In 2008, Ms. Bailey was arrested for an altercation with a family member and was put in the deferral program. Charges were dropped in 2009 and she states the judge told her to stay clean for a year and charges would be dropped. When completing her application she wasn't aware that charges would show because they were dropped. Ms. Bailey has had no other trouble with the law. ALJ Owens recommends Ms. Bailey be allowed to test and issue a license free and clear upon passing.
14. **Tammy Broaddrick** **LPN Endo** **Positive Response**
Ms. Broaddrick appeared for a personal appearance. Ms. Broaddrick applied for an LPN license by endorsement. Ms. Broaddrick has a lapsed Kentucky license and her Ohio license has no issues. Ms. Broaddrick states she was terminated in 2013 due to the DON not approving of her reporting her for misconduct. Ms. Broaddrick states the facility hired a new DON that she states was terrible. She came out of her office with a glass of wine, put a patient that had mercer in a room with a patient that had pneumonia. Ms. Broaddrick states she turned her in and she was targeted by the DON and eventually was terminated in July 2013. Ms. Broaddrick states that at the beginning of her shift she had a lot of patients and the nurse before her left all her notes. She was tired and frustrated, she put in an order wrong, and no one caught it until sometime after. She states she has been a nurse for four years and was working in hospice and plans on looking into

hospice again here in Indiana. ALJ Owens recommends Ms. Broadrick be allowed to test and issued a license free and clear upon passing.

15. **Lakeia Gordon** **LPN Exam** **Positive Response**
Ms. Gordon appeared for a personal appearance. Ms. Gordon applied for an LPN license by examination. Ms. Gordon responded positive to question three on the application. She called the police on a boyfriend of family member and when police arrived they arrested her. Charges were dropped. Ms. Gordon states she has been a CNA since 2009 and has had no other issues. ALJ Owens recommends Ms. Gordon be allowed to test and be issued a license free and clear upon passing.
16. **Bryan Army** **APN** **Positive Response/Failure to Disclose**
Mr. Army appeared for a personal appearance. Mr. Army applied for an APN license. Mr. Army is represented by legal counsel, Latonya Wright. He answered yes to question #4 of his application. Mr. Army was terminated for going home after a 12 hour shift. When arrived home he realized he had narcotic in his pocket, went back to return and was terminated. This was on November 30, 2015. Mr. Army request to have a drug screen, the drug screen was negative. He was arrested for public intoxication in 2014. He was out a bar with co-workers and while sitting on curb waiting for cab in front of the bar, an officer pulls up and deem he was intoxicated, so then he was arrested but charges were dismissed. Robin states that the applicant has been in ISNAP since January 2016 and has had 4 negative drug screens. Mr. Army's monitoring date is for 6 months, January to June. He's currently not working and has become board certified for nurse practitioner. ALJ Owens referred to full board. After appearing in front of the full board a motion was made and seconded to to grant the APN license. Coto/Russell 5-0-0, motion carries.
17. **P.K. Hemmons** **LPN Endo** **Positive Response**
Ms. Hemmons appeared for a personal appearance. Ms. Hemmons applied for an LPN license by endorsement. She was licensed October 26, 2012. Illinois denied her licensure because she didn't disclose all of her criminal back ground. Ms. Hemmons states she didn't know the extent of her criminal history until after applying. Ms. Hemmons also states her criminal history is based on mental illness that she was suffering from, she had gotten helped and has a gang of doctors and psychiatrist that are her mentors. She states her psychiatrist paid for her school because they believe in her. Ms. Hemmons is not currently working. ALJ Owens recommends Ms. Hemmons is issued a license on probation for a period of no less than six months with the terms as follows: Must complete a refresher course, submit employer or self-quarterly reports, and submit a signed board order by employer.
18. **Maria Reddy** **LPN Endo** **Failure to Disclose**
This matter is to be rescheduled one time.
19. **Melissa Santos** **RN Exam** **Failure to Disclose**
Ms. Santos appeared for a personal appearance. Ms. Santos applied for an RN license by examination. She graduated from Ivy Tech in May 2016. Ms. Santos failed to disclose criminal history. She states that in 2012 she didn't pay a health membership and failed to appear for a court date. She states there has been no other issues with the law. ALJ Owens recommends Ms. Santos be allowed to test and issued a license free and clear upon passing.
20. **Ashley Lovell** **RN Endo** **Failure to Disclose**
Ms. Lovell appeared for a personal appearance. Ms. Lovell applied for a RN license by endorsement. She failed to disclose she was charged with public intoxication. Ms. Lovell states she didn't think anything of it because it was a citation and she only had to pay fine. She currently holds an active license in Kentucky, has had no other issues with the law, and is not on probation. ALJ Owens recommends Ms. Lovell be issued a license free and clear.

B. Appearances by Applicants for Renewal

1. **Jennifer Davis** **RN Renewal** **Positive Response**
Ms. Davis appeared for a personal appearance Ms. Davis applied for RN renewal and answered "yes" to questions #1 and #3 on her renewal application. In August of 2015, she was giving a gentleman a ride to Walgreens when she got pulled over for having a headlight out. The gentleman had a package on him and even

though he admitted to the package being his, she was also arrested and both convicted for trafficking. Ms. Davis received 3 counts and probation after completing program. She states she is currently staying in a transitional house (Hope), this was an option rather than go to prison. Ms. Owens states that she feels as if she's not getting the whole story and it's hard to believe that the County would put her in a transitional home for no reason. Nicole, Nursing Board legal counsel, looked up her criminal record and it states that she was charged with 11 counts and a plea agreement. Ms. Davis states that she has had drug problems in the past that started after having knee surgery. She begin to take opiates, Ms. Davis states she quit in 2015 after being found unresponsive and tumor found on her brain. She also states that the last time she worked as nurse was in 2015 at Indiana Health Care, states she left due to medical issues and on good terms. ALJ Owens recommends Ms. Davis license be renewed on probation for the length of her criminal probation or completion of ISNAP RMA whichever of the two is longer meeting the following terms: submitting employers or self-quarterly reports and work in supervised setting only.

2. **Tracey Stevens** **RN Renewal/Positive Response/Out of State Investigation**
Ms. Stevens appeared for a personal appearance. Ms. Stevens applied for RN renewal and answered "yes" to question #1 on her renewal application. Ms. Stevens's license expired in 2013 but she holds a license in Kentucky that has an alert on it. She states that as DON, there were staffing issues. She had a scheduler who let his medication administration certificates lapsed. She asked him how he can get his certificate current and to proceed to do so. Ms. Stevens had surgery and never thought anything else about it until it was discovered the scheduler passed medication twice without the administrator verifying that he was current. She asked him why wasn't he passing meds when she gotten back, he stated that he wasn't going to pass meds if he's not going to get paid. She allowed him to pass meds for 4 hours the day the State Board of Health came in. There was no negative outcome but the company assured her that she would not be terminated, that changed when they started writing their plan of corrections. She didn't know it was reported until she applied for a job in Indiana. She states, since the incident, she has worked in two of the company's facilities. ALJ Owens referred her to full board. Once in front of the full board a motion was made and seconded to renew license free and clear. Coto/Owens 4-1-0, motion fails. This matter is tabled until a sixth board member is back in the room. Ms. Stevens decided to withdraw her application at this time.
3. **Mary Barber** **LPN Renewal** **Failure to Disclose/No CEUS**
Ms. Barber appeared for a personal appearance. Ms. Barber applied for an LPN renewal and answered "yes" to question #2 on her renewal application. She last held an active license in 1998 and last worked as nurse in 1996. Ms. Barber is not interested in practicing as a nurse but wants to know if she can go into a different area of nursing like billing insurance to supplement her income. She needed surgery on her hand for rheumatoid arthritis and carpal tunnel but couldn't receive because of her diabetes which kept her from working. Ms. Barber no longer has the same issues with her diabetes and since has had a surgery on her hand and is awaiting another. ALJ Owens reviewed the continuing education certificates Ms. Barber submitted and found that she has an additional 13 hours over what was requested by the INSNB. ALJ Owens also asked what makes her want to work in billing insurance. Ms. Barber replied that she doesn't have to do a lot of walking and it wouldn't be a handicap. ALJ Owens also asked, why it requires her having an active license. Ms. Barber states that her potential employer has asked for it, to get it back active and then they could talk about employment. ALJ Owens recommends Ms. Barber license for renewal be denied. ALJ Owens expressed to Ms. Barber that she has been out of practice for 20 years, she still has the ability to impact patients and if she could sell herself as someone who has a background in nursing that employers would love to have her, otherwise the board would have to encourage her to go back to school.
4. **Jeffrey Wolfe** **LPN Renewal** **Positive response/Expired over 10 years**
Mr. Wolfe appeared for a personal appearance. Mr. Wolfe applied for an LPN renewal and answered "yes" to question #3 on his renewal application. Mr. Wolfe explains that he had seizures as a kid and they went away only to come back by his mid-30's worse. By his 40's, they had gotten really bad, he was placed on a few different medications. Mr. Wolfe states after his knee surgery, when try to fill a prescription, he checked a box on the prescription that needed to be filled. He states that couldn't tell the count, thought it said 40 and put a 4 in front of the 0. He has not had to be hospitalize for 2 years now and says he's interested in going back into nursing through the Bridge program for RN. Mr. Wolfe last time working as a nurse was in 2004. ALJ Owens asked if he submitted continuing education certificates, he says no, didn't know he had to. He also shares that he wants his LPN license so that he can go back to nursing school. Ms. Owens states that he can go for an RN

license without going thru the Bridge program. Mr. Wolfe states he prefer to go thru the bridge program. ALJ Owens recommends Mr. Wolfe license be renewed on probation with the following terms: practice as an LPN for 6mnths after completing a refresher course with submitting quarterly reports and 24 continuing education credits, 6 in pharmacology, 6 in assessments, 6 in professional development, 6 in risk management/documentation.

Since that time she has learned to be in more control of her actions and has matured. This happened when she was 19. She has not had any other issues. Her driver's license was suspended for an unpaid ticket and she was charged with driving while suspended. She paid the ticket and her license is valid. Due to the time frame of the incident and no other issues, ALJ Rock recommends Ms. Mastin be allowed to test. Upon successful passage her license is to be issued free and clear.

13. Grace Upshaw LPN Exam Positive Response

Ms. Upshaw appeared for her personal appearance regarding her application for licensure. She previously held a CNA license. She worked as a CNA for around 6 years. In 2015, she had a family incident. Her sister has a slight disability. She went with her mom to take care of her. Her mom was scolding the sister. The sister then got mad and got in the mom's face. Ms. Upshaw stepped in the middle of them to protect her mom. They then got into a physical fight. The charges were dropped from a felony to a misdemeanor. She was on probation for six months and she took anger management classes. She doesn't remember the agency she took it through. She believes the classes helped her to think differently. She thought she was protecting her mother at the time. If she could do it over again she knows there could be another way to stop the situation. She has not had any other issues. Due to completing all the court asked her and taking anger management classes, ALJ Rock recommends Ms. Upshaw be allowed to test. After successful passage, her license is to be issued free and clear.

14. Shandie Fiscus LPN Exam Positive Response

Ms. Fiscus appeared for her personal appearance regarding her application for licensure. She graduated in 2016. She previously has a CNA and HHA license. Both of these license are still active. She had just gotten her license when she was 18 and she didn't take anything serious in life. She was working at Garden Villa. She then stopped doing CNA work for a while. She has several driving situations. These started when she was 15. She was driving with a permit and was driving without an adult because she had just dropped her mom off. When she was 17 she got a driving with no insurance and had license was suspended. She has several driving while suspended because her mother was disabled and she was trying to help her. Her license is now active. In 2012, she was charged with criminal mischief. She was with a guy who was also dating another girl, the guy died, the other lady said she keyed her car. She was going to court with her. There was a no contact order in place. The guys that was accused for murdering the other guy said the other girl had tried to have the guy that was murdered killed. She was upset about this and contacted the other girl on Facebook. She was placed on probation for a year and the charges were dismissed afterwards. She has not been in trouble since. She was very young at the time. Nursing school changed her whole life. She is currently working at Golden living as a CNA. She loves working there and will be working there as an LPN once she is licensed. Since she has had no other issues and has taken responsibility for her past ALJ Rock recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

15. Kelly Leard RN Endo Failure to Disclose

Ms. Leard appeared for her personal appearance regarding her application for licensure. She has been licensed as an RN in IL since 2014. She is in the process of moving to Indiana. She failed to disclose an arrest she had when she was 20 years old. In 2009, she was in college and had been drinking at a friend's house. She entered into a pretrial diversion program. She thought since she completed the program the matter was off her record. Due to this being her only issue, ALJ Rock recommends Ms. Leard be allowed to endorse free and clear.

16. Lisa Mello RN Exam Previous Testing Attempts

Ms. Mello appeared for her personal appearance regarding her application for licensure. She graduated in 2013 and has tested 3 times. She has an expired nurse's aide license. She has a letter from Remar review that has a 95% probability of passing. She previously took a Kaplan review course and feels like it didn't work for her. She feels like this last review course was a good one. She developed a study program with this and feels she has really benefited from this. She feels more competent now to take the test than she ever has been before. Due having already taking a review course and being issued the 95% probability letter, ALJ Rock recommends Ms. Mello be allowed to test. Upon successful passage, her license is to be issued free and clear.

17. Phyllis Brown RN Exam Grad Date 2012/Previous Testing Attempts

Ms. Brown appeared for her personal appearance regarding her application for licensure. She has an expired LPN license in LA and SC. She has an active LPN license in IN. She has never had any discipline on any of these license.

She graduated in 2012. She is currently working as an LPN. She works at Millers Merry Manor. She has been studying every day to get ready to test again. ALJ Rock recommends Ms. Brown be allowed to test after completing a review course and submitting documentation to the board showing she has at least a 95% chance of passing. Upon successful passage of the NCLEX, her license is to be issued free and clear.

18. Tania Beasley LPN Endo Failure to Disclose

Ms. Beasley appeared for her personal appearance regarding her application for licensure. She has an active LPN license in TX. That license has not been disciplined. She failed to disclose a 1999 arrest. She was at a friend's house that was raided. She was arrested and the charges were dropped. She has not had any other issues. Due to the time frame of this incident and not having any other issues ALJ Rock recommends Ms. Beasley be allowed to endorse free and clear.

19. Michael Bullock RN Exam Previous Testing Attempts

Mr. Bullock appeared for his personal appearance regarding his application for licensure. He graduated in 2013. He currently has a CNA license and works at Golden Living. He has taken the test 4 previous times. He has audited some courses and has gone to the doctor for his test anxiety. He has also been meeting with a personal tutor. He has been meeting with her since April. He submitted documents showing he completed the auditing, been to the doctor, and getting assistance from the personal tutor. ALJ Rock recommends he complete a review course and provide the board with a 95% probability letter. Once this is received he will be allowed to test. Upon successful passage of the NCLEX his license is to be issued free and clear.

20. Allyson Bonn RN Endo Positive Response

Ms. Bonn appeared for her personal appearance regarding her application for licensure. She currently has a RN license in KY. She has not worked as a nurse since 2013 but her KY license is still active. She starts August 15 as a travel nurse. She wants her nursing license in Indiana so she can work closer to home. In 2010, she was charged with having a concealed handgun without a permit. She had one in KY but didn't have one in IN. She completed a pretrial diversion program and the case was dropped. In 2013, she made a baby bottle in Walmart and they said she did it with their formula. She used her own formula. The charges were dropped. In 2013, she also had an OWI. She was in an abusive marriage and was separated from her husband at the time. She asked him for some Excedrin but he gave her something else. She requested a drug test. This happened in November and the first hearing was in April. Through this time she took voluntary drug tests. She completed probation in April of 2015. She has not had any more issues. Due to the fact that she successful completed probation ALJ Rock recommends her license be issued free and clear.

21. Ronan Onita LPN Exam Grad Date 2012

Ms. Onita failed to appear for her personal appearance. This matter is to be rescheduled one time.

22. Nina Anderson RN Endo Positive Response*

Ms. Anderson failed to appear. Due to this being her second failure to appear ALJ Rock recommends her application for licensure be denied.

23. Doris Jordan RN Exam Grad Date 2002/Previous Testing Attempts* CONTINUED

24. Yuliya Leshcanka RN Endo Failure to Disclose *

Ms. Leshcanka appeared for her personal appearance regarding her application for licensure. She has a RN license in IL. She has not had any discipline on this license. She is currently in a doctorate program and should graduate in Dec. In 2015, she was arrested for theft. She took counseling classes and the matter was dismissed. This matter since has been expunged. Due to the fact that the matter was expunged ALJ Rock recommends her license be issued free and clear.

25. Angela Dean RN Exam Failure to Disclose/Previous Testing Attempts

Ms. Dean failed to appear. This matter is to be rescheduled one time.

26. Thomas Berry RN/APN Endo Positive Response* VACATED

27. Lisa Parsons LPN Exam Grad Date 2009/Previous Testing Attempts*

Ms. Parsons appeared for her personal appearance regarding her application for licensure. She is currently working as a CNA at Wellbrook of Caramel. She graduated in 2009 and has tested once in 2010. She has worked consistently as a CNA since 2007. She had a lot going on with her health since 2010. She went back to Medtech and is taking tutoring sessions through them. Since she has been in the medical field ALJ Rock recommends that she take a review course and provide the board with documentation showing she has at least a 95% chance of passing. Once this is received she will be allowed to test. Upon successful passage of the NCLEX, her license will be issued free and clear.

28. Megan Murray RN Exam Failure to Disclose *

Ms. Murray appeared for her personal appearance regarding her application for licensure. She will be graduating in December. She was due to graduate in sooner but had a baby. She has one med surge class to complete. She failed to disclose a 2011 matter on her application. She was at a graduation party and someone hit her car and called the cops. The cops asked if she was drinking she said she had one glass of wine. Her BAC was 0. She was charged with possession of alcohol. She was a minor at the time. ALJ Rock recommends that she be allowed to test. Upon successful passage of the NCLEX her license is to be issued free and clear.

29. Christine Johnson RN Endo Failure to Disclose *

Ms. Johnson failed to appear. Since this is second failure to appear ALJ Rock recommends that her application be denied.

30. Emily Goble RN Exam Failure to Disclose *

Ms. Goble appeared for her personal appearance regarding her application for licensure. She graduated in May of this year. She has an active LPN license and an expired CNA license. She failed to disclose a public intoxication charge. She had two, on in January and May of 2010. She completed the probation, she took an alcohol course and community service. She has not had any other issues. She only drinks on occasion now. If she drinks she does not drive. She provided a letter of reference. ALJ Rock recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

31. Nancy Monfiston LPN Exam Grad Date 2012

Ms. Monfiston failed to appear. This matter will be rescheduled.

32. Amy Johnson RN Endo Failure to Disclose

Ms. Johnson failed to appear. This matter will be rescheduled.

33. Christina Fulkerson RN Endo Failure to Disclose – VACATED

34. Melissa Popp RN Endo Failure to Disclose

Ms. Popp appeared for her personal appearance regarding her application for licensure. She submitted letters of recommendation and certified documents. She currently has a RN license in IL. She failed to disclose a DUI from 2004. The charges were dismissed due to lack of evidence even though she had been driving and drinking. In 2009, she had another DUI and was found not guilty. She refused to take the breathalyzer out of fear of a false positive. She failed the pivot test. She was arrested. She went to court and was found not guilty. They didn't have any evidence that she had been drinking. This time she had not been drinking. She crossed over the median trying to get something out of her purse and that is why she was pulled over. She has not had any other arrest for drinking and driving. No other arrest since 2009. She doesn't drive after she has had a drink. ALJ Rock recommends that her license be issued free and clear.

35. Eric Karnhem RN Exam Positive Response

Mr. Karnhem appeared for his personal appearance regarding his application for licensure. He graduated in 2015 and has tested once before. In 2015, he had an OWI. When he graduated he went out and celebrated. His criminal probation should be lifted in November. He completed the Prime program and completed 180 hours of community service. He currently volunteers at a day center. He is currently taking Kaplan review course. ALJ Rock recommends that he complete the review course and provide documentation showing that he has at least a 95% chance of passing. Once he has submitted that to the board he will be allowed to test. Due to the fact that he will probably not test before October and his criminal probation will be up in November ALJ Rock recommends that his license not be issued until he provides the board with documentation showing that he has successfully completed his criminal probation. After that documentation is submitted he is to be issued free and clear.

36. Jeffrey Kolbus RN Exam Positive Response

Mr. Kolbus appeared for his personal appearance regarding his application for licensure. He provided charter and academic references. He just graduated this year. In 2011, he was visiting his sister at IU. He was at a tailgate party and one of her friends handed him a beer. The excise police came up to him and he panicked and started to run. He took a pretrial diversion program and successfully completed it. He no longer drinks alcohol. IN April 2011, he took some earrings from Kohl's with a group friends; he doesn't even know why he did this other than trying to fit in with the group of people he was hanging out with it. In March 2011, he drank a coke while in the supermarket and was arrested. This incident and the incident from Kohl's were consolidated together. Upon completing behavior counseling the matter was dismissed. In November of 2012, he was arrested for minor consumption of alcohol. He was at a friend's house and the cops were called. They asked if he was drinking and he said yes. His BAC was .05. He attended an alcohol education class and the charge was dismissed. There have not been any other issues. He was worked really hard to turn his life around. He was 18 and 19 at these incidents and he was seeking happiness through being accepted through friends but now knows that is not where it lies. He has a passion for being a nurse and has been committed to turning his life around. Due to him learning from his experience and taking responsibility of his actions ALJ Rock recommends that he be allowed to test. Upon successful passage his license is to be issued free and clear.

37. Rebecca Wells RN Exam Failure to Disclose

Ms. Wells appeared for her personal appearance regarding her application for licensure. She has an active LPN license in IL where she currently works. She has tested twice since 2009, the last time was in 2013. She believes she was unsuccessful before because she would hurry up and take it. She was looking at it from the wrong angle. The large gap was due to flare ups from her MS and she was having a hard time. She submitted letters of reference. She has been working since 2007 as an LPN. In 1993 she was 21 and was out. She got into an altercation with someone. She accepted the consequences. Since that time she has not had any trouble. ALJ Rock recommends that she take a review course and provide the board with documentations showing she has at least a 95% predictability that she will pass. Once this is received she will be allowed to test. Upon successful passage, her license will be issued free and clear.

38. Matthew Yoder RN Exam Grad Date 1995\Previous Testing Attempts

Mr. Yoder appeared for his personal appearance regarding his application for licensure. He graduated in 1995. He had a CNA license in Indiana. In 2004, he moved to Georgia. He currently works in dialysis as a patient tech. He has not had any criminal issues. He currently lives in Georgia. He wants to take the test in Indiana and endorse to Georgia. He submitted documentation showing what he has done to complete his plan of study. He has bought a lot of books and took Kaplan in Georgia. He has been reviewing online. He was previously told to complete his plan of study and he has done that. He has taken the test 7 times. Due to completing his plan of study like he was instructed to at his last personal appearance, completing an intense in person Kaplan course, ALJ Rock recommends that he obtain a 95% predictability letter from Kaplan. Once that letter is received by the board, he will be allowed to test. Upon successful passage his license is to be issued free and clear.

39. Cherice Brown LPN Exam Failure to Disclose

Ms. Brown appeared for her personal appearance regarding her application for licensure. She graduated in 2014. She has tested once. She hasn't tested again because she went into real estate. She got discouraged when she didn't pass. She has been taking Kaplan, NCLEX reviews, studying books, taking tests. She failed to disclose a criminal matter from June 2014. Driving with a family friend to Georgia, she was pulled over and was told her that she had stolen the car she was driving and stole everything in the car. He searched his passenger and the passenger had an illegal substance on him. She did not know he had marijuana on him. She was arrested. She has never been in trouble. She was stopped due to racial profiling. She was placed on probation and the matter was dismissed. ALJ Rock recommends that she be allowed to test. Upon successful passage of the NCELX her license will be issued free and clear.

40. Katherine Reaves RN Endo Failure to Disclose

Ms. Reaves failed to appear. This matter is to be rescheduled one time.

41. Sydney Sturdevant RN Exam Previous Testing Attempts

Ms. Sturdevant appeared for her personal appearance regarding her application for licensure. She graduated 2015. She has previously tested 3 times. The last time was in February 2016. She took the Hurst review in April 2016. She has

always had test anxiety and struggled with standardize testing. Since she recently taken the Hurst review ALJ Rock recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

42. Christian Wade RN Exam Failure to Disclose

Ms. Wade appeared for her personal appearance regarding her application for licensure. She has a CNA license and has been working at Ortho Indy for 10 years. She has previously test twice; once in Texas and once in Indiana. November 2015 was the last date tested. She has taken the Kaplan, worked with a couple nurse friends, and been working with a personal tutor. She failed to disclose a criminal matter. She was on vacation in Georgia and was pulled over for speeding. She couldn't get back to Georgia to attend a hearing so there was a bench warrant issued for her arrest. The bench warrant will not be lifted until the fees are paid. The fees are currently over \$3,000. She is currently in the process of getting that paid. ALJ Rock recommends that she be allowed to test. After successful passage her license is to be issued free and clear.

43. Niya Johnson LPN Exam Positive Response

Ms. Johnson appeared for her personal appearance regarding her application for licensure. She has previously tested once before in March 2016. She has a CNA license. She is currently working as a CNA. In 2010, a fight broke out and everyone in the area was arrested, there were no charges filed against her. In 2012, one of her family members got into an altercation with someone and that person said she was involved. Once they went to court it was dismissed because she was not involved. She no longer hangs out with those people. She graduated in October 2015. She is currently studying every day for the test. ALJ Rock recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

44. Kelly O'Shaughnessey APN App Failure to Disclose

Ms. O'Shaughnessey appeared for her personal appearance regarding her application for licensure. She was represented by Counsel Lorie Brown. She failed to disclose a past criminal matter. In 2011, she was driving home from a friend's wedding. She was pulled over for having a headlight out. Her BAC was .08. The charge was later amended in court to reckless driving. She disclosed this information on her RN application. She did not disclose it on her APN application because she thought it had been expunged. She took a 6 week education course. She did take an evaluation last week to show no issues. She provided letters of support, and a copy of the evaluation. ALJ Rock recommends that her APN licensure be issued.



3. Jennifer Adams RN Renewal Positive Response -CONTINUED


