#### IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Ernest Klein, Executive Director of the ISNAP Program, presented the monthly report to the Board. Mr. Klein informed the Board that the ISNAP program is in the fourteenth business day with the new ISNAP program. Mr. Klein explained that the transition from Compass Vision, Inc. to ISNA has gone relatively smoothly, with the exception of activating the toll-free number. Mr. Klein introduced Chuck Lindquist as the new ISNAP Program Director and Robin Riebsomer as the new ISNAP Intake Coordinator. Upon request of the Board, Mr. Lindquist, explained the ISNAP program to the nursing students present in the audience.

#### V. EDUCATION

**A. Indiana University Northwest – Plan of Correction** Ms. Peters was out of the meeting

Linda A. Rooda submitted her plan of correction to the Board regarding Indiana University Northwest's ASN and BSN programs. Ms. Rooda explained that Laurie Peters visited the school in December of 2003 regarding their low pass rates. Ms. Rooda informed the Board that the pass rates for their ASN program have increased from 86% last year to 91% this year, and the BSN pass rates are currently at 77%. Ms. Rooda explained that they are confident that these latest changes will be reflected in the pass rates for the ASN and the BSN in 2006.

There is three full time faculty and an administrative assistant that share one office. Ann Fitzgerald appeared and explained that they have two offices and one private office, where all private matters are held.

Ms. Slagle expressed to Ms. Schmidt that she needs to get into compliance with her probation order as soon as possible. Ms. Slagle recommended the Board renew Gabrielle Linn Schmidt's application for renewal.

Mr. Eickbush appeared before the Board regarding the positive response on his renewal application. Mr. Eickbush stated that he has a history of two DUI's. His sobriety date is August 4, 2004, and he attends six to seven AA meetings per week. Mr. Eickbush has clear active licenses in West Virginia and Texas. Mr. Eickbush stated that he self-reported to his employer last August, and was in a monitoring program with them. Ms. Slagle recommended the Board renew Mark Eickbush's application for renewal pending the results of an evaluation by ISNAP.

Ms. Henderson did not appear before the Board regarding the positive response on her endorsement application. Ms. Slagle recommended the Board deny Cynthia Henderson's application for licensure by endorsement.

Ms. Lasco appeared before the Board regarding the positive response on his endorsement application. Mr. Lasco has a sobriety date of April 15, 1995. He has a clear and active license in the State of Kentucky. Ms. Slagle recommended the Board issue Michael Robert Lasco full licensure with no restrictions.

The board felt that they could not render an opinion on this issue. Ms. Rowles appeared again today to try to obtain an advisory opinion since she had since received one from the Kentucky board of nursing. Mervin Helmuth informed Ms. Rowles that it is the board's practice not to interpret the law or to ask the Office of the Attorney General to interpret the law. The law speaks for itself. The board cannot give her advice. Ms. Rowles asked that the board issue a letter stating their position.
