**II. ADOPTION OF THE AGENDA**

**III. ADOPTION OF THE MINUTES FROM THE JULY 18, 2013 MEETING OF THE BOARD**

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Mr. Lindquist provided handouts for the July 2013 monthly report as well as the annual report from August 1, 2012 to July 31, 2013. Highlights include the following: 380 new intakes; 92 of the new intakes had already participated in ISNAP at one time with 65% of those coming back in via the regulatory scheme; 331 new Recovery Monitoring Agreements and of those 48% are coming in via the regulatory process. The largest referral source is IPLA due to personal appearances and the second most common referral source is an employer or EAP. The primary drug of choice for participants is alcohol and then opiates. Mr. Lindquist then addressed the students.

**V. EDUCATION**

**A. Indiana State University- Request for change in credit hours and courses (Lea Hall)**

Staff from ISU appeared before the Board regarding curriculum changes in their BSN program to get to 120 credit hours. They have provided an update which will allow their statistics course to remain in the curriculum. The university now no longer requires three upper division electives they only require two so statistics could be added back into the curriculum. They will remove Sociology 101 and cover it in a variety of other courses given. A motion was made and seconded to grant the request. Burghduff/Narwold 7-0-0, motion carries

**B. Marion Community School System-Tucker Vocational Program Center LPN Program- Monthly progress report and Notice of Intent to close program (Susan Chastain)**

Susan Traynor Chastain appeared along with Amy Roush, Assistant Superintendent, Amanda McCammon and Arletha Smith. The Board reviewed the submitted reports. Ms. Narwold asked where they are in terms of phase out. Ms. Narwold voiced a major concern regarding students and making sure they are going to be qualified to sit for NCLEX and what will occur if they do not sit for NCLEX. Ms. McCammon indicated that the school has no articulation agreements in place for transfer of credits as the program is a clock program and not a credit hour program. The school has been in touch with another facility regarding an agreement for transferring withdrawn students or failing students for transition. There is nothing final in place at this time. Ms. Narwold asked how students could articulate previously on clock hours and staff indicated they could not transfer credits. Mr. Burghduff asked if students were aware there was no articulation agreement and staff indicated this is contained in the handbook. Their estimated graduation date is September 28, 2013. Ms. Smith indicated they currently have 35 students and all are on track for graduation at this time. Ms. Narwold asked about the three disciplinary issues with students this month and what the counseling involved. Ms. Smith indicated that one was placed on probation until the end of the program and if there is another incident they will be dismissed from the program. Ms. Cooper asked about students who are sitting out for personal or financial reasons and staff identified 18 students (4 for academic reasons, 14 self withdrawals; 3 of which occurred prior to September 2012 and 11 after the school's issues) who are in limbo. Ms. Cooper asked if these transitional students had been contacted. Staff indicated the 4 students who failed to meet academic requirements have not been notified; however, prospective students who passed the entrance exam for the 2013-2014 academic year have been notified that there will be no program. Ms. Hall asked what is in place for the September 2013 graduates if they are not successful on NCLEX. Staff indicated there will be a three day live NCLEX review course; they already have ATI embedded in curriculum and ATI following them if they do not pass. Ms. Narwold asked about the one faculty member leaving and staff indicated this individual has not been replaced. The program still employs three full time staff, 2 part time staff and one director at this point in time. Ms. Narwold asked if a staff person will be available if students in the current class do not pass NCLEX as virtual ATI does not meet every need if students are not successful in NCLEX. Staff indicated recommendations will be made to maintain employment of the director for records and follow up. The Board indicated the school needs a person in place until all graduates pass NCLEX or the student decides to self withdraw from the testing environment. Ms. Cooper indicated confusion about the student population. When was the last date they allowed students to test for admission? Staff indicated they notified students as early as January 2013 that they were postponing acceptance into the program for a new 2013-2014 class. **Board Action: A motion was made and seconded to accept the closure plan, report due September 5<sup>th</sup> and the program staff (Superintendent, Director of the Program, Director of the Technology Center) will return to the Board for a visit at September board meeting. 


