II. ADOPTION OF THE AGENDA

III. ADOPTION OF THE MINUTES FROM THE JULY 19, 2012 MEETING OF THE BOARD

A motion was made and seconded to adopt the July 19, 2012 minutes. Narwold/Burghduff, 7-0-0, motion carries

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Lindquist reported on behalf of ISNAP. They have had 39 new intakes and 29 closures in the last year. They currently have 552 individuals in monitoring. Mr. Lindquist reported that Roxanne Thomas resigned and that ISNAP is in the process of finding a replacement.

Mr. Klein gave the annual report for ISNAP. ISNAP is looking at their staffing model and may not replicate job duties in replacing this position. Mr. Klein reported that he has had a greater level of involvement since Roxanne left and indicates he is looking at greater efficiencies within ISNAP. The annual report includes statistics on individuals in monitoring over the last year, gender, breakdown of primary diagnosis, employment status and breakdown by county and out of state monitoring.

Mr. Burghduff noted that in reviewing cases for this month there are a relatively large number of cases where individuals were sent for evaluation and not given them a diagnosis that entered into an RMA and subsequently had additional addiction issues. Mr. Burghduff complimented ISNAP on entering into an RMA for the safety aspect. Chuck indicated that ISNAP

prefers to see collateral evidence from providers who are calling employers, looking at INSPECT, etc. in completion of candidate evaluations.

VIII. BOARD DIRECTOR REPORT

Ms. Crawford reported that the consumer complaint protocol between the OAG and the BON has been successfully adopted and will go into effect on September 1, 2012. The LPN renewal window opened on August 15, 2012 and will close on October 31, 2012. All LPN's will be able to renew online this year. Two new judicial reviews have been filed against the Board in the last month and the Board will be updated as those cases proceed forward. The Board members will need to review the site visit spreadsheet so that site visits can be scheduled for Fall 2012. The Board was successful in the pending lawsuit regarding the release of email addresses of nurses but the anticipation is that an appeal will be made. The Board will be updated as this case progresses.

She has been working with Kaplian since her last test. She believes her issue with passing is due to anxiety. It has been suggested to looking into treatment for anxiety. She needs to take another review course and submit documentation showing the probability of 95% or higher for passing the exam then she will be allowed to test. License to be issued free and clear.

Ms. Quinn appeared regarding her application for licensure. She was arrested in 2008 and 2010 for driving on suspended license. In 2002, she was arrested for retail theft and plead guilty. She was with her cousin who actually stole the items. Her 2008 was dismissed because she did have license. In 2010 she did not have insurance and didn't know she had her license was suspended. She has had no issues since 2010. She is allowed to endorse.
3. Ruth Arce RN Examination Failed 7 times/Graduated 1992
Ms. Arce appeared regarding her application for licensure. She is currently on medication for anxiety. She needs to take a review course and submit documentation showing the probability of 95% or higher for passing the exam then she will be allowed to test. License to be issued free and clear.
4. David Tucker RN Endorsement CBC Hit
Mr. Tucker did not appear for his personal appearance.
5. Tiffany Givens LPN Examination CBC/Positive Response
Ms. Givens appeared regarding her application for licensure. She plead guilty to a misdemeanor battery charge in 2008, incident happened in 2007. She was at her son's grandmother's house. She got into fight with her ex boyfriend. She left the house with her son. Her son was seven at the time and did not want to leave. In the car her son was kicking and screaming and she smacked him in the mouth, because he had retainer in his mouth there was cut. Her ex-boyfriend saw the cut on his mouth and called the cops. In 2007, she was charged with driving on suspended license. These charges were dismissed. She works for St. Francis as a medical assistant.

She has never had an issue at work. She has not been in any trouble since 2007. She is allowed to test. License to be issued free and clear.

Ms. Lewis appeared regarding her licensure application. She has an extensive criminal background. In her past she got into a lot of trouble hanging out with her family. She has distanced herself from her family. She has received battery charges, theft, driving while suspended. All of these charges happened with a group of family members. In 2012 received a theft charge. She ran into a cousin at the mall, cousin gave her a bag to hold while she was holding her child. The cops came over and took the bag, clothes were in the bag. In 2004 theft charge happened was with family members. In 2002 and 2007 she received battery charges. In 2002 she went to pick her sister up who had been jumped by 7 girls. When she got there one of the girls came to the car and struck her with a lock, all the girls involved went to jail. In 2007 her cousin was arguing with someone who ended up stabbing her cousin in the face. Lewis was trying to break up the fight, she was punched in the face and she fought back. All involved went to jail. She doesn't have a relationship with this family any more. She needs to have an MMPI-II. She is allowed to test, license to be issued on probation for 6 months of active nursing, employer reports.
8. David Schwartz RN Examination CBC Hit
Mr. Schwartz appeared for his personal appearance regarding his application for licensure. He was arrested for patronizing a prostitute, via text message. This is the only trouble he has been in. He is not on any kind of probation. He has worked as a nursing assistant for 2 and half years without any trouble. He says he went to the wrong website. He is allowed to test and license to be issued free and clear.

She is currently employed and has had no issues. Ms. Ivy is allowed to test and license to be issued free and clear.
10. Zolakah Rorer LPN Examination Positive Response
Ms. Rorer did appear for her personal appearance. She finished school in June. She had an OWI in 2008 and Domestic Battery charge in 2005. 2005 was a result of fight with ex-boyfriend. Both parties went to jail. NO alcohol involved in the incident. She spent a year in anger management class. In 2008 she was drinking at a friend's house and was pulled over on the way home. She has had no other alcohol related issues. She is allowed to test and license to be issued free and clear.

14. Lisa Thompson RN Endorsement Positive Response
Ms. Thompson's personal appearance was continued.
15. Jamie Nakis LPN Examination CBC Hit
Ms. Nakis did not appear for her personal appearance.
16. Nicole Valencia LPN Examination Positive Response
Ms. Valencia did appear for her personal appearance. She received a DUI in 2006 and domestic battery in 2006 and 2004 battery for fighting with friend. 
