**I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM**

**II. ADOPTION OF THE AGENDA**

A motion was made and seconded to adopt the agenda as amended. McIntosh/Burghduff 8-0-0

**III. ADOPTION OF THE MINUTES FROM THE JULY 21, 2011 MEETING OF THE BOARD**

A motion was made and seconded to adopt the July 21, 2011 nursing board minutes with minor corrections. McIntosh/Laux 6-0-2 (Narwold and Ogle abstain)

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist and Ernie Klein appeared for the ISNAP. ISNAP has signed a contract for electronic case management system. Chuck distributed a copy of the use of controlled substances form for new RMA participants along with a letter for participants to give to their practitioners. Jimmy Ryser's benefit concert will be held on Sept 30<sup>th</sup> at St. Susannah's church gym in Plainfield to raise money for needs assistance fund. Intakes were slow in July but will likely double in August. Ernie Klein gave the annual report for the year for the ISNA and ISNAP. He gave handouts including a graphical representation of the participants over the last two years and a presentation of the financial report for that same two year period. With the new electronic system the goal is that participants can log in to read reports, newsletters, etc. but they will always have the option to call in. Providers will be able to file reports directly into the system and ISNAP staff will be able to scan in documents as well. The one year summary of the data also was presented. Terminations for non-compliance in the program are up. The data shows that most relapses take place in the first 18 months. Self reports in this data do not

include those referred by the Attorney General's Office. The data indicates that the percentage of men in the program is greater than the percentage licensed. There are a high number of nurses in the age 40-60 bracket. Opioids are still the number one drug of choice for ISNAP participants. Almost half of the nurses in the program are not currently working as nurses. Mr. Burghduff requested an accounting of the number of referrals in the Attorney General's Office from January 2010 to present. Ms. Ogle asked for the equation on how to calculate the total numbers of participants as the numbers are not depicted on the chart and Mr. Klein agreed to provide that information.

## V. EDUCATION

### A. FYI- Kaplan College Indianapolis

ADN Program- Request for Curriculum Change and Request for Accreditation Vote

The Board's minutes from April did not include their full accreditation vote and this fact needs to be reflected for accreditation.

Alice Farmer appeared for Kaplan College. Farmer has been there a little over a year. It appeared that the hours were too heavy for an LPN program. She looked at LPN programs in Indiana and surrounding states and NLNAC guidelines. They had duplicate content in many of their courses and needed to reorganize courses.

**Board Action:** A motion was made and seconded to accept the curriculum change. Narwold/Laux 7-0-0

### B. FYI- Kaplan College Indianapolis will change from HESI to KTP as of November 10, 2011

Alice Farmer appeared for Kaplan College. Kaplan Test Prep is a division of Kaplan, Inc. and they are moving it into their own campuses and utilizing their own product. The Board asked if they have a comprehensive prep for the NCLEX which does give a predictability of passing the NCLEX and Farmer replied that they do. Students are given a one to one mentor if they are not successful in passing the NCLEX. This was an FYI item only and did not require a board vote.

### F. Western Governors University- Initial Accreditation Report for BSN Program

Representatives appeared for WGU Indiana. Ms. Narwold and Ms. Hall conducted the initial site visit on August 2, 2011. WGU requests to admit three cohorts of ten students each. The concerns of Narwold and Hall included an additional acute care pediatrics piece farther down in the curriculum but WGU has time to build that piece into the curriculum. Faculty appears to be qualified and most are licensed in the State of Indiana or pending licensure. The recommendation is for initial accreditation with follow up visit in one year.

**Board Action:** A motion was made and seconded for initial accreditation with a site visit in one year. Narwold/Burghduff 6-0-0

### G. Chamberlain College- Initial Accreditation Report for BSN Program

Representatives appeared for Chamberlain College. Ms. McIntosh and Ms. Laux conducted the initial site visit on July 22, 2011. McIntosh was impressed with the facilities including a fully stocked simulation lab. Chamberlain has changed their admission criteria nationally to improve NCLEX scores. Overall concerns of the team were: clinical agency agreements expiring before students began; some clinical faculty expertise was questionable; clinical experts are not hired yet in the specialty areas; and national growth was also a concern as other campuses grew very rapidly.

The curriculum needs to include physics coursework and the capstone course did not include a clinical component.

**Board Action:** A motion was made and seconded for initial accreditation with a site visit in one year. McIntosh/Narwold 7-0-1 (Hall abstained)

## VI. DISCUSSION

A. **Board member participation in the NCSBN Educational Subcommittee-** Board members were asked to submit their interest levels in participating in this subcommittee to Ms. Crawford.

**Board Action:** A motion was made and seconded to consolidate the cause numbers in this matter and dismiss the pending probation withdrawal petition. Burgduff/Laux 8-0-0

**D. Discussion regarding proposed changes to 848 IAC 1-2-7**

The Board discussed their current rule regarding accreditation by the Higher Learning Commission. A panel will be put in place regarding revising the Board's current education rules. The Board members involved with the panel are: Natalie Hall (Chair), Lynda Narwold, Karen Dolk and Jerry Burghduff.

**VII. BOARD DIRECTOR REPORT**

Ms. Crawford reported that the RN renewal window opened on 8/15/11 and will run through 10/31/11. Nearly 5,000 nurses have already renewed at this time. Personal appearances for renewals will take place on ALJ Day and any overrun will move to the full board meeting for that month until January 2012. The plaque and original artwork from the National Counsel of State Boards of Nursing Annual Conference held in Indianapolis, Indiana on August 3-5, 2011 was presented to the Board.

**VIII. PERSONAL APPEARANCES**

Personal appearances were conducted by Board members Laux and Presley on this date.

**A. Appearances by Applicants for Licensure**

**1. Mallory Watson**

Ms. Watson appeared before the BON regarding her application for RN licensure by examination. She has failed the test 5 times previously. The BON voted to deny her application and she may reapply with proof of 95% probability of passing NCLEX following the completion of a review course.

**2. Stefan Coe**

Mr. Coe did not appear before the BON as requested to explain the positive response on his application for licensure by examination. The BON voted to deny his application for licensure.

**3. Ruth Weston**

Ms. Weston appeared before the BON regarding her application for RN licensure by examination. She has failed the NCLEX 6 times previously and therefore the BON voted to deny her application. She may reapply with proof of 95% probability of passing upon completion of a review course.

**4. Mallory Seeley**

Ms. Seeley appeared before the BON due to positive response in which she reported being charged with neglect of a dependent because she and her child were staying in a home in which marijuana was found. She provided additional documentation showing she has completed all requirements as of April 2010. The BON voted to allow her to test and that her license be issued free and clear

**5. Karina Koschmeder**

Ms. Koschmeder appeared before the BON due to reporting a charge of underage possession of alcohol while in college. She reported no further incidents and the BON voted to allow her to test and her license be issued free and clear

**6. Patrick Bryde**

Mr. Bryde did not appear as requested for the personal appearance meeting to explain the positive response on his application by endorsement. The BON voted to deny his application.

**7. Kiley Franklin**

Ms. Franklin appeared before the BON regarding her licensure application for RN. She has failed the test 3 times since completing school in 2008. She reports working with a tutor at this time. The BON voted to deny her application and she may reapply with proof of 95% or higher probability of passing the NCLEX.

8. **Maritza Kulcsar**

Ms. Kulcsar appeared before the BON after reporting that in 2007 she collected unemployment benefits while still working. For this reason, NV denied her license application. Based on this, the IN BON denied her application.

9. **Erica Burch**

Ms. Burch requested that her PA be rescheduled and it will be set for Sept. 1. She has applied for RN licensure by examination and has failed the NCLEX five times since completing nursing school in 2003.

10. **Jennifer Miller**

Ms. Miller did not appear before the BON regarding her license application by endorsement; therefore, the BON voted to deny her application. She also did not appear at the personal appearance meeting in May 2011 as requested.

11. **Christine Fruit**

Ms. Fruit appeared before the BON regarding her application for RN licensure by examination. She has failed the NCLEX 6 times previously but has participated in a review course. She presented proof of 95% or higher probability of passing the test; therefore, the BON voted to approve her application to take the NCLEX.

12. **Kimberly Means**

Ms. Means appeared before the BON regarding her 2006 felony conviction for theft. She stated she worked at a hotel and let a man into rooms who stole 4 televisions. The matter was not resolved until 2009 when a warrant was issued for her. After debate, the BON voted to allow her to test and that her license is issued on probation for 2 years with quarterly employer reports.

13. **Dolly Gill**

Ms. Gill reported 2 terminations in 2007 and 2010 and an arrest in 2007 for domestic battery. Which occurred before nursing school. The BON voted to allow her to test and that she is issued a license on probation for 1 year with quarterly employer reports.

14. **Carrie Ricci**

Ms. Ricci requested that her PA be rescheduled for Sept. 1. She has attempted the NCLEX in 2005 and 2006 and failed since completing her nursing school program in 2004.

15. **Gia Hayes**

Ms. Hayes appeared before the BON regarding her RN application by endorsement. She reported a 1997 arrest for resisting arrest and in 2001 for battery charges. The BON voted to issue her license on probation for two years with quarterly reports or self reports if not employed.

16. **Cynthia Neiman**

Ms. Neiman appeared before the BON and reported 2 terminations in health settings while in nursing school due to attendance in 2009 and 2010. The BON voted to allow her to test and that she be issued a probationary license for 6 months with two quarterly reports from her employer

17. **Kimberly Johnson**

Ms. Johnson appeared before the BON regarding her LPN license application. She reported a termination in 2010 for an emotional outburst directed at another employee. She also reported a domestic battery charge in 2004 in CA that led to her arrest. The BON recommended that she complete an MMPI -II evaluation and report the results to the BON before a decision can be made.

18. **Elizabeth Morrison**

Ms. Morrison appeared before the BON regarding her application for licensure by examination. She reports treatment in 1996 and 1999 for alcohol abuse and a DUI in 1999. She stated her sobriety date is in 1999. The BON recommended that she have an ISNAP evaluation and sign an RMA if eligible. Upon completion of the ISNAP evaluation, her license will be issued free and clear.

19. **Amanda Engle**

Ms. Engle did not appear before the BON as requested. The BON voted to deny her application. She has failed the NCLEX 6 times previously.

20. **Susan Shepherd Smith**

Ms. Smith appeared before the BON regarding her RN license by endorsement application. She reported taking Ambien to sleep then realizing she had unwashed narcotics in her pocket. She attempted to return them and ended up in jail following an accident in her vehicle which she could not recall happening. She was terminated for not returning the medication because she was in jail. She stated she completed all terms of her arrest and her KY license was not disciplined. The BON recommend that she be issued a free and clear license

21. **Tationna Arnold**

Ms. Arnold did not appear as requested and the BON recommended that her application be denied. She had completed her nursing school program in 2007 and failed the test in 2008.

22. **Diana Revalee**

Ms. Revalee appeared before the BON regarding her RN licensure application following 4 previous failures on the NLCEX exam. The BON recommended that her application be denied and she may reapply with proof of 95% or higher probability of passing the NCLEX.

23. **Daniel Landeros**

Mr. Landeros appeared before the BON regarding his application for RN licensure by examination. He reported a DUI while in nursing school in 2008; his BAC was .08% and he has completed all requirements and the matter is resolved as of Feb. 2010. . The board voted to allow him to test and that his license be issued free and clear.

24. **Anne Frey**

Ms. Frey appeared as requested. She has been assessed by ISNAP and is entering into an RMA. She will be allowed to test and her license will be issued on probation for the length of her RMA with quarterly employer reports.

25. **Todd Shaw**

Mr. Shaw appeared before the BON and reported a DUI in July 2010 which he did not report on his 2010 LPN renewal as charges pending. The BON recommended he complete an ISNAP evaluation and enter into an RMA. He is on criminal probation until Oct. 2011 so his license will be issued on probation for the length of his criminal probation or the length of the RMA whichever is longer


