II. ADOPTION OF THE AGENDA

A motion was made and seconded to adopt the agenda as amended. Narwold/Ogle, 9-0-0, motion carries

III. ADOPTION OF THE MINUTES FROM THE NOVEMBER 14, 2013 MEETING OF THE BOARD

A motion was made and seconded to adopt the minutes from the November 2013 board meeting. Dolk/Laux, 8-0-1, motion carries (Narwold abstains)

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Chuck Lindquist, Program Director, appeared on behalf of ISNAP. Quarterly reports for the third quarter of 2013 were handed out. The category for "significant non-compliance" increased from 3% to 6%, partly because of a clean-up of a vacant case manager position. Approximately 87% of ISNAP participants were in "significant compliance." ISNAP is moving towards going fully electronic with all of their records. There were 45 intakes in November and 43 in October, with 114 total licensees currently in the intake process. Most of the new intakes include alcohol as the primary drug of choice as a result of a DUI reported during the RN renewal cycle. Mr. Lindquist indicated videos for employers and participants are being worked on and should be available on ISNAP's web page after the beginning of the year.

V. EDUCATION

There were no education agenda items for this meeting.

VI. DISCUSSION

A. ISNA Update (Gingy Harshy-Meade)

Ms. Harshy-Meade, ISNA Director, indicated that ISNA is currently conducting an inventory on their computer equipment at this point in time. She delayed it previously due to her new role and gaining an understanding of the organizational structure. ISNA is restructuring and they will not be hiring any new staff until they figure out exactly what is required. ISNA has increased the number of hours of the current case managers and the office manager took over some previous ISNAP responsibilities. Ms. Dolk asked about a projected timeline for implementation and Ms. Harshy-Meade indicated she anticipates a January 2014 implementation date. Dr. McIntosh asked about the increase in case manager hours and Ms. Harshy-Meade indicated that case managers have increased their workload to forty (40) hours per week. Ms. Ogle asked about the plan for IT and ISNAP support. Ms. Harshy-Meade indicated they are in the middle of the assessment and can present a strategic plan as part of the next Board meeting. The Board requested a strategic plan at the January 2014 Board meeting.

B. Request for Dismissal of Judicial Review Stacy Henderson, L.P.N. vs. Indiana State Board of Nursing

Mr. White explained to the Board that Ms. Henderson's counsel wishes to dismiss the pending judicial review. A motion was made and seconded to allow for the filing of the dismissal of the judicial review with prejudice. Narwold/Ogle, 7-0-0, motion carries

VIII. BOARD DIRECTOR REPORT

Ms. Kiefner Crawford reported the following:

- The NCSBN midyear meeting will take place in March 2014 in Kansas City, Missouri. NCSBN will fund two delegates with additional requests to be made through the NCSBN member resource fund. Ms. Kiefner Crawford suggested that the Board wait until after its election of officers next month to name the participants.
- The RN renewal clean-up is going smoothly. Several hundred personal appearances have already taken place and all clean-up will be completed by January 2014.
- The APN Audit notice has been released and participants will have until January 15, 2014 to turn in their continuing education and supporting documentation.
- Staff evaluations are in the process of being completed and are due by December 16, 2013.
- The education consultant has been hired. The estimated start date is December 30, 2013. Orientation will begin in-house but then the education consultant will shadow board members in the first quarter of 2013 for site visits.
- The emergency rules for prescribing controlled substances for all CSR holders are with the Board of Pharmacy and will undergo a vote in January 2014. This will affect APN subscribers.
- Ms. Kiefner Crawford attended an NCSBN conference in November 2013 where discussion was held regarding a new nurse licensure compact that would provide for portability across all fifty (50) states. Another meeting is to be held in spring 2014.

She was not drunk or drinking. She thought it would be funny. This happened in Mary 2013. She is allowed to test and her license is to be issued free and clear

 6. Amber Garcia LPN Exam CBC Hit/ Positive Response
Ms. Garcia appeared for her personal appearance regarding her application for licensure. In August 2011, she received an OWI. She was pulled over after leaving a concert. Her blood alcohol level was .09. She rarely drinks and does not drink if she has to drive. She is allowed to test and her license is to be issued free and clear.
 7. Rachel Crisman RN Endo CBC Hit
Ms. Crisman appeared for her personal appearance regarding her application for licensure. She had ticket for speeding and didn't appear in court and they suspended her license. She was then pulled over and was arrested for no license and insurance. In 2010, she had an OWI. She was out drinking and drove a friend home. Her blood alcohol level was either .15 or .16. The charge was dropped down to reckless driving. She has completed her probation. She was also arrested for minor theft and served a year of probation. She took some earrings. Her license is to be issued on probation for 6 months active practice with one employer report.
- Sierra Weddell RN Exam CBC Hit/ Positive Response

Ms. Weddell appeared for her personal appearance regarding her application for licensure. Last December she had a disorderly conduct charge. She was being disrespectful to a police officer. She had been drinking at the time. She was with friends. Her friend received an OWI. She needs to have an ISNAP evaluation. She is allowed to test. Her license is to be issued on probation for the length of her RMA. If she does not meet criteria for an RMA she will be on probation for six months active practice with one employer report.

8. Tyler Morrow LPN Exam CBC Hit/ Positive Response
Mr. Morrow appeared for his personal appearance regarding his application for licensure. He had DUI and battery charge. These were two separate incidents. He got into an argument with his girlfriend and she started hitting him so he grabbed her to stop. Alcohol was not involved in this incident. The batter charge was dismissed. When he had the DUI his blood alcohol level was .094. This is his only DUI. He did have a minor consumption. He also failed to appear in court due to the summons being sent to the wrong address. He is allowed to test. His license is to be issued on probation for 6 months active practice with one employer report.

Mr. Alford appeared for his personal appearance regarding his application for licensure. He took a formal review with Kaplin with the 95% chance of passing. He is allowed to test and license to be issued free and clear.

Ms. Nehring appeared for her personal appearance regarding her application for licensure. She went to school at ITT. She has taken ATI. She has a previous drug related charge. She needs to have an ISNAP evaluation. Her license is to be renewed on probation for the length of her RMA or one year active practice with quarterly reports whichever is longer.
4. Maureen Socha RN Renewal Office Manager Did Renewal*
Ms. Socha appeared for her personal appearance regarding her application for renewal. She asked someone to renew her license for her. Now she realizes she can't do this. She was under a lot of stress at the time. This matter is to be referred to the Attorney General's office and her status is to be Valid to Practice.
5. Sarah Lloyd RN Renewal Positive Response
Ms. Lloyd appeared for her personal appearance regarding her application for renewal. She is in a diversion program for an OWI from February this year. She is currently on criminal probation for a year. She has been in contact with ISNAP and has had her assessment. Renew on probation the length of her RMA or for two years active practice whichever is longer.
6. Stacy Haley RN Renewal Positive Response
Ms. Haley appeared for her personal appearance regarding her application for renewal. She appeared with attorney Lorie Brown. In March she was confronted by nursing manger due to discrepancy report to pharmacy. She was asked to take a drug test. There were also times she had forgotten to waste medication. She refused to take a drug test. She is in ISNAP and on an RMA for 3 years. So far she is in full compliance. Her license is to be renewed on probation length of RMA.
7. Carol Allison RN Renewal Positive Response
Ms. Allison did not appear for her personal appearance regarding her application for renewal. Her request for renewal is denied.
8. Natasha Freije RN Renewal Positive Response
Ms. Freije appeared for her personal appearance regarding her application for renewal. She appeared with attorney Lorie Brown. She received an OWI. She is currently in ISNAP. Her license is to be renewed on probation the length of her RMA.
9. Sarah Benninghoff RN Exp Renewal Positive Response
Ms. Benninghoff appeared for her personal appearance regarding her application for renewal. In October 2012, she received a DUI. Her blood alcohol level was .13. She no longer drinks at all. The licensee appeared before the ALJ and was referred to the full Board. The licensee's Counsel, Henry Dein, requested a continuance until the January 2014 meeting, which was granted.
13. Alana Schaefer RN Renewal Positive Response
Ms. Schaefer appeared for her personal appearance regarding her application for renewal. She received an OWI that was reduced to reckless driving. She had her brother in the car with her at the time. Her blood alcohol level was .1. She did community service. This is the only time she has been in trouble. She no longer drinks. She does not meet criteria for ISNAP. Her license is to be renewed free and clear.
14. Allen Howard RN Renewal Positive Response*
Mr. Howard did not appear for his personal appearance regarding his application for renewal. His request is denied.
15. Maureen Elmore RN Renewal Positive Response*
Ms. Elmore appeared for her personal appearance regarding her application for renewal. She is currently in ISNAP and in full compliance. She is on a 3 year RMA. Her license is to be renewed on probation for the length of her RMA.
16. Diana Handley RN Renewal Positive Response*
Ms. Handley appeared for her personal appearance regarding her application for renewal. She had an OWI. She was placed on new medication and got up out of bed and went to someone's house. She has no memory of this. The OWI was a result of the medication. She was taken off the medication after his. She is currently on other medication. She needs to have an ISNAP assessment. Her license is to be issued on probation the length of her RMA.
17. Larry Swaby RN Renewal Positive Response*
Mr. Swaby did not appear for his personal appearance regarding his application for licensure. His request for renewal is denied.
18. Virginia Timbrook RN Renewal Positive Response*
Ms. Timbrook appeared for her personal appearance regarding her application for renewal. She was arrested for domestic violence in August 2013. It involved a domestic issue with ex husband. She has never had any issues at work. Her license is to be renewed free and clear
19. Kendra Clay RN Renewal Positive Response* FULL BOARD
Ms. Clay appeared before the full Board regarding her response for the RN renewal cycle. She appeared before Ms. Cooper last month regarding her termination as a nurse faculty member. She was doing consulting for another nursing program at this time while serving as a full-time faculty member. The program felt it was a conflict of interest and terminated her. All of the programs were in the Indianapolis area. Ms. Ogle asked if this was ethical behavior and Ms. Clay indicated she did not see any issue. Ms. Ogle asked if she took knowledge from her first position and used it in the consulting role and Ms. Clay indicated she used her "general nursing skills". Ms. Cooper asked where the primary place of employment was and Ms. Clay indicated it was Fortis College. Ms. Cooper began consulting for ITT during this time. Ms. Clay indicated she also worked at Ivy Tech-Anderson, Harrison College. Ms. Clay indicates she left Harrison College as an agreement to a mutual separation as she filed a complaint and received a severance package. Dr. McIntosh asked why she agreed to a separation at Harrison College. She indicated she had issues with management and filed a complaint with EEOC. Ms. Narwold asked about the knowledge she gained regarding nursing faculty and working with the Board of Nursing. She is now the chair of the Nursing program. Ms. Cooper asked if previous employers would share her characterization of her leaving from Fortis and Harrison. Ms. Clay indicates she does not think Harrison would. Ms. Cooper asked if she was disciplined in the scope of her employment at Harrison and Ms. Clay indicated she was. Ms. Cooper asked if she reported the discipline and she indicated she did not. Ms. Clay was read her response from the 2011 renewal cycle and it indicates that she was terminated from Harrison College for not meeting the demands of the position. The Board does not believe Ms. Clay is being forthcoming or truthful about the entire situation. A motion was made and seconded to place the license on probation for completion of 48 hours of continuing education in ethics and nursing leadership. She must also provide a report from a current employer regarding her work evaluation and give them a copy of her probationary order. The licensee agreed to these terms. Ms. Stevens did not appear for her personal appearance regarding her application for renewal. Her request is denied.
21. Jennifer Brown RN Renewal Positive Response*
Ms. Brown appeared for her personal appearance regarding her application for renewal. She appeared with attorney Sherry Fabina Abeny. She was working at clinic and some of her collaborative physicians were being investigated so she was investigated. She was writing for phetamine. She did not know she couldn't write for this. Her license will be Valid to Practice with a referral with the Attorney General's office.
22. Meghan Peffers RN Renewal Positive Response*
Ms. Peffers appeared for her personal appearance regarding her application for renewal. She appeared with her attorney Fred Viana (?). She was arrested for a DUI. She should be completed with her criminal probation next week. She needs to have an ISNAP evaluation. Her license is to be issued on probation for the length of her RMA. If she does not meet criteria for ISNAP she will be on probation for six months active practice with quarterly employer reports.

Ms. Ferringer appeared for her personal appearance regarding her application for renewal. She was with her Attorney John Crist. She received a DUI in January 2013. She is currently on criminal probation until April 2014. She had an accident. Noone was hurt in this accident. She is not drinking. She needs to have an ISNAP evaluation. She will be renewed on probation the length of her RMA or criminal probation whichever is longer.

Mr. Schlomer appeared for his personal appearance regarding his application for renewal. He downloaded skype on his computer at work and talked with friends. He has taken 2 different ethics course. He learnt that he always needs to keep his professional ethics on board. His license is to be renewed free and clear.

She is currently not working and has not worked since 2011. Her license is to be renewed on probation for one year active practice with quarterly reports. Ms. Ylanan appeared for her personal appearance regarding her application for renewal. She worked on expired license for 12 days. Her license status is to be Valid to Practice and referred to the Attorney General's office.
32. Cynthia Rupp RN Renewal Positive Response
Ms. Rupp appeared for her personal appearance regarding her application for renewal. She was terminated after a co-worker went to the nursing manger with concerns that she was not capable of doing her job. There was also an incident where her blood sugar dropped and they did a blood test on her that came back positive. She had taken vicidion extra strength and tyenol 3 the night before going to bed. She needs to have an ISNAP evaluation. Her license is to be renewed on probation for the length of her RMA. If she does not meet criteria for an RMA it will be on probation for a year of active practice with quarterly reports.
33. Lisa Johns RN Renewal Did Not Disclose
Ms. Johns appeared for her personal appearance regarding her application for renewal. She appeared with Attorney Lorie Brown. She did not disclose pending litigation. Her license is to be renewed on Valid to Practice pending outcome of current litigation.
34. Kori Babb RN Renewal Positive Response
Ms. Babb appeared for her personal appearance regarding her application for renewal. In July 2012, she had an OUI. She was on probation. She will be on non-reporting until August 2014. She was previously involved with ISNAP and successfully completed prior RMA. She was placed in monitoring basically to show she didn't have a problem. She no longer drinks. Her license is to be renewed on probation for 6 months active practice with quarterly reports.
35. Ryan Sitter RN Renewal Positive Response
Mr. Sitter appeared for his personal appearance regarding his application for renewal. In October 2012, he had an OWI. He doesn't remember blood alcohol level was probably over .2. He was by himself. He no longer drinks. He needs to have an ISNAP evaluation. His license is to be renewed free and clear.

She was terminated for no call no show the day after Thanksgiving, she looked at the wrong schedule. She has had some issues with passing medication. She has been terminated 3 times since 2011. Her license is to be renewed on probation until she completes 6 CEU hours in medication administration, documentation, pharmacology, and assessment. Also 4 hours of CEU in professionalism.
37. Amanda Moon RN Renewal Positive Response
Ms. Moon appeared for her personal appearance regarding her application for renewal. In 2012, she was charged with leaving the scene of an accident. She was not drinking. She was driving home, late at night. She fell asleep and hit a decorative pot. She called a friend to come and get her and she was going to call a tow truck after she got some sleep. When she woke up the cops were there. She was never in trouble before or since. Her license is to be renewed free and clear.
38. Kimberly Ayon RN Renewal Positive Response
Ms. Avon appeared for her personal appearance regarding her application for renewal. She was terminated. She was outside talking on her cell phone. She was consulting with her SDC, she went outside because she was going to talk about what the DON had been doing to her. The DON came out and asked her to clock out. She was engaged to someone else that worked there. He was in ISNAP. There was an investigation for missing drugs. Her husband was a part of this investigation. She was terminated for this. The 2nd time she was hired as MDS coordinator. The DON was not really showing her how to do her job. She was terminated because it was not

working out. It was a mutual agreement. Her license is to be renewed on probation for 6 months active practice with quarterly reports.

39. Brittany Stofel RN Renewal Positive Response

Ms. Stofel appeared for her personal appearance regarding her application for renewal. She was terminated for failure to document. She failed to document a wound care dressing and gave medication but failed to document it. She has never been in trouble before. She is currently working at Kindred. She has been there for over a year. Her license is to be renewed on probation for six months active practice with quarterly reports.

40. Cynthia Reid RN Renewal Positive Response

Ms. Reid appeared for her personal appearance regarding her application for renewal. In April 2012, she received an OWI. Her blood alcohol level was .16. She was drinking at home and decided to go to the camp ground for the weekend. She had other people in the car. She was arrested for another OWI this August. She needs to have an ISNAP evaluation. 
