**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of January 1, 2011, 572 active clients, 12 new intakes, 66 intakes in process, 31 closures in monitoring and 35 new Recovery Monitoring Agreements returned.

Mr. Lindquist addressed the attendees at the Board Meeting at the request of the Board President and described the nature of the ISNAP program, which provides monitoring and assessment / treatment referral services to nurses licensed in Indiana who meet the program's monitoring criteria.

## VI. DISCUSSION

### A. Update on Pending Legislation in the Indiana General Assembly.

Mr. Gorman presented an overview of language contained in Senate Bill 363 that would require all new licensees to submit to a criminal background check prior to initial licensure by endorsement or by examination. The background check process is expected to add an undetermined amount of time to the initial license approval process, particularly for applicants submitting paper fingerprint cards, that will then be outsourced by the Indiana State Police for digitization and then back to ISP for the actual background check process. Another potential implication for the criminal background check process as it is envisioned currently is that it would prohibit temporary licensure prior to the background check results return, which may be the time limiting factor for full licensure eligibility and would remedy the temporary licensure process useless in affected situations.

The Board noted that elections for Board officer positions were not conducted in January due to a lack of quorum. Following discussion a motion was made and seconded to retain the current officers: Mr. Burghduff as Board President, Ms. Narwold as Board Vice-President, and Ms. McIntosh as Board Secretary.

### B. Angela Biddings Order: - wording disputed by licensee.

Ms. Biddings submitted a request to the Board regarding the Order issued by the Board placing her license on a probationary status. The wording at issue involved the fact that she was arrested on a felony welfare fraud charge, but she signed a plea agreement that resulted in a misdemeanor conversion conviction. Mr. White will review the case file and Board Order for accuracy and modify if necessary.

## VII. BOARD DIRECTOR REPORT

Mr. Gorman presented to the Board for their consideration the potential issue of Board wording ording a specific behavioral diagnostic tool as a condition in a Board Order. A recent situation involving a nurse ordered as such occurred where the psychologist felt that a diagnostic assessment tool other than the ordered MMPI-2 was more appropriate and would result in an assessment report that would be more useful for the purposes of determining safety to practice. Mr.

Gorman suggested that in future cases, the specific diagnostic tool used be left to the discretion of the attending psychologist as long as it can most effectively speak to the nurse's ability to practice safely.

Annual report forms for Indiana nursing programs are available in electronic form on the Board's website. Reports will be due by April 1, 2011. At the April Board meeting, the Board will be presented with the adjusted pass rate and be asked to vote on the 2010 adjusted pass rate as well as the individual school pass rates.




