If renewing to "Inactive" status, you do not need to complete the required CPE. However, while in inactive status, you may not use the title "public accountant," or "accounting practitioner" or the abbreviation "PA," or "AP" unless it is immediately followed by the word "inactive". To reactivate the certificate, you must file an application for reactivation and submit evidence of the completion of 120 CPE hours obtained within the previous 3 years.
