Make check or money order payable to 'Indiana Professional Licensing Agency'. If this document is postmarked after June 30, 2018 you must include a \$50 late fee. If you answer 'Yes' to any question below send a detailed statement regarding the response with your renewal form.

**\*Status Change:** If you wish to discontinue the practice of accountancy, you may select "Inactive" or "Retired" status on the renewal form. If renewing to "Inactive" or "Retired" status, you do not need to complete the required CPE. However, while in inactive or retired status, you may not use the title "certified public accountant" or the abbreviation "CPA" unless it is immediately followed by the word "inactive" or "retired", designating the licensee's selected status. To reactivate the certificate, you must file an application for reactivation and submit evidence of the completion of 120 CPE hours obtained within the previous 3 years.
