- (1) Limited Criminal Background Check for the 4 preceding years or duration. The background checks must be completed at the state level. Third party background checks will not be accepted.
- (2) Certificate of insurance or other "evidence of financial responsibility" detailing limited liability insurance with a minimum of \$100,000 and meets board requirements. If insurance is due to expire prior to license expiration (10/1/19) a certificate detailing the next policy coverage period must be submitted.
