To renew by mail, send this form with the renewal fee of \$70.00 to the address above, allowing 4 weeks for processing. Make check or money order payable to "Indiana Professional Licensing Agency". If postmarked after the license expiration date, you must include a \$50 late fee. If you answer 'Yes' to questions 1-3 below please send a detailed explanation along with the form.
