II. ADOPTION OF THE AGENDA

III. ADOPTION OF THE MINUTES FROM THE DECEMBER 11, 2014 MEETING OF THE BOARD

A motion was made and seconded to adopt the minutes of the December 11, 2014 Board meeting. Laux/Cooper, 7-0-1, motion carries (Presley abstains)

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Lindquist appeared on behalf of ISNAP. Over the last six months ISNAP has been meeting with representatives from the Parkdale Center which aims to provide a consistent network for counseling and nurse support groups. ISNAP believes these services will strengthen nurse accountability. It is their hope to have access to these services in place by mid-March 2015.

V. EDUCATION

A. St. Elizabeth School of Nursing Quarterly Report (Deacon John Jezierski)

Staff appeared from St. Elizabeth's. Staff reported they are modifying and monitoring student progression in standardized testing and looking at policies in grading (raised passing standard from 75% to 80%). The indication is that although they have students that are not successful and are on probation, overall student honors percentages increased from last fall with similar student populations from the Fall 2013 to Fall 2014 academic years. They have implemented a mandatory TEAS 5 to begin in the Fall 2015 admission cohort. Staff also reported they are in the process of curriculum revision and are working with a consultant on the curriculum revision. In Fall 2014, they also implemented an NCLEX review course for the graduating cohort as well as using that data to determine what students still need to demonstrate continued structure review. They are utilizing ATI at this time. Of the 23 students in the December 2014 cohort, 16 have the green light and 7 are in progress with weekly progress reports. Ms. Cooper felt the ATI breakdown submitted by the program was appreciated and easy to read. The staff understands that they have three additional quarters to move their NCLEX scores above 80% or additional action may occur by the Board. The program will be seen again by the full Board in April 2015.

B. ITT Tech Merrillville Quarterly Report (Daniel Faretta)
ITT Tech South Bend Quarterly Report (Linda Newton)
ITT Tech Indianapolis Monthly Report (Marie Holder)

Staff from all ITT campuses appeared along with Mr. Hamm. Mr. Faretta has implemented a live HESI review at the Merrillville campus and preceptorship before graduation for clinicals. Feedback has been that nurses don't understand what a nurse does when

they come out of school. In their recent clinical setting, students have been assigned a nurse from the beginning to the end of a shift. Dr. McIntosh indicated that good schools of nursing have been doing this for years and this is how it should have been done previously. Merrillville has hired a person who works with "flipping the classroom." Dr. McIntosh indicated they need to be cautious because the programs are giving autonomy to students who may not be at that point yet. Ms. Cooper asked about pass rates and is concerned across the Board for all programs. Merrillville reported an unofficial pass rate of 46% and Indianapolis reported an unofficial pass rate of 66% at this time. Indianapolis campus has not admitted students since June 2014 due to Board action. Merrillville campus reported to looking to admit students in March 2015 and admitted 27 new students in December 2014. Their maximum admission is 30 students. Ms. Cooper expressed concern that Merrillville is still taking in new students. Ms. Cooper wants an accounting of their December 2014 graduating classes and their pass rates in their next Board reports. Ms. Hall indicated with the results before them today this is their fifth year in a row with pass rates below standard. Mr. Hamm indicates he shares and understands the significance of where the campuses are with their NCLEX scores. He indicates they need additional time for their campuses to improve. He indicates the results are embarrassing and they are trying to make changes to their campuses. The school understands it is their responsibility to have high NCLEX scores. Ms. Ogle indicates that she wants to make sure consumers are protected and they are not admitting students who cannot pass the NCLEX. Mr. Hamm indicated that the number of students being admitted is not his concern, but that his concern is for overall quality of the program. **Board Action: A motion was made and seconded to suspend admissions for all ITT campuses at this time. This step will be reviewed in June 2015 for Indianapolis campus and September 2015 for Merrillville and South Bend campuses. Site visits will occur prior to Board reviews in June 2015 (Indianapolis) and September 2015 (Merrillville and South Bend). Cooper/Narwold, 7-0-0, motion carries**

C. MJS Monthly Report

No representatives were here from MJS to present their monthly report.

D. V.R. Ashwood Site Visit Report (Dr. Nellie Smith)

The site visit report was presented by Toni Herron. Staff appeared from V.R. Ashwood. Their LPN program was originally approved for initial accreditation in June 2011. The unannounced site visit was due to relocation of the school due to flooding of their original site. They have had no NCLEX testers to date. There were significant problems with communication and getting in touch with the school. They have two cohorts at this time of 9 students each with the first set to finish in September 2014. Ms. Cooper asked about September 2014 graduates and Ms. Smith reported that the eight (8) students who were set to graduate made a decision to join the upcoming graduating class in mid-February 2015 or early March 2015 as several had not completed 96 hours described by Ms. Smith as an internship/clinical experience/capstone. Ms. Cooper indicated concerns about students who have completed coursework and the lag time of nearly six months in taking the NCLEX examination. Ms. Smith reported that students finished didactic work around September 25, 2014. From October to December these students were preparing for NCLEX. Ms. Smith reported that these students completed the 96 hours of capstone as of November 7, 2014. Dr. McIntosh indicates struggle with this because didactic and clinical were not completed together and there is a significant amount of time between finishing coursework and NCLEX. Dr. McIntosh also indicates it is in the rules that these experiences need to be paired together and that does not appear to be happening. The Board also expressed concern about students being able to vote on their own graduation date. When asked, Ms. Smith reported that these eight (8) students were admitted into the program on July 29, 2013. Staff indicates they had no students enrolled from 2011 to 2013. The length of the LPN program is reported as 48 weeks. Board members are concerned about public safety and having delays putting students at risk for not passing the licensure boards. Ms. Smith reported the program is looking at admitting eight (8) new students into the program in June or August 2015. Their admission criteria include TABE testing on 10th grade math and 9th grade reading. The Board members indicate they have never heard of TABE testing being used as admission criteria. The Board does not think that students should be voting on their curriculum and progression dates. Ms. Hall indicates they need to have clear admission standards, criteria and their graduation requirements. The Board would like another site visit before their next appearance with the Board. **Board Action: A motion was made and seconded to suspend admissions at this time. McIntosh/Cooper, 7-0-0, motion carries**

E. University of St. Francis-Crown Point Site Visit Report (Dr. Marsha King, Margaret DeYoung, Dr. Andrew Prall)

Staff appeared from USF. Ms. Herron indicated this visit was prompted from low NCLEX scores since their first admissions in 2011. They have an ASN program and an LPN to ASN bridge program. The curriculum is consistent with the Fort Wayne campus. They changed locations in January 2011. **Board Action: A plan of correction must be submitted within one month. The program will return to the Board at the February 19, 2015 meeting to present their plan of correction. McIntosh/Narwold, 7-0-0, motion carries**

F. Medtech All Campuses Monthly Report

Staff from Medtech appeared along with Counsel Myra Selby. Unofficial NCLEX scores are currently being reported for 2014 as: Fort Wayne: RN 54.7%, PN 84.3%; Greenwood: RN 34.5%, PN 74%; Indianapolis RN 51.3% and PN 74.4%. Monica Baugh left as faculty development specialist effective 12/31/15. Ms. Horhoro (Fort Wayne Director) indicated that at present they are going to look within the company to fill this position and that their Regional Vice President of Nursing will be helping to fill this position as well. A pre-hearing conference will be held in this matter prior to the February 19, 2015 Board meeting.

A. Appearances by Applicants for Licensure

- 1. **Oluwaseun Popoola** **LPN Exam** **CBC Hit/ Positive Response**
Oluwaseun Popoola appeared for a personal appearance on January 15, 2015. Ms. Popoola applied for licensure as an LPN by examination. She answered "yes" to questions 3 and 4 on her application for theft in October of 2013 and for two terminations. She was arrested for stealing clothing to help pay for school. She is currently not on criminal probation. Ms. Popoola also addressed two terminations by her employers. In 2011, she was accused of patient abuse at Brookdale Senior Living and she was terminated. No charges were filed. While working at Allisonwood Meadows, she failed to notify her staff that she was taking a break. Her supervisor thought she was not working while on the clock and she terminated. Ms. Laux recommends that she is eligible to sit for the exam. Upon successful passage, the license will be issued on indefinite probation for a minimum of 1 year. She must complete 40 hours of continuing education: 20 in Patient Safety and 20 in Professional Ethics.
- 2. **Brandon Goetzke** **RN Exam** **Grad Date of December 2010**
Brandon Goetzke appeared for a personal appearance on January 15, 2015. Mr. Goetzke applied for an RN license by examination. He has failed the NCLEX exam twice. He is currently taking an NCLEX review course and he would also like to take the Kaplan course. Board Ms. Laux recommends that he submit a letter from one of the courses that show he has a 95% personal probability of passing the NCLEX. His license may be issued free and clear upon passing the exam.
- 3. **Brian Wilkins** **RN Exam** **CBC Hit/ Positive Response**
Brian Wilkins appeared for a personal appearance on January 15, 2015. Mr. Wilkins applied for an RN license by examination. He answered yes to question #3 on his application regarding an arrest. In 2012 he reports an altercation occurred between him, his fiancé, and an ex-girlfriend. They were at a bar and a fight broke out. He swung a punch at a group of people. He was arrested for aggravated battery. When he was 17 years old, he was driving with his friends. One of the friends had crack cocaine. Since the drugs were in his vehicle, he was arrested. Ms. Laux recommends that he is evaluated by ISNAP and that his license is issued on indefinite probation upon passing his exam. His license shall remain on indefinite probation for no less than six months of active practice or the length of his RMA if eligible, whichever is longer.
- 4. **Jamie McKittrick** **RN Endo** **CBC Hit**
Jamie McKittrick appeared for a Personal Appearance January 15, 2015. Ms. McKittrick applied for an RN license by Endorsement from Kentucky. She checked "No" to the questions on her application. Three records appeared on her Criminal Background Check. On November 6, 2014 she was at Kohl's in Franklin, Indiana. She received a phone call and was distracted. She left the store with \$500.00 worth of unpaid items. She has not been to court yet and criminal charges are pending. She has been seeing a psychologist and she has volunteering at a church. She was also charged for driving while suspended. She received three tickets within three days. She reports that the speed sensor had gone out in her car. She bought and replaced the part. She went to court and the charges were dismissed. She charged with check deception for bouncing a \$15.00 check. The prosecutor's office offered her to pay the \$15.00 but she did not have the money at the time. Ms. Laux recommends that Ms. McKittrick is placed on indefinite probation with a minimum of 1 year active nursing practice, or successful completion of criminal probation,

whichever is longer. She must submit a minimum of 4 quarterly employer reports to the Board. She must complete 40 hours of continuing education: 20 hours in Professionalism and 20 hours in Ethics.

- 5. Gwendolyn Farrow** **RN Exam** **Grad Date of Aug 2002**
Gwendolyn Farrow appeared for a personal appearance on January 15, 2015. Ms. Farrow applied as an RN by examination. She graduated in August of 2002. She was diagnosed with breast cancer and she was raising her children. She has been working as an LPN in long term care. She has taken the exam three times and failed. She just signed up for the Kaplan refresher course. Ms. Laux recommends that she submits a letter from Kaplan that she has a 95% personal probability of passing before she can take the exam.
- 6. Yolondia Barksdale** **RN Exam** **Four Failed Attempts**
Yolondia Barksdale appeared for a Personal Appearance January 15, 2015. She applied for an RN license by Examination. She failed the exam four times. She completed the Kaplan refresher course in October. She admits that she had test anxiety and that she has been seeing a psychologist. Ms. Laux recommends that she sit for the exam but if she does not pass this time, she must go back to nursing school.
- 7. Faith Gavros** **RN Exam** **CBC Hit/ Positive Response**
Faith Gavros appeared for a Personal Appearance on January 15, 2015. Ms. Gavros applied for a RN license by examination. She answered "yes" to questions 3 and 4 on the application for theft and for a termination. In December of 2014, she stole \$500.00 of cash from a coworker. At the time she was going through financial struggles and was trying to support her children while going to school. She paid back the money and \$1000 in restitution. She is currently on criminal probation until September of 2015 and is in counseling. Ms. Laux recommends that Ms. Gavro's license be issued on indefinite probation for the length of her criminal probation upon passing the NCLEX exam. She must complete 20 hours of continuing education in professional ethics.
- 8. Bridgett Evans** **RN Endo** **CBC Hit/ Positive Response**
Bridgett Evans appeared for a Personal Appearance January 15, 2015. Ms. Evans applied for an RN license by Endorsement. She answered yes to questions 3, 4, and 6 on her application. She is licensed in Kentucky and Florida. In 2002 she was arrested in Florida for a DUI. She refused a breathalyzer. In 2005 she had multiple surgeries and became addicted to pain medication. She enrolled in the KARE program for addiction in Kentucky. In 2010 she relapsed. She is scheduled to complete the KARE program in December 2015. Ms. Laux recommends that Ms. Evans signs an out of state agreement with ISNAP and that her license is issued on indefinite probation for the length of her ISNAP/KARE RMA.
- 9. Wendy Bentley** **RN Exam** **Positive Response**
Wendy Bentley appeared for a Personal Appearance January 15, 2015. Ms. Bentley applied for an RN license by Examination. She answered "yes" to question 3 on her application for a class C misdemeanor for driving on an expired vehicle registration and failure to provide proof of insurance. She stated that she did have car insurance but she was not carrying the insurance card. The insurance company was unable to verify her policy at the time. The traffic violations have been paid and she is currently insured. Ms. Laux recommends that the license be issued free and clear upon passing the NCLEX exam.
- 10. Teresa Leckrone** **RN Exam** **CBC Hit/ Positive Response**
Teresa Leckrone appeared for a Personal Appearance on January 15, 2015. Ms. Leckrone applied for an RN license by examination. She answered "yes" to question 3 on her application and reports an arrest for Operating a Vehicle While Intoxicated. In March 2013 she went to a bar and had several drinks. She got in her car to drive home and dozed off. She drove into a corn field. She was arrested for an OWI with a blood alcohol of 0.19. She had previously been in contact with ISNAP. Ms. Laux recommends that Ms. Leckrone has a second evaluation done with ISNAP. She may take the NCLEX exam but her license cannot be issued until the evaluation is received. If she is a candidate for an RMA, she will be issued on indefinite probation for the length of the RMA. If she is not a candidate, then the license may be issued free and clear.
- 11. Alyssa Ubelhor** **RN Exam** **Positive Response**
Alyssa Ubelhor appeared for a Personal Appearance on January 15, 2015. Ms. Ubelhor applied for an RN license by Examination. She answered yes to question 3 on her application. In March of 2012, she was ticketed for underage drinking. She was in nursing school at the time. This was a first time incident. The charges were deferred. Her criminal background check is clear. Ms. Laux recommends that her license is issued free and clear upon passing the NCLEX exam.
- 12. Kelsey Baker** **RN Exam** **CBC Hit**
Kelsey Baker appeared on January 15, 2015. Ms. Baker applied for an RN license by Examination. She answered no to the positive response questions on her application. In January 2012, she had been drinking and there was a conflict between her and her dorm roommate. The police were called and she took a breathalyzer. She had a .10 blood alcohol level. She was arrested. Ms. Laux recommends that she take the NCLEX exam but she must complete 40 hours in continuing education, with 20 in Ethics and 20 in professionalism. She must submit the continuing education before she can be licensed.
- 13. Joshua Ramirez** **RN Exam** **Four Failed Attempts***

Joshua Ramirez appeared for a personal appearance on January 15, 2015. Mr. Ramirez applied for RN license by Examination. He has taken and failed the NCLEX exam four times. He took the Kaplan course but it was unsuccessful. Ms. Laux recommends that he take a virtual ATI course. When he receives confirmation from ATI that he is eligible to pass, he must take the exam within 6 weeks.

14. Sharnita Sharkey

LPN Exam

CBC Hit/ Positive Response

Sharnita Sharkey appeared for a personal appearance on January 15, 2015. Ms. Sharkey applied for an LPN license by examination. She answered yes to questions 3 and 6. She submitted documents from her current supervisor Catherine Smith, LPN. In 2009 she failed to appear in court for a driving violation and her driver's license was suspended. She was arrested for driving on a suspended license. When they searched her car, there was an open alcohol bottle, that charge was dismissed. In November 2013, she was arrested for a DUI. She was the designated driver and she was pulled over. She took the sobriety test but did not do a breathalyzer. She pled guilty to the charges. In March 2014, she was staying with a friend to carpool. She woke up and started the car. A police officer approached her and questioned why she had started the car when she has a suspended license. The police officer saw she had a DUI in her record and asked her for a breathalyzer. She refused so he arrested her. She is currently on criminal probation for her DUI and is attending classes. She will remain on criminal probation until she completes the classes. Ms. Laux recommends that Ms. Sharkey receive an evaluation by ISNAP and that she is to be issued on indefinite probation for the length of her criminal probation or a RMA, whichever is longer.

15. Karie Velasquez

RN Exam

CBC Hit/ Positive Response

Karie Velasquez appeared for a Personal Appearance on January 15, 2015. She applied for a RN license by Examination. She answered yes to question 3 on her application for charges including: operating a vehicle while intoxicated and driving while suspended, disorderly conduct and trespassing. In October 2003 she received an OWI and was placed on criminal probation that she fulfilled. In April 2004, she had been driving to work on a suspended license and someone reported her. She found out that she had a warrant out for her arrest because she had violated her criminal probation and she turned herself in. In August 2004 she entered a pre-trial diversion for a disorderly conduct. She, her brother, and a friend were at her house. Her brother sold his car to the friend. The friend had been driving recklessly around the neighborhood and the police were called. The car was at her house and when the police arrived, she and her friend were fighting. There was slight bodily harm. The police arrested Ms. Velasquez and the friend. In March 2014, she was arrested for an OWI. Her blood alcohol level was .20 and she was by herself in the car. She stopped to get gas and someone reported her. She was placed in home detention for 5 months. In September 2014, she moved and was renting a room with someone to be closer to school. The arrangement did not work out and that person called the police. She was charged for trespassing because she could not provide any documentation or a lease showing that she lived there. She is in a pre-trial diversion for this case until October 2015. Ms. Laux recommends that Ms. Velasquez receives an evaluation by ISNAP and that she is issued on indefinite probation for the length of her pending criminal case or a RMA, whichever is longer. She must also complete 40 hours of continuing education: 20 hours in Professionalism and 20 hours in Ethics and submit quarterly employer reports to the Board.

16. Lenora Graye

LPN Exam

Positive Response

Lenora Graye appeared for a Personal Appearance on January 15, 2015. Ms. Graye applied for an LPN license by Examination. She answered yes to questions 3 and 4 on her application for an arrest 4 years ago and 3 employer terminations. In 2007 she was terminated from Belhaven Nursing and Rehabilitation in Jackson Mississippi. She had fallen asleep on the job. In 2009 she was terminated from South Suburban Nursing and Rehabilitation Center in Homewood, Illinois. The company had switched to a new charting system. She had fallen behind on charting. The system locked her out and she asked her supervisor to log her back in. Since they recently had a meeting regarding charting, she was terminated for being insubordinate. In 2013 she was terminated from Children's Rehabilitation in Harvey, Illinois. She took hospital leave and did not return on time. She failed to submit the FMLA forms to extend her leave and she was terminated. Four years ago, she could not recall the exact day, she was staying at a friend's apartment. The apartment was raided by the police for drugs. They arrested and questioned her but no charges were filed. Ms. Laux recommends that Ms. Graye's license is issued on indefinite probation with a minimum of six months of active practice. She must submit a minimum of two quarterly employer reports to the Board.

17. Alfredo Sanchez

RN Exam

CBC Hit/ Positive Response

Alfredo Sanchez appeared for a Personal Appearance on January 15, 2015. Mr. Sanchez applied for an RN license by examination. He answered yes to question 3 on his application for Reckless Driving, Possession of Paraphernalia, Operating a Vehicle While Intoxicated, Resisting Law Enforcement, Battery, Mischief, and Public Intoxication from 2005-2009. In July 2005, he was driving erratically and was cited for reckless driving. In March 2006, he was riding in a car with a friend. He was not aware his friend possessed paraphernalia. They were pulled over and they were arrested. In December 2006, he was celebrating his high school graduation and had been drinking. He got in his car and drove intoxicated. He was pulled over and fled from the police. In September 2009, he was out with his friends and he had a verbal altercation with a patron that became physical. He was not the aggressor. The charges were dismissed. In December 2009, he was with friends and the police were called for due to a noise complaint. There were others at the home that were drinking and underage. He left the party before the police arrived. He was arrested for resisting law enforcement and public intoxication. Ms. Laux recommends that Mr. Sanchez receive an evaluation by ISNAP. If he is a candidate, he will be issued on indefinite probation for the length of a RMA. If he is not a candidate, he may be issued free and clear.

18. Taylor Morken **RN Exam** **Positive Response**
Taylor Morken appeared for a Personal Appearance on January 15, 2015. She provided documents for review. Ms. Morken answered yes to question 3 on her application for two charges for underage drinking. In 2011 she was attending a concert and was drinking. She was seen holding a beer. She was only 19 years old. In 2012, she was a passenger in a vehicle. There were four people in the back and they were not wearing their seat belts. They were pulled over by a police officer and everyone took a breathalyzer and her blood alcohol was .10. She was arrested for underage drinking. She had to do community service. She continues to do volunteer work at the places she did community services at. She currently works in the emergency room. Ms. Laux recommends that Ms. Morken receive an evaluation from ISNAP. If she is a candidate, she will be placed on indefinite probation for the length of the RMA. If not a candidate, the license may be issued free and clear.

19. Thomas Schmania **RN Endo** **Positive Response***
Thomas Schmania appeared for a Personal Appearance on January 15, 2015. His counsel was present. Mr. Schmania applied for an RN license by Endorsement. He has an active license in Michigan. He answered yes to questions 4 and 5 for a medication error, termination and malpractice. In January of 2014, Mr. Schmania was doing a colonoscopy. The patient had a history of heart disease. He gave the patient propofol to decrease the patient's blood pressure. The heart rate dropped so he gave the patient Ephedrine to bring it back up. The patient's heart rate went up to 140. He was asked by HR if he had called for the Anesthesiologist at this time. When the Anesthesiologist arrived, he ordered Metoprolol. Mr. Schmania picked up the wrong medication and gave the patient Labetalol. The patient's heart rate dropped. The patient was taken to the recovery room and discharged the next day. He was terminated from his position for medication error. He has had a malpractice judgment in the past but he is currently insurable. His National Practitioner Databank is clear. He would like to continue working in Anesthesiology in Indiana. Ms. Laux recommends that Mr. Schmania brings his case to the Full Board to review. Mr. Schmania appeared for the full Board along with Counsel Latonya Denise Wright. Mr. Schmania appeared regarding his positive response. He provided letters of recommendation from his positions. He also provided continuing education and his current work evaluation. The recommendation was to allow endorsement free and clear. Smith/Laux, 7-1-0, motion carries (Ogle against)

20. David Witcher **RN Exam** **CBC Hit/ Positive Response**
David Witcher appeared for a Personal Appearance on January 15, 2015. Mr. Witcher applied for an RN license by examination. 



Patricia Gibson appeared on behalf of the State of Indiana. Respondent appeared in person and waived the right to counsel. After a hearing, ALJ Hall recommended that the probation be withdrawn in this matter.

There being no further business, and having completed its duties, the meeting of the Indiana State Board of Nursing adjourned at 7:35 p.m.
