**I. CALL TO ORDER & ESTABLISHMENT OF QUORUM**

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT**

Ernie Klein, ISNAP Executive Director, appeared before the Board and informed them that ISNAP signed a one year contract that is valid through July 31, 2008. Mr. Klein informed the Board that the money presented in the contract will run out prior to the end of the contract. Mr. Klein suggested that the Board and IPLA staff meet to come up with solutions to the shortage of money to run the program. Mr. Klein also welcomed the Board members to visit the ISNAP facility at any time.

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of June 2007, 468 active clients, 22 new intakes, 44 intakes in process and 15 RMA's returned.

Mr. Lindquist stated that the second quarterly newsletter has been printed and mailed. ISNAP met June 18, 2007 to review those who have applied for the "Needs Assistance Fund." Mr. Lindquist informed the Board that ISNAP has increased the number of vouchers available to applicants who qualify from 1/3 to 1/2 of the scheduled urine drug screens that ISNAP will pay for. In addition, Mr. Lindquist informed the Board that the nurse is eligible to re-apply every three months.

Mr. Lindquist informed the Board that ISNAP is planning their fall conference for September 21, 2007. Mr. Lindquist also stated that ISNAP has \$6,000 dollars committed in sponsorships.

Mr. Lindquist addressed the audience as requested by the Board.

## V. EDUCATION

### 1. Huntington University – BSN Initial Accreditation Site Visit

Margaret Winter and Pat Pierce appeared before the Board regarding the site visit conducted by Laurie Peters, Vice-President and Susan Dye, Board Member, on June 25, 2007. Ms. Peters informed the Board that they currently do not have a secretary. The admissions policy is non-specific and the Board asked them for clarification. The Board also requested clarification of their curriculum. Ms. Winter informed the Board that they do have some books on file for the library and they do have a designated library space. Ms. Winter also informed the Board that they currently have seven students registered and twelve for the first intake.

### 2. ITT Tech – Report of Survey Visit

Marilyn Chestnut, Karen Larson and Louise Hart appeared before the Board regarding the site visit conducted by Paulette Worcestor, State Surveyor on June 25, 2007. Ms. Hart informed the Board that they will be admitting thirty students per quarter. They also informed the Board that they have contracts established with various health systems and hospitals.

### 3. Ball State University – Change in Nursing Credit Hours

The Board reviewed documentation they received from Nancy Dillard at Ball State University regarding a change in their nursing credit hours between two nursing courses. Ms. Dillard explained that the change would not affect the total nursing credit hours for the student's degree. She further explained that the intent of the change is to enable students to utilize clinical time more effectively for nursing practice. They are decreasing the NUR 230/230L from four credit hours to three credit hours and increasing NUR 404/404L from three credit hours to four credit hours.

The Board reviewed this information as an FYI.

#### 1. Brandi Stone

Ms. Stone appeared before the Board regarding the positive response on her application for licensure by examination. Further, prior to petitioning for reinstatement, Respondent must submit a psychology evaluation and twelve contact hours of anger management.
