**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT**

Donna Goch, Program Director, presented the monthly report to the Board. Ms. Goch reported that there were 394 participants involved in ISNAP during the fourth quarter. Of those participants, 26 intakes were initiated, 26 RMA's were signed, 64 participants were discharged and approximately 32 relapses occurred. Ms. Goch stated that there are 191 nurses who identified alcohol as their drug of choice, and that hospital settings remain the primary source of employment. Ms. Goch informed the Board of the three primary sources of referrals. She explained that 81 nurses were referred to ISNAP by the Indiana Attorney General's Office, 67 nurses were self referred, and 55 nurses were referred by the Board. Upon request of the Board, Ms. Goch, explained the ISNAP program to the nursing students present in the audience.
