**I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM**

**8:30 a.m.**

Dr. McIntosh, President of the Indiana State Board of Nursing, called the meeting to order at 8:30 a.m. and established a quorum in accordance with IC § 25-23-1-5(b).

**II. ADOPTION OF THE AGENDA**

A motion was made and seconded to adopt the agenda as amended. Laux/Ogle, 8-0-0, motion carries

**III. ADOPTION OF THE MINUTES FROM THE JUNE 19, 2014 MEETING OF THE BOARD**

A motion was made and seconded to adopt the minutes from the June 19, 2014 board meeting. Cooper/Presley, 5-0-3, motion carries (Smith/McIntosh/Laux abstain)

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Mr. Lindquist presented on behalf of ISNAP. He gave the Board a reminder on the ISNAP conference in September 2014. ISNAP is in contact with their vendor and has started the process of creating the professional video with the goal of presenting the full video with goals and mission, how to contact ISNAP, ISNAP's role with the BON and OAG at the September conference. Ms. Ogle asked about where ISNAP is with redoing the computer infrastructure and hardware and Mr. Lindquist indicated that the system is working well with quarterly employer reports being sent online through the Affinity system and working well. Ms. Ogle asked if they will use technology when they come to the meeting and Mr. Lindquist indicated that he can. Mr. Lindquist then addressed the audience.

**V. EDUCATION**

**A. MJS College of Nursing Curriculum Changes (Annette Murray)**

Staff appeared from MJS College. They have been open for three years and have had 4 cohorts graduate. They placed pharmacology in the theory/alternative health classes in their initial presentation of curriculum. The staff found upon assessment that students are deficient in pharmacology. They utilize ATI for the exit exam and range for pharmacology was deficient. They would like to add in a separate pharmacology class to support their students. Ms. Narwold asked about their setup and the program is a 15 month accelerated program with seven terms consisting of 36 credits. They are not deleting any credit hours. Pharmacology will be in Term 2 if accepted by the Board. Ms. Hall asked when clinicals occur and clinicals begin in Term 2 as well. Other changes include changing the first term from three days a week to four days a week. They would also like to add in a pre-requisite course for study skills. Ms. Cooper asked about their 2013 and 2014 NCLEX scores and how many students they admit into their program. They only take a small number of students in each cohort and are capped at 10 students. Ms. Ogle asked if they have feedback from the students on these changes and staff indicated students enjoy the four day a week system. Students are not happy about a separate pharmacology class but staff feels it will benefit them in the long run. The last change is to go from an 8 week term to a 9

week term. Ms. Cooper asked if this is for new cohorts or a change in the entire system with existing cohorts and they would like the entire Nursing program to change to 9 weeks. Ms. Cooper indicated that students need to be notified and staff indicated students have been polled regarding this. They also have a student council that has 1 or 2 students from every cohort. Ms. Laux asked about the % on ATI and staff requires a passing % on practice exam that varies. Every term the % increases ranging from 58 to 80%. Students must have an 80% on proctored exams and Ms. Laux cautioned that students on proctored exams need to have a Level 2 on proctored exam before graduation. Ms. Laux indicated that practice exams can be repeated and students should be obtaining 100% before moving on. Ms. Hall indicated the important part of the practice exam for ATI is remediation as well so that students are not just memorizing test questions. **Board Action: A motion was made and seconded to grant the requested curriculum change and schedule changes. Narwold/Cooper, 8-0-0, motion carries**

#### **B. Fortis College Site Visit Report (Kathy Plankenhorn)**

Ms. Herron presented the site visit report on Fortis College. Staff from Fortis College appeared as well. Fortis was visited in May 2014 prompted by declining NCLEX scores 2013- 60% and Q12014 was 50%. Initial accreditation was granted in 2010 and they received ACEN accreditation this year. They have adjusted course sequencing and students complete 100 NCLEX questions per week with the HESI given at each course. Failure of courses requires immediate remediation. Students can retake up to 2 nursing courses but failure of 2 nursing courses results in dismissal from the program. Students were interviewed and positive about their experiences, small class size and faculty with an open door policy. Students enjoy their clinical experiences despite having to travel some distance for some of them. Faculty acknowledged immediately that they have NCLEX issues and are working on them. HESI and Kaplan review are required for graduation with access to the NCSBN question banks funded by the school. They have the ability to revise curriculum at a local level which is critical. Faculty has a dedicated simulation coordinator who is doing well.

Staff indicated they have recognized that they need to be proactive with their NCLEX and provide NCSBN five week study plan at their cost. They have a three day virtual review for their students as well in the last month. They have 17 students currently pending to take the NCLEX. They have small class sizes as well and acknowledge that. Ms. Cooper asked their pass rates for 2014 they are at 50% with 14 testers and 17 that need to test. They have 94 students in the current classes. Ms. Hall asked if the bridge students are passing and they are it is the more traditional student that is not passing the NCLEX. Ms. Cooper asked if they have increased enrollment. Staff indicated they take students every 12 weeks and they take 20-30 students in per quarter. Ms. Laux asked about the attrition rate and since January 2014 they have had 59 students start the program with 9 leaving this year, 6 of those being academic failures with an approximately 85% attrition rate. A few have left due to life changes or jobs. Ms. Laux asked what they are doing to improve clinical sites. Staff indicated they are in negotiation for St. Vincent Carmel which will provide them with a new site. Ms. Laux indicated students also need access to CINAHL. Ms. Cooper indicated that there will need to be a significant number pass to bring them up to 80% pass rate and that they need to review their number of admissions and admission practices in relation to NCLEX scores. Staff indicated they are working on test rigor and curriculum rigor and working with an individual who does test analysis and providing professional development to their faculty. This start they had 28 students and this is likely related to ACEN approval. 2013 total enrollment was 6, 8 or 15 students per quarter. Their typical class size is 6 to 10 students. **Board Action: A motion was made and seconded to produce a corrective action plan related to the NCLEX. The campus will need to come back to present the corrective action plan and updates on improved item writing and resources. McIntosh/Laux, 8-0-0, motion carries**

**A motion was then made and seconded to formally approve the LPN to RN bridge program. McIntosh/Presley, 8-0-0, motion carries**

#### **C. Everest College Transition Plan (Tracy Miller and Patricia Jones)**

Staff appeared from Everest College and they are one of 12 campuses being closed by their parent company Corinthian. They are developing a teach out plan with a target date of closure of the campus in April 2015. They currently have 150 Nursing students but all of them will not finish by April 2015. Students in the RN Associate degree program that started in April 2014 will not finish. They are in contact with ITT Merrillville to try to do an articulation agreement and if they finish this term by September 5, 2014 they will all be able to transfer to ITT in Quarter 3.

Dr. McIntosh asked when they knew the school was closing and staff indicate they were notified last week. Their last admission date was April 2014 for the RN Program and May 2014 for the PN Program. Dr. McIntosh asked how many students will not finish and staff indicated that 14 RN students will not be able to complete. Ninety PN students will graduate if they complete the plan with no failures or life changes, etc. Ms. Cooper asked if there is a plan for the 90 PN day students and there is no plan for them if they fail. Dr. McIntosh asked about the articulation agreement with ITT Merrillville and whether they are notifying students about the subpar NCLEX pass rates for the last two years. Staff acknowledged knowing about ITT's pass rates. Dr. McIntosh asked about the option of PN's admitted in April and May

2014 and giving them their money back with a stipend for finding other Nursing programs. Staff then indicated for the PN Nursing program students 24 PN evening students that will not be able to finish the program before it closes. This was not been disclosed upon the first questioning by the Board. What have the students been told? Staff started yesterday sitting down with individual students and explaining what will happen. Dr. McIntosh asked what assistance the parent company has given and staff indicated they have regularly scheduled calls with schools that are closing. Dr. McIntosh asked how staff is going to be retained. They currently have 10 full time and 7 adjunct faculty members. Out of the 10 faculty all were given a retention package offer and an incentive to stay. Ms. Narwold asked if there is anything in the plan to address students who have not been successful in NCLEX and staff indicated there currently is nothing in place. **Board Action: A motion was made to table the matter and have them return next month with a clear written plan, a signed articulation agreement for students, and an NCLEX teach out plan. Hall/Narwold, 8-0-0, motion carries**

#### **D. Medtech College Monthly Report (All Campuses)**

Staff appeared on behalf of Medtech College. They are making a request for a curriculum change in the RN program. A motion was made and seconded to grant that request. McIntosh/Laux, 7-0-0, motion carries

Since the June report which covered corporate level changes and the action plan provided to the Board. The July report covers changes in personnel, faculty reports and student surveys. Faculty education is ongoing and detailed. Ms. Cooper indicated they are above the 50% level on Indianapolis campus; Greenwood campus had some small improvements. Dr. McIntosh asked if there were any Greenwood students in the audience. Students are calling and indicating they were discouraged from attending this meeting so that they could not attend. Ms. Cooper indicated the program should look at having options available for outliers because they affect their NCLEX results. Staff indicated they are following all of the outliers until they test. Ms. Cooper indicated they need to look at admitting practices and plans and are still admitting students into a system that is troubled. They admitted new students in June 2014 but are forecasting a pass rate below 50%. The Board indicated that they need to continue to see improvement until January 2015. The Board will now look at student surveys in October 2014 and January 2015 with fine tuning to address the issues in the action plan. The programs will continue next month on what they need to do with NCLEX scores. Ms. Narwold indicated that it seems with trouble in the RN program the faculty needs development in increasing rigor, differentiation in practice between PN and RN, etc.

#### **E. ITT Tech Indianapolis Monthly Report (Marie Holder)**

Staff appeared from ITT Tech Indianapolis to give their monthly report. Ms. Holder indicated that ITT has gone through each action and follow up from the last time they were present. Mr. Hamm is present as well. Ms. Holder reported that the program currently has 130 students with 32 of them in the general education classes. Ms. Holder reported that moving forward each Nursing class will be doing more NCLEX practice questions, open lab hours for Nursing students for skills practice, time for faculty to have open doors and tutoring available, development of test taking strategies in each level, reviewed resources in the resource center and lab, two adjunct faculty are coming on Board as full time faculty, working on faculty development as all didactic faculty took a test writing course, they have had no faculty turnover since they last met, they are working on faculty development areas on a monthly basis. Ms. Hall indicated they asked students to submit to an anonymous survey. Staff was to compile the information and the results were not available prior to today's Board meeting. Hamm indicated that they utilized Survey Monkey tool for results but did not compile the result. Ms. Cooper indicated the results are only 52-54% and there needs to be a way for every student to complete the survey. Ms. Ogle indicated they need to scope the questions to the issues they are having vs. the blanket group of questions. Mr. Hamm apologized about missing the last meeting of the BON. Mr. Hamm indicated that their foremost thought is their NCLEX results and they take this seriously. Ms. Hall asked about how long this program has been on conditional accreditation and Mr. Hamm acknowledged they have been on conditional accreditation for two years. Mr. Hamm indicates they are in the process of putting individual plans together for each campus for success. Mr. Hamm indicates he has been in this position for sixteen months. Ms. Cooper asked how many times he has been on the Indianapolis campus in the last sixteen months. He indicates he has visited two times in the last 16 months. Ms. Holder reports to the campus director and has a byline report to Dr. Yazu who then reports to Mr. Hamm. Dr. Yazu has been with the program for about a year at this time. Dr. Yazu has a master's degree in Nursing and a Ph.D in education. Board Action: For next month's appearance, they are to fine tune their questions to the students about their particular issues at each campus, compile the information and send it to the Board prior to the Board meeting. McIntosh/Ogle 8-0-0, motion carries

## **VI. DISCUSSION**

### **A. Letter from Stephen Freeland, CEO, Cancer Care Group**

**Introduction of Cancer Care staff (listed in email).**

The Group is seeking guidance on the scope of practice for Nurse Practitioners regarding radiation therapy and their use of NP's for direct supervision for radiation therapy. Their NP is working in this role within some hospitals and they want to provide appropriate guidance to the hospitals in this role. Direct supervision is becoming more of a day to day term in the hospital due to service inclusion and coverage requirements. The NP's are working under the direction of a radiation oncologist. Dr. McIntosh indicated the Board would like to review their regulations and send a letter back. Ms. Laux asked about direct and general supervision and whether there are a certain number of cases the physician reviews of the NP. In their practice the NP does not staff daily but only when radiation oncologist is not staffing the clinic. They are seeking guidance because of compliance needed for Medicare reimbursement. Ms. Ogle asked who the NP's are supervising. Dr. Dugan indicated that there are two aspects of managing patients one is the technical side with plan review and adjustment of films which falls on the oncologist, the NP sees patients under treatment with regard to symptoms from radiation, dehydration, etc. The NP does not supervise the therapist per se because that is not within their scope of practice. Ms. Smith asked for a competency standpoint and wanted to know more about qualifications to supervise is there a continuing education or formal education that has been done and an observation log that shows the NP background? Diane was a radiation oncology nurse for ten years before she obtained the NP. They have a course and a test they can give people and everything the NP does is bounced off of an oncologist. Their current NP is oncology certified. Exhibit D is the competency assessment they use for these roles and continue to assess at least annually on competencies. Ms. Ogle asked if they are looking to improve patient care and they indicated that this is all about patient care and taking care of them in the most efficient way possible. Ms. Narwold asked what they are looking at is designation of direct care or whether the oncologist has to be present when the NP is providing services and staff indicated that is correct.

**B. IUPUI Seeks Guidance Regarding Clinical Experiences for Internationally Educated Students Licensed in Their Home Country, But Not Licensed in the U.S.**

Ms. Reynolds appeared for her personal appearance regarding her application for licensure. In 2004, she was charged with reckless driving. This incident did involve alcohol. She was 20 at that time. In 2012, she received an OWI. She was out with friends for a birthday. She had left her car somewhere for the night but then decided she wanted to take it home. Her BAC was .15. She was placed on criminal probation which has been completed. She will occasional have a social drink but does not abuse it. She was in nursing school when she received the OWI. She informed her school as soon as it happened. Ms. Hall recommends she be allowed to test. She must have an ISNAP evaluation. If she meets criteria for an RMA her license will be issued on probation. If she does not meet criteria for ISNAP her license is to be issued free and clear.

Ms. Holler appeared for her personal appearance regarding her application for licensure. She has taken the test 6 times and failed. She graduated 2007. This is her first appearance before the board. Ms. Hall recommends that she take a

review course and provide the board with documentation showing that she has at least a 95% chance of passing the NCLEX. Once this documentation is received from her she will be allowed to test. Once she passes the test she must take a refresher course with a clinical component before she is allowed to practice.

4. **Melissa Kerr** **RN Exam** **Did Not Disclose**

Ms. Kerr appeared for her personal appearance regarding her application for licensure. She appeared with her attorney Lorie Brown. She was in treatment in 2007 through May of 2014. She was going to a methadone clinic because she didn't know any other options until she got in touch with ISNAP. After talking to ISNAP she went through intensive outpatient in May of 2014. Her sobriety date is May 23, 2014. ISNAP is waiting on information from her therapist to determine her evaluation. Ms. Hall recommends she be allowed to test must have an INSAP evaluation. Her license is to be issued on probation the length of her RMA.

5. **Matthew Miller** **RN Exam** **CBC Hit/ Positive Response**

Mr. Miller appeared for his personal appearance regarding his application for licensure. In 2011, he had an OWI charge. He completed his criminal probation. He was 19 at the time. His BAC was .077. This happened in Iowa. He wants to test in Indiana because he is in the process of moving here. He rarely drinks but never in excess. He has not had any other issues. Ms. Hall recommends he be allowed to test and license to be issued free and clear.

6. **Jameka Kennedy** **RN Exam** **Positive Response FULL BOARD**

Ms. Kennedy appeared regarding her application for examination. Ms. Kennedy was involved in a fight when she was 16 years old and defended herself against her aunt resulting in her aunt's death. Ms. Kennedy was charged initially with murder and the charge was pled down to involuntary manslaughter and entered into a plea agreement. She obtained a GED after this, became a medical assistant, obtained certification to become a phlebotomist and completed her ASN level degree. She was able to finish clinicals at school and fully disclosed her past history.

There has been no other violence in her life since this incident. The driver of the car was not charged but Ms. Kennedy was charged with murder. **Board Action: A motion was made and seconded to allow her to sit for the exam, obtain an MMPI-2 to assess anger management and a probationary license not to exceed six months with 1 employer report to discuss patient interaction, quality of care and attendance. Laux/Presley, 3-4-0, motion fails A motion was then made and seconded to allow her to test and upon successful completion issue a free and clear license. Narwold/Cooper, 4-3-0, motion fails The motion was then made and seconded to allow to test with a free and clear license upon successful completion of NCLEX. 5-2-0, motion carries**

7. **Charles Crane** **RN Endo** **Positive Response**

Mr. Crane did not appear for his personal appearance regarding his application for licensure.

Ms. Hall recommends his licensure for application be denied.

8. **Tonya Broadus** **LPN Exam** **CBC Hit/ Positive Response FULL BOARD**

Ms. Broadus appeared regarding her application for licensure by examination. She was taking a shower and left a 4 year old and 18 month old alone in the yard, the 18 month old drowned in a neighboring pool. This occurred in 1998. She was arrested and charged with child neglect leading to death and child neglect of the toddler who lived. Her other two children were placed in the foster care system and she has not seen them since 1998. She pled guilty to reckless homicide. She spent 21 months in prison and an additional three years on parole. She fully disclosed this to her Nursing program and completed her clinicals. She has another charge on her record from when living in an apartment building and her friends were smoking crack cocaine in her apartment unknown to her. She was charged with possession of crack cocaine but the charges were eventually dismissed. She has a CNA license and has been working in home health care for the past three months as an aide. Ms. Laux asked if she ever filed to get child custody back and she did not. **Board Action: A motion was made and seconded to deny licensure. Laux/Ogle, 8-0-0, motion carries**

9. **Jessica Smith** **RN Exam** **CBC Hit/ Positive Response FULL BOARD**

Ms. Smith appeared regarding her application for licensure by examination. She has a gambling addiction and was stealing lottery tickets from the gas station she was working at in April 2013. This conviction occurred after she graduated. She is on criminal probation and will complete in March 2016. Ms. Cooper asked about her graduation date that was April 2012. She took her Boards and has failed them twice in Ohio. She last tested in May 2013. She has been to Hurst and Kaplan reviews and completed VATI and was given the green light. She lives in Ohio but works in Indiana. She currently works in home health care as an aide. **Board Action: A motion was made and seconded to allow her to test and if she successfully passes would be issued on probation for the length of the criminal probation with quarterly employer reports. Laux/Presley, 7-0-0, motion carries**

10. **Norma Robinson** **LPN Exam** **Four Fails/ Grad Date of May 2011**

Ms. Robinson appeared for her personal appearance regarding her application for licensure. She was terminated from a CNA job. She had attendance problems due to 6 months old twins. This happened in 1992. She graduated in nursing

school in 2011. She has taken the NCLEX 4 times. She took the ATI review course in March but has since tested and did not pass.

Ms. Hall recommends the application is denied. She is to get in touch with her school and work out an review plan. Once that review plan has been completed she can reapply.

**11. Amanda Martinez**

**RN Exam**

**CBC Hit/ Positive Response**

Ms. Martinez appeared for her personal appearance regarding her application for licensure. In January 2009, she was charged with underage drinking. In 2010, she was charged with public intoxication. She completed everything the court asked her to do relating to these charges. The cases are closed. She no longer drinks. Ms. Hall recommends she be allowed to test. She needs to have an ISNAP evaluation. If she meets criteria for an RMA her license is to be issued on probation. If she does not meet criteria her license is to be issued free and clear.

**12. Jennifer Hooper**

**RN Exam**

**CBC Hit/ Positive Response**

Ms. Hooper appeared for her personal appearance regarding her application for licensure. She has had 5 battery charges, 3 driving with suspended license, and a mischief charge. The mischief charged was a result of an argument with her daughter's father. He accused her of taking the windshield wipers off his car when she only took the blades off. She has never taken the NCLEX since graduating from school. The school just released her certification of competition within the last couple of years. She has had an MMPI-II. There were some concerns on the MMPI-II with impulse control and difficulty dealing with authority figures. She has shown a long history of criminal matters but nothing since 2008. She has grown up and been in therapy. She has recognized her triggers and has changed her life accordingly. She has a wonderful support now and never had that before. Ms. Hall recommends she be allowed to test. She will need to take a refresher course with a clinical component. Her license is to be issued on probation for 3 years active practice with employer reports.

**B. Appearances by Applicants for Renewal**

**1. Dana Clinton**

**LPN Exp Renewal**

**Positive Response**

Ms. Clinton appeared for her personal appearance regarding her application for renewal. In 2007, she had a charge for resisting a police officer. She has no other legal issues. She has an active license in IL and VA and an expired MI. None of these have discipline on them.

Ms. Hall recommends her license be renewed free and clear.

**2. Jayison McCorkle**

**RN Exp Renewal**

**Positive Response**

Mr. McCorkle appeared for his personal appearance regarding his application for renewal. He was previously denied a renewal. He needed to appear for a personal appearance but was unable to come. He was denied for failing to appear. In 2011 he was charged with reckless driving. He went to a party and left after having a couple drinks. He did not know the area and turned the wrong way down a one way street. His BAC was .10. He was on criminal probation for 6 months. He successfully completed that probation. This has been the only issue he has ever had. He does not drink anymore. He has an IL license that is active with no discipline. Ms. Hall recommends his license be renewed free and clear.

**3. Tonna Haggard**

**RN Exp Renewal**

**Did Not Disclose**

Ms. Haggard appeared for her personal appearance regarding her application for renewal. She was terminated from one position due to poor attendance. She was terminated from another position for failing to complete a fall report. She was working at an assisted living facility. A patient hit their arm and sat on the floor. She did not realize she needed to file a report on this. She last worked July or August 2013. Ms. Hall recommends that she complete 12 CEUs on patient safety and 12 CEUs on professionalism/ethics. Once the CEUs are received her license is to be renewed free and clear.

**4. Dianne Johnston**

**RN Exp Renewal**

**Expired Over 10 Years**

Ms. Johnston appeared for her personal appearance regarding her application for renewal. Her license has been expired for over 10 years. She has completed some continuing education. She has not really done anything to keep nursing up to date. She wants to take a certification test and has to be licensed as an RN.

Ms. Hall recommends needs to complete a refresher course with a clinical component then can be renewed free and clear.

**5. Leslie Crutcher**

**RN Exp Renewal**

**Positive Response**




