- I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM 8:30 a.m.
Natalie Hall, President of the Indiana State Board of Nursing, called the meeting to order at 8:30 a.m. and established a quorum in accordance with IC § 25-23-1-5(b).

- II. ADOPTION OF THE AGENDA
A motion was made and seconded to adopt the agenda. Morrison/Russell 6-0-0, motion carries.
- III. ADOPTION OF THE MINUTES FROM THE MAY 19, 2016 MEETING OF THE BOARD
A motion was made and seconded to adopt the minutes from May 19, 2016. Russell/Rock 5-0-1, motion carries.
- IV. INDIANA STATE NURSES ASSISTANCE PROGRAM
Chuck Lindquist presented his monthly report to the board. He informed the board of the ISNAP Conference "Catch me if you can-Diversion in the workplace" that will take place on August 26, 2016. He also addressed the students to explain ISNAP.
- V. EDUCATION
A. Huntington University Site Visit report & response (Margaret Winter EdD, MS, RNC
Dr. Margaret Winter, Dr. Diana Schenefield and Dr. Mike Wanous appeared on behalf of the program. The site visit for full accreditation was requested by the program. Dr. Winter will be retiring this summer and Dr. Schenefield has been named as the interim director. Dr. Schenefield's position has been filled by an individual who is in the last year of her master's program. After Education Compliance Officer Toni Herron's report, Board member Cooper asked how many students were currently in the program and Dr. Winter stated 30. Ms. Cooper asked about program completion rate and Dr. Winter stated that it is 90%. Ms. Cooper stated that she has some concern about NCLEX scores, and where they stand in comparison to the national standard, even though they are above the required 80% now. There are 4 full time and 3 part time faculty members in addition to the simulation lab manager. Board member Hall asked about the responsibilities of the lab manager and if it involved teaching students. Dr. Winter stated that she may help with correcting a skill but does not do actual instruction. She manages supplies and equipment primarily. Ms. Hall stated that this really involved instruction since she was interacting with students and encouraged the program to re-look at this position as part of faculty. The lab manager is baccalaureate prepared. Ms. Hall asked Ms. Herron about the educational requirement for faculty in a BSN program. Ms. Herron answered that the requirement was that faculty for a BSN program be master's prepared. Dr. Winter stated that she understood the requirement stated that the rules made

allowance for a grace period if there was a matriculation plan in place to complete the degree within a one year period. Ms. Herron replied that this was correct and she apologized for forgetting that part of the rule. Board member Rock asked if the remodeling of the simulation lab was currently underway and Dr. Winter replied that it was in the design stage currently and in addition, they were seeking adequate funding. Ms. Hall made a motion and Ms. Cooper seconded to accept the site visit report and the recommendations with the addition of a 3rd requirement.

The recommendations are:

1. Approve change to full accreditation status
2. Resurvey according to ISBN rules
3. Submit to ISBN no later than July 8, 2016, a written plan for all those faculty who are not master's prepared at the current time

Motion carries 8-0-0

B. Indiana University East - Request for Curriculum Change (Karen Clark EdD, RN)

Dr. Karen Clark appeared on behalf of the program. The request for curriculum change at this campus in Richmond is consistent with the curriculum revisions previously approved for other Indiana University campuses. The Board had no questions. Ms. Hall made a motion and Ms. Cooper seconded to approve the curriculum revision. Motion carries 8-0-0

C. Indiana University Kokomo - Modification of Previously approved Curriculum Change (Linda Wallace EdD, RN)

Dr. Wallace appeared on behalf of the program with Bridget Whitmore MSN, RN and Dr. Mary Bourke. In the original plan, the plan was to use independent studies for those students who fail a course when moving them to the new curriculum. The program has requested a revision to that plan to eliminate the independent studies. Dr. Wallace also shared that there are currently 5 nurses from Saudi Arabia completing their studies in administration or education tracks but not involved in patient care activities. This campus will be opening a family nurse practitioner program in February 2017. Ms. Hall made a motion and Ms. Cooper seconded to accept the proposed curriculum revision. Motion carries 8-0-0.

D. ITT Technical Institute Merrillville – monthly written and in person report (Karen Helmecy MSN, RN)

Karen Helmecy, Ruth Clayman and Myra Selby, counsel, appeared on behalf of the program. Ms. Herron shared that she had received written notification from Ms. Selby that Mariah Wood was not able to attend this meeting due to a schedule conflict that was not able to be resolved. Ms. Cooper asked about the number of current students and the projected graduation date of the final cohort of students. Ms. Helmecy stated that there are still 82 active students and the graduation date of the final cohort is September 2017. Ms. Cooper made a motion and Ms. Rock seconded to accept the report as submitted. Motion carries 8-0-0.

E. ITT Technical Institute Indianapolis – monthly written report

Ms. Cooper made a motion and Ms. Rock seconded to accept the report as submitted. Motion carries 8-0-0.

F. ITT Technical Institute Newburgh – monthly written report

Ms. Cooper made a motion and Ms. Rock seconded to accept the report as submitted. Motion carries 8-0-0.

G. ITT Technical Institute South Bend – monthly written report

Ms. Cooper made a motion and Ms. Rock seconded to accept the report as submitted. Motion carries 8-0-0.

H. Brown Mackie South Bend - monthly written report

Board member Hall recused herself and left the room as she has a conflict of interest as a result of her employment with Brown Mackie College. Ms. Cooper chaired the discussion. The Board had no questions regarding the submitted report. Brown Mackie College has announced plans to close all programs nationally. A teach out will occur for current students. Ms. Rock made a motion and Board member Morrison seconded the motion to accept the report as submitted. Motion carries 6-0-2.

- I. **MJS College - monthly written report and request for curriculum change (Annette Murray MSN, RN)**
 Annette Murray appeared on behalf of the program. The Board had no questions regarding the submitted monthly written report or the requested curriculum change. Ms. Cooper made a motion and Board member Presley seconded to accept as submitted. Motion carries 8-0-0.
- J. **VR Ashwood - monthly written report**
 Ms. Cooper made a motion and Ms. Rock seconded to accept the report as submitted. Motion carries 8-0-0.
- K. **Fortis College - monthly written report and request for curriculum change (Cinnamon Bell-Williams MSN, RN)**
 Cinnamon Bell-Williams and Dr. James Cox appeared on behalf of the program. Board member Hall recused herself at the request of the program and left the room. Ms. Bell-Williams stated that the material previously presented as "Quarter 9" has been renamed simply as "NCLEX prep". The Board voiced agreement with that decision. One faculty member teaches this material and is the same faculty person that teaches the Transitions course. NCLEX prep is not part of any other current course and requires that each student complete a minimum of 500 NCLEX style questions. This is meant to allow the student to progress through at their own pace, which is usually predicated on their performance up to this point in the program. Ms. Rock asked Ms. Herron if withholding the Certificate of Completion was something that she had seen with other programs. Ms. Herron stated that there are 2 or 3 other programs in the state that hold the Certificate until a certain metric is met, which assures the program that the graduate is likely to pass NCLEX on the first attempt, but it is not a common practice. Board member Owens asked that Fortis return with some data regarding the success of this initiative and how the data gathered is being used to revamp the concept. Initial results can be included in the quarterly in person reports to the Board and annual data can be reported in one year. Motion made by Ms. Cooper and seconded by Ms. Presley to accept the monthly written report as submitted and to approve the curriculum change request regarding the NCLEX prep material. Motion carries 7-0-1.

Ms. Herron stated that a written notification had just been received in the staff office. The notice stated that Brown Mackie would teach out all current students and would provide the Board with a written "teach out" in the near future. For the information to the members new to the Board, Ms. Herron stated that this process had been used when Corinthian College doing business as Everest College closed. The final cohort is due to graduate in June 2018. Ms. Herron will place the teach out plan on the agenda when it is received for Board review.

3. Natalie Byunn **RN Exam** **Grad Date 1991/Previous Testing Attempts**

Natalie Byunn appeared for a personal appearance. Ms. Byunn applied for an RN license by examination. Byunn graduated from University of Saint Francis in May of 1991. She has tested 9 times. Her last exam date was July 2010. She has not tested since due to life circumstances. She currently works assessing patients admitted into nursing facility to determine their needs. Byunn completed the Hurst review course. She believes she is prepared for the exam because she came close to passing on her last exam and has been studying. She has not submitted a copy of the predictor letter to IPLA yet. Since Byunn has completed the Hurst review ALJ Rock recommends that she submit a 95% probability of passing letter. She may test once it is received. Natalie Byunn's license may be issued free and clear upon passing the NCLEX.

4. Courtney Castle **RN Exam** **Failure to Disclose**

Courtney Castle appeared for a personal appearance. Ms. Castle applied for an RN license by examination and failed to disclose a criminal charge on her license application. In the summer of 2013, she went shopping with someone she knew from high school. The girl pressured Castle into shoplifting. Castle took 4 articles of clothing valued at \$158. When she tried to leave, she was stopped. She went to court and entered a deferral program. She paid a \$350 fine; attended counseling and the charges were dropped. She did not know she had to disclose the charges because she had asked her public defender if she would have to report the arrest on job application and she told her no. Castle has not had any issues with the law since. Since it was a onetime incident, ALJ. Rock recommends that Courtney Castle's license is issued free and clear upon passing the NCLEX.

5. Marissa Vaught **LPN Exam** **Grad Date 2009/Positive Response**

Marissa Vaught appeared for a personal appearance. Ms. Vaught applied for an LPN license by examination. Vaught graduated from Brown Mackie College in September 2009. She decided not to test and has been working as a manager at a hair salon. She recently became a patient care technician at a hospital in Fort Wayne. She is looking into an LPN to RN transition program at Ivy Tech. Vaught had a CNA license in 2009 but it is expired. It is not required to hold a CNA license to work as a patient care tech. In December 2006, Vaught was on her way home from a Christmas Party. She was pulled over and charged with a DUI. She was placed on one year probation. She was required to complete drug and alcohol courses and do random drug screenings. This was an isolated incident and she has not had trouble with the law since. Letters of recommendation were submitted. Since Vaught is still working in Healthcare and the DUI was over 10 years ago, ALJ Rock recommends Vaught complete a review course and provide the Board with a 95% probability passing letter before she can be made eligible to test. Marissa Vaught's license may be issued free and clear upon passing the NCLEX.

6. Susan Jones **RN Exam** **Failure to Disclose**

Susan Jones appeared for a personal appearance. Ms. Jones applied for an RN license by examination and failed to disclose a criminal charge on her license application. In September 2008, Jones was arrested for shop lifting at Dillard's Shopping Center in Richmond, IN. She was 18 years old at the time. She was in a dressing room and when she came out, she was approached by a retail worker and security guard. She was accused of putting a shirt under her clothes that she already had on but they didn't find anything on her or in her bags. She was arrested but bonded out a few hours later. The public defender advised her to take the deal because the judge will believe the store over her. She was fined and required to complete 20 hours of community service. She did not answer correctly on the application because she believed the charges were dismissed and the incident did not even cross her mind. Jones has not had trouble with the law since. Since this was a onetime incident ALJ Rock recommends that Susan Jones' license be issued free and clear upon passing the NCLEX.

7. Lakyn Boyd **LPN Endo** **Failure to Disclose**
 Lakyn Boyd appeared for a personal appearance. Ms. Boyd applied for an LPN license by endorsement and failed to disclose a criminal charge. Boyd holds an active and unencumbered license in Kentucky and also holds an active CNA license in Indiana. In January 2009, Boyd was arrested for minor consumption. She was 19 years old at the time. She was below the legal limit for an adult but because she was minor she was arrested. She entered a pretrial diversion that required community service. The charges were dismissed once she completed the diversion program. She held several other jobs including the Indiana Correctional Office and the arrest never appeared. She didn't think it was still on her record. Boyd has not had any legal trouble since. Since this was a onetime incident and the charge has been dismissed, ALJ Rock recommends that Lakyn Boyd's license be issued free and clear.

8. Taylor Thompson **RN Exam** **Positive Response**
 Taylor Thompson appeared for a personal appearance. Ms. Thompson applied for an RN license by examination and answered "yes" to question 3 on her license application. In December 2014, Thompson was arrested for minor consumption. Her blood alcohol level was .03 but Porter County has a zero tolerance policy. Thompson entered a one year pretrial diversion and completed 30 hours of community services at an animal shelter and at Goodwill. She attended alcohol classes at Valparaiso University. She has not had any trouble with the law since and plans on having the record expunged. Thompson still drinks occasionally. A copy of her community service and court documents was submitted into her file. Since this was a onetime incident ALJ Rock recommends that Taylor Thompson's license be issued free and clear upon passing the NCLEX.

9. Allison Trevithick **RN Exam** **Positive Response CONTINUED**

10. Zachary Kempf **RN Exam** **Failure to Disclose CONTINUED**

11. Andrea Wilson **RN Exam** **Failure to Disclose**
 Andrea Wilson appeared for a personal appearance. Ms. Wilson applied for an RN license by examination and failed to disclose a criminal charge. Wilson holds an active and unencumbered LPN and NAC license in Washington. She's been working as an LPN for 6 years with no issues. Wilson lives in Washington but completed a distant education RN program with Indiana State University. The Dean of Nursing requires distant education students to take the NCLEX through Indiana. In June 2009, Wilson was arrested for domestic violence in Tacoma, Washington. Her boyfriend was driving her and a friend home. Wilson and her boyfriend were both intoxicated. They got into an argument and he slapped her. She called the police from her cell phone. The friend told the police that Wilson was the one who hit him and she was arrested. Wilson was under the impression that the charges were expunged. She went to court recently to clear it up. A copy of the expungement document was submitted into her file. Since the charges were expunged, ALJ Rock recommends that Andrea Wilson's license be issued free and clear upon passing the NCLEX.

12. Taylor Ratcliff **LPN Exam** **Failure to Disclose**
 Taylor Ratcliff appeared for a personal appearance. Ms. Ratcliff applied for an LPN license by examination and failed to disclose a criminal charge on her license application. Ratcliff holds an active and unencumbered CNA and HHA license in Indiana. In July 2013, Ratcliff was arrested for conversion. She was out shopping with two friends. They were caught shoplifting and because she was with them, she was arrested but not charged. She was never placed on criminal probation. At the time, she was about to enter a CNA program and she was able to use her training as part of her community service. She was under the impression after a year it would be expunged, but she now knows that she has to request it. Since this was a onetime incident, ALJ Rock recommends that Taylor Ratcliff's license be issued free and clear upon passing the NCLEX.

13. Alexander Leisz **RN Exam** **Positive Response**
 Alexander Leisz appeared for a personal appearance. Mr. Leisz applied for an RN license by examination and answered "yes" to question 3 on his license application. Leisz holds an active and unencumbered LPN license in Indiana since 2014. In April 2011, Leisz was celebrating his birthday with friends. They were unable to get ahold of their designated driver. He thought he was fine and made the mistake of driving home. He was stopped by the Bloomington Police and he admitted to being intoxicated. Leisz entered a pre-trial diversion and completed 1 week of alcohol education and community service. In the summer of 2011, Leisz had gone out to celebrate the end of the school year with friends. Having learned his lesson about drinking and driving, he decided to walk home that night. He

was stopped by the Bloomington Police and was charged with public intoxication. He completed an alcohol evaluation and they determined that he did not need go into treatment. He has not had any legal issues since. A copy of the court documents were submitted into his file. Due to the age of the charges and that he has not had any other legal issues, ALJ Rock recommends that Alexander Leisz' license be issued free and clear upon passing the NCLEX.

14. Latina Neal

LPN Exam Grad Date 2012/Previous testing attempt

Latina Neal appeared for a personal appearance. Ms. Neal applied for an LPN license by examination. She graduated from PCCTI Healthcare School in 2012. She currently holds an active CNA license in Illinois since 2010 and is currently working. In Illinois, they only have 3 years after graduating to take the NCLEX. She took the exam twice, failed, and ran out of time. She believes it has a lot to do with anxiety. In 1991, she was in High School. She got into a fight with another girl and her friends jumped in. One of the friends had a box cutter and dropped it. She picked up the box cutter and cut one of the girls. The charges were dropped. Neal attended a review course in Illinois and completed it in August of 2015. Letters of recommendation submitted into her file. Due to her graduation date and failed attempts, ALJ Rock recommends that Neal submit a 95% of passing letter to the board before she can be made eligible to test. Latina Neal's license may be issued free and clear upon passing the NCLEX.

15. Tristan Sieber

APN

Positive Response

Tristan Sieber appeared for a personal appearance. Ms. Sieber is applying for her APN license and prescriptive authority. In October 2015, Ms. Sieber worked as a Temp for a Hospice Care as an RN case manager in Kokomo, IN. She was covering for a nurse on maternity leave. She had planned on resigning after the nurse returned but was transferred to a different office. She was pulled into a meeting questioning admissions paperwork that had been split between she another RN from December 2015. At the time, she was told that the split was approved by management but they denied approving it. They terminated Sieber and the other RN that had split the admission process for not following the company policy on charting. Sieber believes there was a lot of miscommunication and she now knows to verify company policy. Since this is her first termination, ALJ Rock recommends that Tristan Sieber's license be issued free and clear.

16. Stacey Claycamp

LPN Exam Grad Date 2008/Previous Testing Attempts

Stacey Claycamp appeared for a personal appearance. Ms. Claycamp applied for an LPN license by examination. She graduated from Ivy Tech Community College in 2008 and is currently working on her BSN. Claycamp holds an active and unencumbered LPN license in Indiana since 2006. She has failed the NCLEX 5 times. Her last exam was in 2010. Claycamp hired a personal tutor and completed the ATI in May 2016. She has a 97% probability of passing. A copy of the ATI letter submitted into her file. Since she already completed the ATI, ALJ Rock recommends that she be made eligible to test. Stacey Claycamp's license may be issued free and clear upon passing the NCLEX.

17. Lori Lupica

RN Exam

Positive Response

Lori Lupica appeared for a personal appearance. Ms. Lupica applied for an RN license by examination and answered "yes" to question 3 on her license application. She currently holds an active and unencumbered CNA license in Indiana. In January 2012, she was at a gas station with friends. She had been out celebrating New Year's Eve. Another female approached her in the parking lot and punched Lupica in the face. She defended her and hit back. A police officer pulled up and she was arrested for disorderly conduct. She was set for a pretrial diversion and the case was dismissed December 2012. She has not had any legal issues since. Copies of court documents submitted into her file. Due to the age of the charge and it being a onetime incident, ALJ Rock Recommends that Lori Lupica's license be issued free and clear upon passing the NCLEX.

Nina Anderson Failed to appear. She may be rescheduled one time.

19. Nadine Burns

Nurse Midwife

Positive Response- FULL BOARD

Ms. Burns appeared for her personal appearance regarding her application for licensure. She had a previous personal appearance in August 2015 regarding her RN renewal regarding the same issue she is appearing for now. She had an outstanding malpractice suit and very little information was given to her. At the time of the RN renewal she thought the malpractice suit was still pending. At that time a consumer complaint was sent to the Attorney General's Office for investigation. Since that personal appearance she has been informed that the suit was dismissed. She has not been involved in any other litigation. She had a termination in 2010 that she did not disclose. She was terminated for not

scanning in a document. She had not been shown how to do this. She has a current license in IL with no issues. A motion was made and seconded to approve her midwife license free and clear. Owens/Morrison, 4-3-0, motion fails. After more discussion a second motion was made and seconded to issue midwife license free and clear. Coto/Owens, 3-4-0, motion fails. Since an agreement was not reached a motion was made and seconded to table this matter until July full board. Hall/Coto, 6-1-0, motion carries.

20. Valeah Butler

LPN Exam Grad Date 2012/ Previous Testing Attempts

Valeah Butler appeared for a personal appearance. Ms. Butler applied for an LPN license by examination. She graduated from Chicago Practical Nursing Program in 2012. She has failed the NCLEX 3 times in Illinois. She completed a review course in August 2015. She applied in Illinois to take the exam the 4th time but her deadline to take the NCLEX within 3 years of graduating expired. She is now attempting to take it in Indiana. Since it has been over a year since she took a review course, ALJ Rock recommends that Butler complete a new review course and submit a 95% probability of passing letter to the board before she can be made eligible to test. Valeah Butler's license may be issued free and clear upon passing the NCLEX.

21. Jamie Barbour

LPN Endo

Positive Response

Jamie Barbour appeared for a personal appearance. Ms. Barbour applied for an LPN license by endorsement. She holds an active, unencumbered license in Kentucky and an expired license in Texas. In October 2013, Barbour was arrested and charged with a DUI. She was going through a divorce and was having a hard time, so she had been drinking. She was in a fender bender and when the police arrived they noticed that she was intoxicated. She does not recall her blood alcohol level. She was required to complete 12 weeks of AA classes. She now understands the consequences of her actions and there was no excuse for what she did. She has not had any legal issues since. Since this was first incident and she has learned from her mistake, ALJ Rock recommends that Jamie Barbour's license be issued free and clear.

22. Sarah McCammack

RN Exam

Failure to Disclose

Sarah McCammack appeared for a personal appearance. Ms. McCammack applied for an RN license by examination and failed to disclose a criminal charge on her license application. In February 2007, she moved to Illinois and was trying to make new friends so she attended a party. They had a few drinks and on their way home, during a snow storm, the car got stuck. A police officer stopped to help them. She did not blow over the legal limit and was not driving but there is a zero tolerance for minor consumption so she was arrested. She was placed on 6 months probation, completed community service and alcohol classes. This was her first arrest and has not had any legal issues since. She worked as a CNA before attending nursing school and currently had a job lined up in the PCU. Letters of recommendation submitted into her file. Due to the age of the charge and it being a first time incident, ALJ Rock recommends that Sarah McCammack's license be issued free and clear upon passing the NCLEX.

Positive Response

Heidi Morrison appeared for a personal appearance. Ms. Morrison applied for an APN license and prescriptive authority. In September 2015, Morrison applied for her APN license. In October 2015, she was charged with a DUI and notified the Board. Morrison holds an active and unencumbered license in Wisconsin, Alabama, and has an RN license in Indiana since 2015. Ohio is her home state. She currently works for Optum Health in telemedicine, which requires her to hold many state licenses. In October 2015, Morrison was arrested and charged with a DUI in Mentor, OH. Her blood alcohol level was .192. She had 4 glasses of wine on an empty stomach. In February 2016, the charge was lowered to Physical Control, a lesser offense. She was placed on probation and was required to complete 72 hours of Driver's Intervention School, 16 hours of community service, and a MADD meeting. She completed an alcohol evaluation and it was determined that she did not need treatment. Upon completion, the judge ended her probation early on April 21st, 2016. Letters of recommendation were submitted into her file. Ms. Riebsomer does not believe that she needs to be evaluated by ISNAP. Since there was no past history with alcohol, the judge ended the probation early, and does not require an ISNAP evaluation ALJ Rock recommends that Heidi Morrison's license be issued free and clear.

25. Lyniece Barnes**RN Endo****Failure to Disclose**

Lyniece Barnes appeared for a personal appearance. Ms. Barnes applied for an RN license by Endorsement and failed to disclose a criminal charge. Barnes holds an active and unencumbered LPN and RN license in Illinois and an active LPN license in Indiana. In June 1993, when she was 22 years old at the time, she was outside and saw that her sister was waving and yelling frantically. Three girls jumped out of a car. She knew one of the girls because she was dating her brother. They were only 17 and 18 years old. She were talking about fighting her sister and she tried to diffuse the situation that ended in a physical altercation. The police arrived and she was arrested for aggravated assault and battery because one of the girls was pregnant. She did not know she was pregnant until she had gone to court. Many neighbors saw the altercation and the judge dismissed the case and dropped the charges. Letters of recommendation were submitted into her file. Due to the age of the situation and because it was self defense, ALJ Rock recommends that Lyniece Barnes' license be issued free and clear.

26. Shakena Mann**LPN Exam****Failure to Disclose**

Shakena Mann appeared for a personal appearance. Ms. Mann applied for an LPN license by examination and failed to disclose criminal matter on her license application. In July 2012, she was riding in the car with a friend and they were pulled over. The friend told the police there was a handgun in the car. The officer asked them to get out of the car while he searched it. The friend changed his story and claimed the gun belonged to Mann. Since he would not own up to it, they were both charged. Mann found out there was a warrant out for her arrest for driving without a license. In April 2011, she did not have her driver's license at the time and drove. She was unaware of the warrant because she never received a court date for the incident. Letters of recommendations submitted into her file. Due to the age of the incident, ALJ Rock recommends that Shakena Mann's license be issued free and clear upon passing the NCLEX.

27. Stacie Dunn**RN Exam****Positive Response**

Stacie Dunn appeared for a personal appearance. Ms. Dunn applied for an RN license by examination and answered "yes" to question 3. In May 2011 Dunn went to a bachelorette party and had been drinking. She received a call that her 7 month old would not fall asleep. She was in New Albany, IN and was not familiar with the streets and was pulled over. She passed the sobriety tests but her blood alcohol level was .08, above the legal limit. She was arrested and charged with a DUI. She was placed on 6 months' probation and was required to complete drug and alcohol classes. The charges were lowered to reckless driving. Due to the age of the charge and it being a onetime incident, ALJ Rock recommends that Stacie Dunn's license be issued free and clear upon passing the NCLEX.

28. Megan Murray**RN Exam****Failure to Disclose**

Megan Murray failed to appear. She may rescheduled one time.

29. Elizabeth Nutt**RN Endo****Failure to Disclose**

Elizabeth Nutt appeared for a personal appearance. Ms. Nutt applied for an RN license by endorsement and failed to disclose a criminal matter on her license application. In July 2000, Nutt went to an event, had a few drinks, and made the choice to drive home. She did not make it even 2 blocks when she was pulled over for not using a turn signal. She was arrested and spent 3 days in jail. Her blood alcohol level was .167. Nutt was required to complete a 3 day alcohol safety class. She did not understand the question and that is why she did not answer it correctly. This was her first and only DUI. Due to the age of the charge and it being her only criminal issue, ALJ Rock recommends that Elizabeth Nutt's license be issued free and clear.

30. Luke Coleman**RN Exam****Positive Response- FULL BOARD**

Mr. Coleman appeared for his personal appearance regarding his application for licensure. On May 6, 2016, he went out to celebrate completing nursing school. He received a DUI after moving his car. His BAC was .167. He has not had any other issues. He has contacted ISNAP and will be entering into a one year RMA. His employer has also been notified and will be having drug screens at work. He has now starting using good coping mechanisms. He goes to court on July 12, 2016, for the DUJ charge. A motion was made and seconded to allow him to test. His license will be issued on probation with the following terms and conditions: the probation is to be the length of his RM A or criminal probation, whichever is longer; one year active practice; and quarterly reports. Cooper/Hall 7-0-0, motion carries.

31. Cynthia Kirton**RN Exam****Positive Response**

Cynthia Kirton appeared for a personal appearance. Ms. Kirton applied for an RN license by examination and answered "yes" to question 3 on her license application. In September 2015, Kirton was charged with possession of

marijuana. She was driving around with her friends and one of them had marijuana on them. Since it was her truck, she was arrested. These charges were dismissed. In November 2015, Kirton was at a Thanksgiving Dinner. She had recently placed her father in hospice care and received a lot of backlash from her family. During the dinner, she got into an argument with her brother. She left despite the fact that she had been drinking. She drove her truck off the road and it rolled 6 times. Nobody else was involved in the accident. She pled guilty to Operating While Intoxicated and was placed on one year probation in February 2016. She voluntarily checked herself into Treatment and is attending counseling twice a month at Centerstone. She completed her drug and alcohol classes February 2016 and is currently working on her 64 hours of community service. Letters of recommendation submitted into her file. Since Kirton is still on criminal probation and that her blood alcohol level was high, ALJ Rock recommends that Cynthia Kirton's license be placed on indefinite probation and she receives an ISNAP evaluation. The length of her probation will be the duration of her RMA or criminal probation, whichever is longer. As part of her terms, she will be required to submit quarterly reports. Ms. Kirton agreed to her terms.

32. Sarah Berry

LPN Exam

Positive Response

Sarah Berry appeared for a personal appearance. Ms Berry applied for an LPN license by examination and answered "yes" to question 3. When she was 16 years old, she was caught shoplifting cosmetics from Kroger with a friend. She paid back what she had taken in restitution. She was given 8 hours of community service and had to take shoplifter's classes and three jury duties for teens. In 2011, she was going through a bad breakup. She had gone to her ex-boyfriends house to talk to him and settle their differences but many of his friends were there. It resulted in a heated argument. Her boyfriend came towards her with a closed fist and she slapped his face. She tried to leave to avoid making things worse. One of his friends threw a beer can at her car and the two of them were standing in the middle of the road. She swerved out of the way and wrecked into her ex-boyfriends car. Since her ex had 2 witnesses, the police took their word over hers and she was arrested. She was charged with battery and was given one year probation. She had to attend 6 months domestic violence classes and now knows there are better and more mature ways to handle situations like that. She has not had any criminal issues since. Due to the age of the incidents and that she has learned from the experience, ALJ Rock recommends that Sarah Berry's license be issued free and clear.

33. Alex James Fiechter

Failure to Disclose

Alex James Fiechter appeared for a personal appearance. Mr. Fiechter applied for an RN license by examination and failed to disclose a criminal matter on his license application. In December 2010, he was 19 years old. He was the passenger in his friend's car. They were heading back home and stopped at gas station. An employee there called the police claiming that his friend seemed intoxicated. Shortly after leaving the gas station they were stopped. Fiechter blew a .05 and was arrested. He entered a pre-trial diversion program. He was required to complete 12 weeks of substance abuse and AA classes. The charges were dismissed after he completed the program. He was not sure how to answer the question. Due to the age of the charge and it being a onetime incident, ALJ Rock recommends that Alex James Fiechter's license be issued free and clear.

Casey Flynn-Lichty failed to appear. Ms. Rock recommends that her license application be denied.

35. Robert Koons

Failure to Disclose

Robert Koons appeared for a personal appearance. Mr. Koons applied for an RN license by endorsement and failed to disclose a criminal matter on his license application. He holds an active and unencumbered license in Kentucky and is also a notary public for Indiana and Kentucky. In September 2010, Koons was pulled over for a broken tail light and discovered that he had a warrant out for his arrest for failure to appear in court. In 2000, he had rented an apartment that was a 12 month lease. He spoke to the landlord and was told that after the lease ends it will become month to month. He 2003 he gave the landlord a 30 day notice that he was moving out and moved one street over. The landlord filed a small claims suit on him for breaking his lease. Koon never received notification and had gone through background and credit checks without anything appearing. Due to age of the arrest and that it was regarding a civil issue, ALJ Rock recommends that Robert Koons' license be issued free and clear.

David Copeland appeared for a personal appearance. Mr. Copeland applied for an RN license by examination and failed to disclose a criminal matter on his license application. In February 1999 Copeland and a friend had gone out to a club in Kentucky and they took a cab back home. When they returned to his house, Copeland could not sleep and felt

fine driving home. On his way home, he got a flat tire and a police officer stopped to help and noticed that he was intoxicated and arrested him. He had to pay a \$400 fine, had his driver's license suspended for 90 days, and took 6 week drug and alcohol class. Letter of recommendation submitted into file. Due to the age of the charge, ALJ Rock recommends that David Copeland's license be issued free and clear.

37. Amy Claire

Amy Claire appeared for a personal appearance. Ms. Claire applied for an LPN license by examination. Claire graduated from Ivy Tech Community College in 2012 and has never taken the NCLEX. She was having ongoing health issues and was diagnosed with cancer. She has been feeling much better now and would like to go back into nursing. She has been working in a group home for patients with disabilities that needs extra care. Letters of recommendation were submitted into her file. Since she has been out of nursing school for so long, ALJ Rock recommends that Claire complete a review course and provide the board with a 95% probability of passing letter and that her license be issued on indefinite probation with 6 months active practice. As part of her terms, she will be required to complete a refresher course with a clinical component before she can begin practicing and submit quarterly employer reports.

38. Winita Lee

Winita Lee failed to appear. Ms. Rock recommends that her license application be denied.

Julia Dicken appeared for a personal appearance. Ms. Dicken applied for an RN license by examination and failed to disclose criminal matter on her license application. In June 2010, Dickens went to a friend's house in Valparaiso, IN for a party. She had a few drinks and fell asleep on the couch. She woke up to the police investigating a noise complaint. She admitted to drinking and her blood alcohol level was .03. Because she was underage she was arrested. She was fined and was required to complete 12 hours of community service. In August 2010, she was arrested and charged with conversion in Hobart, IN when she took a box of hair dye and other items from Walmart. When she tried to leave, she was stopped by security but she ran to a nearby restaurant and dropped the items in a bush. She was caught by the police and was arrested. She stole about \$35 worth of items. She pled guilty and was required to complete 40 hours of Community Service. Dickens stated that she has 30 days to test or she will lose her job and cannot wait for the Board to vote on the recommendation and asked to be seen by the full board. After explaining all the above information a motion was made and seconded to allow her to test. Her license will be issued on probation with the following terms and conditions: Must have an ISNAP evaluation, probation will be the length of her RMA or 6 months active practice, whichever is longer; quarterly reports; 12 CEUs in professionalism; and 12 CEUs in impaired nursing.

In July 1989, Nester shoplifted a video game from a department store. He was 19 years old at the time. He was stopped by security in the parking lot and was arrested. He was required to take classes and the charges were dismissed. Nester has served in the United State Air force for 24 years and has been awarded with numerous awards based on his character. Since Nester has learned from the experience, it was a first time incident, and the age of the charge, ALJ Rock recommends that Earnest Nester's license be issued free and clear.

Alexandra Conner appeared for a personal appearance. Ms. Conner applied for an LPN license by examination. She graduated from Kaplan College in 2013 has taken and failed the NCLEX 4 times. She holds an active CNA and HHA license in Indiana. In July 2015, she completed the Hurst Review. ALJ Rock recommends that Conner complete a review course and provide the board with a 95% probability of passing letter before she can be made eligible. Alexandra Conner's license may be issued free and clear upon passing the NCLEX.

44. Beverly Brooks**LPN Exam****Failure to Disclose* Full Board**

Ms. Brooks appeared for her personal appearance regarding her application for licensure. She has been out of school for 4 years but has been working as a CNA the whole time. She last tested in 2012. She has been studying on her own. She failed to disclose an arrest on her application. She had written a bad check 30 years ago. This was her only issue. She forgot this had happened. A motion was made and seconded to allow her to test and her license be issued free and clear. Cooper/Morrison 6-1-0, motion carries.

45. Sara Johnson**RN Exam****Previous Testing Attempts**

Sara Johnson appeared for a personal appearance. Ms. Johnson applied for an RN license by examination. She graduated from University of Saint Francis in 2015 and has failed the NCLEX 3 times. Johnson currently holds an active CNA license and is working as a patient care tech at Lutheran Hospital. ALJ Rock recommends that Johnson complete a review course and provide the board with a 95% probability of passing letter before she can be made eligible. Sara Johnson's license may be issued free and clear upon passing the NCLEX.

McKenzie Finney appeared for a personal appearance. Ms Finney applied for an RN license by endorsement. Finney holds an active and unencumbered RN and LPN license in Illinois. She exited the business the way she came in but it was a one way entrance. A policeman pulled her over and she blew over the legal limit. They searched her car and found a gun that belonged to her friend. She was keeping the gun for her friend who was watching her nephew and didn't want him to accidentally find it. The friend was at the birthday party that night and even assured her that the gun did not belong to her. Finney was arrested and charged with a DUI. She paid a fine, placed on 24 months' probation and was required to complete 6 months of alcohol treatment. On December 2014, her probation ended. Since she completed her criminal probation and has not any legal issues since, ALJ Rock recommends that McKenzie Finney's license be issued free and clear.

Heather Lees appeared for a personal appearance. Ms. Lees applied for an RN license by examination and answered "yes" to question 3 on her license application. In the summer of 2012, she was a freshman in college. She attended a bonfire at a friend's house. She had an alcoholic beverage and was only 19 years old at the time. Towards the end of the night she noticed her purse had been stolen and called the police. During her statement she admitted to consuming alcohol. She was ticketed for minor consumption. She went to court and entered a deferral program. She still drinks occasionally but takes a Cab or an Uber if she goes out and knows to be careful. Letters of recommendation were submitted into her file. Since it was a onetime incident and that she knows the consequences of alcohol, ALJ Rock recommends that Heather Lees' license be issued free and clear.

She did not get off until 10PM. Before she arrived, two of the friends drove around and hit several mailboxes with a baseball bat. Someone saw their car and reported them. She had a designated driver but they decided not to go out that night. Keys agreed to drive her and friends home. She was pulled over for having a tail light out and the police officer smell alcohol. She was arrested and charged with a DUI. She was placed on a 2 year probation, had to take and complete alcohol counseling and her driver's license was suspended. In December 2011, she had gone out with a group of friends for her birthday. She was not going to drive that night but a

friend pressured her to drive them home. She was pulled over and failed the breathalyzer and sobriety test and was arrested. She lost her drivers license for a year, placed on 2 years probation, 100 hours of community service, and alcohol counseling. She has not had any legal trouble since and realizes her mistakes. She became a mother and enrolled in college to turn her life around. Since she has made a significant change to her lifestyle, ALJ Rock recommends that Kelli Keys' license be issued free and clear.

He asked the officer to help the guy. He was pulled out of the vehicle. The police had a gun pulled on him. He asked the policeman if he was going to shoot him. He asked this question twice. He was then arrested for resisting arrest. He went to court. He was found guilty and was on probation for a year. He successfully completed his criminal probation. Mr. Barhams submitted four letters of reference. Due to the fact that this issue happened in 2012, it is his only offense, and successfully completion of his criminal probation, ALJ Russell recommends the following: He be allowed to test and upon passage his license to be issued free and clear.

5. Chelsey Brown LPN Exam Positive Response

Ms. Brown appeared for her personal appearance regarding her application for licensure. She has had two legal issues. Both incidents happened in 2012. One was for illegal consumption and the other was public intoxication. Regarding the public intoxication, she was going through a rough time. She had gone out. The people she was with got into an accident. She left the vehicle and went to a house and called her dad. She went to jail after the police showed up. She was placed on criminal probation. She was 20 at the time for both incidents. She does not drink often now. She made a bad decision at that time. She has learned that she does not want to go to jail again and to be more responsible. She is now very cautious. Due to the fact that these events happened in 2012, she successfully completion of criminal probation, and she has had no other issues ALJ Russell recommends the following: Ms. Brown be allowed to test. Upon passage of NCLEX her license be issued free and clear.

6. Cory Hay RN Exam Positive Response

Mr. Hay appeared for his personal appearance regarding his application for licensure. In June 2012, he was charged with public intoxication and disorderly conduct. At the time he had a lot of personal issues going on. He was out with a friend and drank more than he should have. He got into an argument with the bartender and was asked to leave. When leaving he made a scene and kicked over the barstools. The police were called and he was arrested. The case was dismissed after he completed community service. In January 2013, he was out with friends and had been drinking. He started to drive home. He pulled over to call his girlfriend to come and get him. The police pulled up behind him. The keys were in the ignition, so he was charged with a DUI. He had 8 or 9 drinks that night. He refused to do a breathalyzer. He successfully completed his criminal probation. Since this time he has straightened his life out. He doesn't associate with the same people anymore. He drinks on a very low level. He doesn't go to bars. He submitted a letter of reference and two employment appraisals. Due to two serious alcohol related events ALJ Russell recommends the following: He be allowed to test. He must have an ISNAP evaluation. Upon passage of NCLEX, if he meets criteria for an RMA his license will be issued on probation for the length of his RMA with quarterly reports. If he does not meet criteria for an RMA, his license is to be issued free and clear.

7. Christi Swafford LPN Exam Positive Response

Ms. Swafford appeared for her personal appearance regarding her application for licensure with Counsel Aaron Harshman. In May 2015, she was terminated for allegedly abusing a patient. She was a CNA. She and coworkers were wearing the wig of a patient. Someone took a picture of her and the resident was in the background. The picture was sent to her boss. She didn't know the picture had been taken. She knew the resident and the resident was not aware this was happening. Everyone was just passing the wig around. She receive a letter saying she was being investigated for abuse, then a letter stating there was abuse found and she was responsible. There were other patients around when this happened. It happened on night shift. She is currently employed. She just started so she doesn't have any documentation from them. She works at the library at the New Castle Correctional Facility. She has not done anything like this before or since. She does not know what she was thinking. She would never do anything like that again. This was before she attended nursing school. She submitted two letters of reference and notice from the Indiana State Department of Health regarding the investigation. Due to the serious nature of her termination ALJ Russell recommends the following: Ms. Swafford be allowed to test. Upon passage of the NCLEX her license be issued on probation for a year active practice, quarterly reports, 12 CEUS in abuse and 12 CEUS in professionalism.

8. Ceaira Bentley RN Exam Positive Response

Ms. Bentley appeared for her personal appearance regarding her application for licensure. In July 2013, she was charged with minor possession of alcohol. This happened in Nebraska. She paid the fee a couple of days later in court and the matter was finished. This is her first and only run-in with the law. She was not driving during this incident. She was outside at a campground. DNR showed up. No one was driving. She occasionally drinks but not enough to impair and no driving when she drinks. She has learned that she is responsible for herself and actions 24/7. She now is more responsible. This happened the summer after her freshman year. She submitted letters of reference, employee evaluation, court documents, resume, personal statement, and transcripts to be reviewed. Due to fact that she paid her fine and this is her one and only issue ALJ Russell recommends the following: Ms. Bentley be allowed to test. Upon passage her license be issued free and clear.

9. Akan Anamndu LPN Exam Grad Date 2012

Mr. Anamndu appeared for his personal appearance regarding his application for licensure. He graduated nursing school in 2012. He has tested in 2012, 2013, 2014, and 2015. These tests took place in Illinois. He has not moved to Indiana. He is trying here because if he can't test in Illinois unless he goes back to school. He has taken online review courses. He did not receive any predicator from them. Due to his graduation date and unsuccessful testing attempts ALJ Russell recommends the following: Mr. Anamndu must complete a review course and submit to the board documentation showing he has a 95% chance or greater of passing NCLEX. Upon passage his license is to be issued free and clear.

10. Jude Anuka LPN Exam Grad Date 2002/Previous testing attempts

Mr. Anuka appeared for personal appearance regarding his application for licensure. He graduated in 2002. He has taken NCLEX 3 times. His last attempt was in 2008. He has taken some review courses in the past. He is enrolled at Ivy Tech for his RN license. He has not started any classes yet. He is not working in the health care field. Due to his graduation date and unsuccessful testing attempts ALJ Russell recommends the following: Before Mr. Anuka is allowed to test he must complete a refresher course with a clinical component. Upon passage his license is to be issued on probation for six months active practice with quarterly reports.

11. Jennifer Hoyt APN Failure to Disclose

Ms. Hoyt appeared for her personal appearance regarding her application for licensure. In 1998, she received a check from her mother to pay for tuition and room and board. She deposited this check into her account then wrote checks for the tuition and room and board. Her mother stopped payment on the check causing the other checks to bounce. She and her mother had a rough history. She was charged with theft of service. She was 19 at the time. She didn't deal with the things the way she should have. She paid back the money and the charges were dismissed. She had paid an attorney money to get the matter expunged. She assumed this had been taken care of. Due to the age of the case and believing the matter had been expunged ALJ Russell recommends the following: Ms. Hoyt is to be issued a license free and clear.

12. Brittani White RN Exam Failure to Disclose/Previous testing attempts

Ms. White appeared for her personal appearance regarding her application for licensure. In 2012, she was driving a vehicle with altered license plates. She went to court and the matter was dismissed. She marked "no" because she thought this was a minor traffic violation. This is her third application and she checked "no" on two previous applications as well. She was not brought in for a personal appearance regarding the first two applications. The license plate issue was not her fault. She has had no other issues. ALJ Russell recommends the following: Ms. White be allowed to test and upon passage her license is to be issued free and clear. ALJ Russell wants Ms. White to understand she has to pay careful attention to what she is filling out. She wants this to be a learning experience for Ms. White.

13. Cecille Absin RN Endo Failure to Disclose

Ms. Absin appeared for her personal appearance regarding her application for licensure. She did not disclose a previous disciplinary action in Mississippi. She was working when she didn't have a license. She thought she had a license, but did not realize the temporary had expired and the permanent license had not been issued yet. She had to pay a fine. She had submitted documents to CGFNS and thought they would immediately follow up with the board. She was given a permanent license. She worked for around 9 months in Mississippi without the license. Her license in Mississippi is active with no restrictions. She answered "no" because she thought it was a pre-disciplinary action. She also has licenses in New York, Nevada, California, and Vermont. None of these other licenses have been disciplined. Due to no discipline in the other states and all fines in Mississippi paid ALJ Russell recommends the following: Ms. Absin be issued a license free and clear.

14. Adrian Morales RN Exam Positive Response

Mr. Morales appeared for his personal appearance regarding his application for licensure. In April 2015, he received a DUI. He was at a friend's house in Bloomington. The plan had been to spend the night but he got into a fight with his girlfriend. He left to drive home. He fell asleep and skidded into a guard rail. His BAC was .10. He spent 3 days in jail and was on criminal probation for 9 months. He had a previous arrest. Alcohol was not involved in that arrest. It was a domestic dispute where he called the police. It was the same girlfriend. He has stopped hanging out with his Bloomington friends. He doesn't take any chances after he has a drink. He now only drinks on occasion. He has a LPN license. Due to the fact that he successfully completed his criminal probation ALJ Russell recommends that Mr. Morales be allowed to test. Upon passage his license be issued free and clear.

15. Taylor Gibson RN Exam Positive Response*

Ms. Gibson appeared for her personal appearance regarding her application for licensure. In September 2013, she was charged with illegal consumption. She completed a pretrial diversion program and the charges were dismissed. She was in Bloomington when she was 20. She walked home to her apartment, a noise complaint was filed and the police showed up. This is the only issue she has ever had with the law. Due to fact that this is the only issue she has had and she successfully completed the diversion program ALJ Russell recommends the following: Ms. Gibson be allowed to test. Upon passage her license be issued free and clear.

16. Meri Baucom LPN Endo Failure to Disclose*

Ms. Baucom failed to appear for her personal appearance. Due to multiple failure to appear ALJ Russell recommends the following: This application be denied.

17. John Nystrom RN Exam Failure to Disclose- VACATED

18. Falguni Patel RN Exam Grad date 2012/Previous testing attempts

Ms. Patel appeared for her personal appearance regarding her application for licensure. She has previously tested. All of her testing attempts have been in Illinois except for one. She has taken a review course before. She doesn't think she took enough time to study before taking the test. She is currently enrolled in ATI. Due to her graduation date and unsuccessful testing attempts ALJ Russell recommends the following: Ms. Patel must complete a review course and submit documentation to the board showing she has at least a 95% chance of passing NCLEX. Upon passage her license is to be issued free and clear.

19. Camille Marshall RN Endo Failure to Disclose

Ms. Marshall appeared for her personal appearance regarding her application for licensure. She answered "no" on her application and should have answered "yes" to question number 3. In 2001, she worked at a hospital and paid for parking on a regular basis with a check. She tried to leave one day and was told they didn't take checks anymore. She was upset. The police were called. She was charged with Theft of Services. The judge dropped the charges. She answered "no" due to the fact that she misread the question. ALJ Russell recommends the following: Due to the time and nature of the incident Ms. Marshall is to be issued a license free and clear.

20. Perry Evans RN Exam Failure to Disclose

Mr. Evans appeared for his personal appearance regarding his application for licensure. He checked "no" to question number 3 because he had forgotten about the incident. He was going to Huntsville AL for a race. They were parking the vehicle. He got out to help make sure the vehicle did not hit anything while it was being parked. He had a beer in his hand. He was charged with drinking in public. This happened in 2004. There was no driving involved. He has had nothing since. ALJ Russell recommends the following: Due to the timeframe and this being the only incident, upon passage of the NCLEX Mr. Evans be issued a license free and clear.

21. Ali Phillips RN Exam Positive Response

Ms. Phillips appeared for a personal appearance regarding her application for licensure. In February 2014, she drove when she was drunk. She does not have any excuse for this. The car was parked when she was arrested. She completed all that the court asked her to do. She completed a deferral program. She has not had any trouble before or since this incident. She was out and ready to go home. No one else was ready to leave so she just left. She pulled over to make a phone call and the police came up behind her. She now rarely drinks. ALJ Russell recommends the following: Due to this being her only issue and she completed all the court has asked, upon passage of the NCLEX Ms. Phillips be issued a license free and clear.

22. Allison Knight RN Exam Positive Response

Ms. Knight appeared for her personal appearance regarding her application for licensure. She is currently a QMA. On December 2011, she was out with friends and had a few drinks. She misjudged how strong the drinks were and left the bar. She was pulled over because she forgot to turn the headlights on. She was placed on probation. This has been completed. This is her only issue. She rarely drinks and not in excess. She doesn't drive after drinking now. Ms. Knight submitted letters of reference and court documents to be reviewed. ALJ Russell recommends the following: Due to this being her only incident and completion of court probation, upon passage of the NCLEX Ms. Knight be issued a license free and clear.

23. Tristan Sieber APN Positive Response- CONTINUED

24. Shannon Sewell RN Exam Positive Response

Ms. Sewell appeared for her personal appearance regarding her application for licensure. She answered "yes" to question number 3. She was at a concert and during intermission she went out to take a picture. She had a drink in her hand; an officer came up and asked to see her id, she was 20 at the time. She was given a ticket and completed a diversion program. This is her only issue. This happened in 2014/2015. Her criminal probation was completed in December 2015. She now thinks about things more now before doing anything. Ms. Sewell submitted letters of reference and a certificate of completion for Prime For Life. ALJ Russell recommends the following: Due to this being her only incident and successful completion of the diversion probation, upon passage, Ms. Sewell is to be issued a license free and clear.

25. Haley Ivers RN Exam Positive Response

Ms. Ivers appeared for her personal appearance regarding her application for licensure. In March 2013, she was visiting a friend in Evansville and had a few drinks. She had stopped drinking and thought she was ok to go home. She rear ended someone at the stop sign. She was arrested, had 3 charges, the charges were dismissed after completion of the DADS program. This is her first and only offense. She never gets behind the wheel after having a drink now. She only occasionally drinks. Ms. Ivers submitted court

documents and letters of reference to be reviewed. ALJ Russell recommends the following: Due to this being her only offense and completion all the court requirements, upon passage of the NCLEX, Ms. Ivers is to be issued a license free and clear.

26. Scott Helmcke RN Exam Positive Response

Mr. Helmcke appeared for his personal appearance regarding his application for licensure. In 2012, he received a DUI. He was in a rural town and went through a yellow light. A police officer saw this and said light was red. He completed all the court requirements. In 2014, he was a passenger in a vehicle on Labor Day weekend. There was a check point. When the officer was walking away he said the word "unbelievable" and he was then charged with disorderly conduct. He had unsupervised probation and had alcohol evaluation. Alcohol was involved with this matter. The driver had not been drinking but he had. Mr. Helmcke submitted reference letters to be reviewed. ALJ Russell recommends the following: Due to the time frame, completing all court requirements, and good recommendation letters, upon passage of the NCLEX, Mr. Helmcke is to be issued a license free and clear.

27. Tabitha Lane LPN Exam Failure to Disclose

Ms. Lane appeared for her personal appearance regarding her application for licensure. In 2005, she was at a party. She was a senior in high school. She had been drinking and was taken to jail. She completed a deferral program. She has not had any other issues. She answered "no" because she thought it was off her record. She rarely drinks now. She thought the deferral and expungement was the same thing. ALJ Russell recommends the following: Due to this being her only incident, the time frame of the incident, and completing all court requirement, upon passage Ms. Lane is to be issued a license free and clear.

28. Candace Jordan LPN Exam Positive Response

Ms. Jordan appeared for her personal appearance regarding her application for licensure. She currently works in dialysis. They have a red book that state documents go in. She was just learning how to open the clinic. They had been out of a solution, she reported this to a preceptor and he told her what he had been doing. The next day she reported it to someone else and there was an investigation. She was reprimand because she didn't report it to the right person on the first day. She is still at the same facility. Everyone involved was written up. ALJ Russell recommends the following: Due to there being no adverse outcome to any patients, her reporting the problem, and still being at the same employer, upon passage of the NCLEX, Ms. Jordan is to be issued a license free and clear.

29. Kenyatta Brooks LPN Exam Positive Response

Ms. Brooks appeared for her personal appearance regarding her application for licensure. In 2002, she and a group of friends went to a store and someone had taken something. Everyone was charged with theft. They went to court but she missed a court date and a warrant was issued for her. During this time she had to report for a urine drug screen, she tested positive for marijuana. She had to go for regular drug testing after that. It was dismissed after she completed court requirements. She was then arrested for driving on suspended license. She was not aware it was suspended for an unpaid ticket. She went to traffic court and proved she had a driver's license and the matter was dismissed. In 2007, she was at a Wal-Mart with her aunt. They had a case of pop under the cart. They were stopped by a security guard. They tried to pay but she was still charged with theft. The matter was dismissed when she went to court. She no longer smokes pot. She is currently a medical assistance. She has been at the same place of employment for the last seven years. ALJ Russell recommends the following: Due to the date of the last issue, completing all court requirements, and being at the her place of employment for 7 years with no issues, upon passage of the NCLEX, Ms. Brooks is to be issued a license free and clear.

30. Richard Watkins RN Exam Positive Response

Mr. Watkins appeared for his personal appearance regarding his application for licensure. In December 2012, he and a friend, were released from duty for the day. They decided to ride their bikes at a high rate of speed. A policeman had attempted to pull them over, he did not see the officer, and his friend did and pulled over. He called his friend when he got to the apartment, the officer answered the phone. He returned to the scene. He was arrested, charged with fleeing the scene. He signed a plea agreement. The racing on the highway would stand and other charges were dropped to reckless driving. He completed all the court requirements. He also answered "yes" to question number 4. He was clocking out and an intern had locked her keys in the front building. He saw her crying, He called the nurse to see if they had a key. The nurse said figure it out and hung up on him. He called the receptionist and she said tell her to wait till morning. He lifted the frame glass up and she was going to reach her hand in to open the door. The glass fell out. He reported the issue and was asked why he didn't call maintenance. He was not aware they were on call. He received a written reprimand. He is no longer with the company. There was no patient involvement with the incident. Mr. Watkins submitted court documents to be reviewed. ALJ Russell recommends the following: Due to no patient care issues and completing court requirements, upon passage of the NCLEX, Mr. Watkins is to be issued a license free and clear.

31. Carey Faw RN Exam Failure to Disclose

Ms. Faw appeared for her personal appearance regarding her application for licensure. In 2009, she was arrested for check deception. She was arrested in 2009 but the warrant for her arrest was issued in 2007. There was no conviction. The matter was dismissed a couple days after the arrested. She believes she must have read the question wrong and answered "no" when it should

have been "yes". She is in the process of having it expunged. She submitted court documents to be reviewed. ALJ Russell recommends the following: Due to the time frame of the matter and the fact that she is in the process of getting this expunged, upon passing the NCLEX, Ms. Faw will be issued a license free and clear.

32. Pamela Campbell RN EndoPositive Response- Application Withdrawn

33. Ralph Esparza RN EndoPositive Response

Mr. Esparza did not appear for his personal appearance. This matter is to be rescheduled one time.

34. Ora Lenoir RN Exam Positive Response/Grad date 2003/Previous Testing Attempts

Ms. Lenoir did not appear for her personal appearance. This matter is to be rescheduled one time.

35. Dustin Mart RN Exam Positive Response

Mr. Mart appeared for his personal appearance regarding his application for licensure. In February 2013, he pled guilty to an OWI. He completed all court requirements. His BAC was either .12 or .15. Being arrested was a turning point for him. He rarely drinks; only under very strict circumstances; and, only at home. He has learned a lot about himself through this matter. He has not had any other issues. Mr. Mart submitted a letter of reference to be reviewed. He informed his employer when this happened. ALJ Russell recommends the following: Due to completing all the court requirements and informing his employer, upon passage of the NCLEX, Mr. Mart be issued a license free and clear.

36. Patricia Wyant RN Exam Failure to Disclose

Ms. Wyant appeared for her personal appearance regarding her application for licensure. She answered "no" to question number 3 when she should have answered "yes". She misunderstood what expungement meant. In 1974, her boyfriend at the time, had taken her car without her knowing it and was in an accident where he left the scene. He came back and talked her into taking the blame. She went to court. She pled not guilty. She told the judge the boyfriend did it. The judge dismissed the case. ALJ Russell recommends the following: Due to the time frame and the misunderstanding, upon passage of the NCLEX, Ms. Wyant be issued a license free and clear.

37. Cassa Ledwidge RN EndoFailure to Disclose

Ms. Ledwidge did not appear for her personal appearance. This matter is to be rescheduled one time.

38. Thomas Berry RN/APN Endo Positive Response

Mr. Berry did not appear for his personal appearance. This matter is to be rescheduled one time.

39. Sade White LPN Exam Failure to Disclose

Ms. White appeared for her personal appearance regarding application for licensure. She was told by an instructor to answer "no". She had a suspended license for unpaid tickets that she didn't know she had. They came to her house and arrested her. She paid the tickets and the matter was dismissed. She answered "no" because she thought it was a minor traffic offense. She had quite a few tickets. This is her only offense. She currently has her permit and her license will be active in 45 days. ALJ Russell recommends the following: Due to the nature of the matter, upon passage of the NCLEX, Ms. White be issued a license free and clear.

40. Emilee Buchanan RN Exam Failure to Disclose

Ms. Buchanan appeared for her personal appearance regarding her application for licensure. In July 2011, she was arrested for illegal consumption. The matter was dismissed. She never went to court on this issue. She thought that since the matter was dismissed, it was off her record. Ms. Buchanan provided a letter of reference to be reviewed. ALJ Russell recommends the following: Due to the misunderstanding and this being her only issue, upon passage of the NCELX, Ms. Buchanan be issued a license free and clear.

41. Matthew Evans RN EndoFailure to Disclose

Mr. Evans appeared for his personal appearance regarding his application for licensure. He checked "no" to question number 3 when he should have answered "yes". In 2000, he was charged with disorderly conduct. He completed a pretrial diversion program and thought this meant it was off his record. He is currently in the process of getting it expunged. He is a travel nurse. He has not had any other issues. He submitted documentation to be reviewed. ALJ Russell recommends the following: Due to the fact that he is in the process of getting the charges expunged and has an unencumbered licenses in multiple states with no issues, Mr. Evans be issued a license free and clear.

42. Lisa Parsons LPN Exam Grad Date 2009/Previous Testing Attempts

Ms. Parsons did not appear for her personal appearance. This matter is to be reset one time.

43. Phillip Harpenau RN Exam Positive Response

Mr. Harpenau appeared for his personal appearance regarding his application for licensure. In 2014, he was charged with disorderly conduct. He was at a fraternity event; he was the "sober" brother. He got off on the hayride and one of the brothers was passed out. He summoned a police officer. The officer asked him to stay with the passed out individual while he went and got the other officer. Someone needed to ride with the minor in the ambulance. The kid's roommate said he would ride with him. The officer said ok. Mr. Harpunau spoke up and said he didn't think that was a good idea because the roommate was also intoxicated. He walked away; he was then arrested because he was talking about it with other people that were on the hayride. The matter was dismissed after he paid a fine and completed community service. He submitted court documents and letters of reference to be reviewed. ALJ Russell recommends the following: Due to this being his only offense and the nature of the situation, upon passage of the NCLEX, Mr. Harpenau is to be issued a license free and clear.

44. Samuel Miller LPN Endo Positive Response *

Mr. Miller appeared for his personal appearance regarding his application for licensure. In 2012, he had a verbal altercation with his brother-in-law. His brother-in-law claimed he had a gun. He did have a pocket pistol but had not taken it out of his pocket. His sister called the police and claimed he was crazy and threatening her husband. He recorded the whole thing on his Iphone. He was arrested but no charges were filed. He answered "yes" to number 3. In 2000, he had a charge of wrongful use of controlled substance while in the military. He has a North Carolina license that is unencumbered. Mr. Miller submitted documentation to be reviewed. ALJ Russell recommends the following: Mr. Miller be issued a license free and clear.

45. Candace Postell LPN Exam Grad Date 2011/Previous Testing/Positive Response*

Ms. Postell appeared for her personal appearance regarding her application for licensure. She graduated in 2011 and last tested in Michigan-twice. She has not yet tested in Indiana. She lives in Ohio, but plans to move to Indiana and that is why she wants to test here. In 2007, she was with a group of friends. One decided to shoplift from the store. When they left, they were stopped by officers in the mall and both were arrested. She was charged with vandalism, just for being there. In 2009, she was with some friends who shoplifted. She paid all the fines and court costs. Both incidents happened within months of each other, but the court case was drawn out. She no longer associates with the same friends. Back then she had a bad group of friends and she has learned from her mistakes. She took a review course in September 2015. She is currently working in the health care. She submitted proof of taking the review course and a letter of reference to be reviewed. ALJ Russell recommends the following: Due to the time frame of the cases and all court requirements being completed, upon passage of the NCLEX, Ms. Postell be issued a license free and clear.

46. Erica Trueblood LPN Exam Positive Response*

Ms Trueblood did not appear for her personal appearance. ALJ Russell recommends the following: Due to the fact that this was not her first "no show", Ms. Trueblood's application for licensure be denied.

47. Allison Trevithick RN Exam Positive Response

Ms. Trevithick appeared for her personal appearance regarding her application for licensure. In August 2012, she was 18 years old. She went to a party with a small group of friends. A parent of one of the friends who was not invited called the police. They were all cited with illegal consumption of alcohol. She entered into a pretrial diversion program. After this was completed the matter was dismissed. This is her only issue. Ms. Trevithick presented letter of recommendation and court documents to be reviewed. ALJ Russell recommends the following: Due to the time frame of the matter, completing all court requirements, and no other issues, upon passage of the NCLEX, Ms. Trevithick be issued a license free and clear.

49. Zachary Kempf RN Exam Failure to Disclose

Mr. Kempf appeared for his personal appearance regarding his application for licensure. He answered "no" to question number 3 when he should have answered "yes". In 2012, he was charged with minor possession of alcohol. He entered and completed a deferral program. The charges were dismissed, so he thought it was off his record. Since this time he has learned to be responsible and now knows his actions today will affect him in the future. ALJ Russell recommends the following: Due to completing the court requirements and time frame of the matter, upon passage of the NCELX, Mr. Kempf be issued a license free and clear.

B. For Renewal- Personal appearances were held in Conference Center Room C at 8:30 a.m.

1. Lorrie Norton RN Renewal Positive Response

Ms. Norton appeared for her personal appearance regarding her application for renewal. Her license expired in 2007. She has been working as a nurse in Florida during this time. She has been terminated twice, once in Indiana and once in Florida. In Indiana, it was for not turning in paper work. In Florida, she worked on a med surge floor; the patient had an outpatient surgery and was admitted to the floor. At home the patient took 2 pills. In the hospital the doctor had actually ordered only one. She gave the patient 2 pills. She was terminated for this due to the fact the hospital had a no tolerance policy. Her

Florida license is active and unencumbered. Ms. Norton submitted a letter of reference to be reviewed. ALJ Russell recommends that she be renewed free and clear.

2. Elizabeth Eib RN Renewal Expired over 10 years-VACATED

3. Elisabeth Wilson LPN Renewal Expired over 10 years

Ms. Wilson appeared for her personal appearance regarding her application for licensure. Her license expired in 2002. She answered "yes" to number 7 but has not signed her name since her license was expired. She needs her LPN license renewed so she can obtain a "start of care" order from the physician. She does not plan to return to patient care. She plans on staying at her current position with her administrative duties. She submitted documentation to be reviewed. ALJ Russell recommends the following: Due to the fact that Ms. Wilson completed numerous CEUs and is not working directly with patients, once she completes a refresher course with clinical component, Ms. Wilson's license can be renewed free and clear.

4. Peggy Gregory RN Renewal Failure to submit statement


Ms. Gregory did not appear. Matter to be rescheduled for July 21.

5. Chastidy Sulinski RN Renewal Positive Response

Ms. Sulinski appeared for her personal appearance regarding her application for renewal. She answered "yes" to questions number 3 and number 5. In 2014, she was charged with obtaining controlled substance by fraud or deceit. She did do this while she was practicing. She is currently on criminal probation. She took them from work. She currently has an OWI charge where she hit and injured someone. For the OWI, she completed home detention. She has an addiction issue that she is now dealing with. She has spent a great deal of time in recovery and is still involved with the process. She has contacted ISNAP. It has been recommended she have a 2 and a half year RMA. She did not renew her license because she knew she needed to deal with her addiction issues first. Her life is different today. She feels like she is safer to practice today than the 10 years prior. In the accident she hit a pedestrian. She fell asleep while she was driving but had methamphetamine in her system. She submitted documentation to be reviewed. ALJ Russell recommends the following: Ms. Sulinski's license be renewed on probation with the following terms: successful completion of her ISNAP RMA, successful completion of criminal probation, active practice for one year, quarterly reports, CEUs, 12 in medication administration and 12 in professionalism. Ms. Sulinski agrees to have her license renewed on probation.
